NEW YORK | CIVIL PROCEDURE

Court Imposes Sanctions on Defendant For Missing Deadlines

Plaintiff is an art gallery; its managing member, Projjal Dutta, is the brother of defendant Prajit Dutta. Although plaintiff and defendants operated separate art galleries, they operated in the same space at 35 Great Jones Street in Manhattan. Plaintiff claims that it received a piece of artwork by the artist S.H. Raza on consignment from the painting's owner. Plaintiff argued that although defendants have no interest in the work at all, they took the painting and refused to return it to plaintiff. Plaintiff brought three causes of action for replevin, for conversion, and for tortious interference with contract. Plaintiff moved for sanction after defendants did not show for discovery. The motion was granted. The court held defendants' behavior was deliberate and contumacious. They did not attempt to offer legitimate excuses for missing the court's deadlines.

NEW YORK | REAL ESTATE

Receiver Appropriate After Members of LLC Did Not Engage in Accounting

The sole issue in a petition concerning a lease from an LLC was whether the petitioner was entitled to have a court appointed receiver do an accounting as part of the wind-up of 176 West 87th Leasehold LLC and whether the petitioner was entitled to legal fees. The court held petitioner was not entitled to legal fees but they were entitled to an accounting. The court held the Operating Agreement requires unanimous consent to make decisions on behalf of the LLC. The members were unable to effectively communicate with each other. The members were unable to properly discuss whether or not to sell the lease, which was the LLC's sole asset. Some of the members were also allegedly taking the LLC's funds for their own personal use without the consent of all of the members. Thus, the management of the entity was unwilling to reasonably permit the stated purpose of the entity to be achieved, dissolution of the LLC was proper, appointment of a receiver was appropriate and an accounting was warranted.

NEW YORK | INSURANCE LITIGATION

Court Grants Motion for Default Judgment In Insurance Action

Defendant, the claimant for the subject insurance policy, was involved in a motor vehicle accident. Following the provision of medical services, the medical provider defendants submitted claims to plaintiff American Transist Insurance Company. Citing the claimant's breach of the policy terms, plaintiff denied coverage to defendants. Plaintiff filed suit seeking declaratory judgment that plaintiff was not required to reimburse defendants for no-fault claims arising out of the accident. Plaintiff moved for an order granting default judgment against the defaulting defendants for failure to timely answer or appear. The motion was granted. The court held the relevant regulations require an insurer to act within a specified timeframe following receipt of an application for no-fault benefits, not when plaintiff receives a bill from the medical provider. As such, the record showed plaintiff did not abide by the relevant timeframe.

NEW YORK | CIVIL PROCEDURE

Court Grants Motion for Defendants; Plaintiffs Failed to Appear

Defendants and counterclaim plaintiffs National Holding Corporation and B. Riley Wealth Management Holdings, Inc. moved to dismiss plaintiffs' amended complaint for failure to appear at the oral argument and virtual conference on August 26, 2025 and to grant a default judgment on moving defendants' counterclaims in the amount of \$4,097,447 with interest from the date of each payment. Moving defendants also sought to sever their counterclaims against counterclaim defendant. There was no opposition to this motion. The motion was granted. The court held plaintiff United Atlantic Capital, LLC had not retained counsel and plaintiff Penske had not appeared on behalf of himself or retained counsel. 22 NYCRR § 202.27(b) permitted the court to dismiss the action if defendant appears at a conference and plaintiff does not. The court may also order a severance of any counterclaims.

BRONX | CRIMINAL LAW

Court Finds Certificate of Compliance Valid, Dismissal Denied

Defendant was charged with driving while ability impaired, driving while intoxicated *per se*, aggravated driving while intoxicated *per se*, and fourth-degree criminal mischief. The accusatory instrument alleged that defendant was involved in a multiple-car collision on Delafield Avenue in the Bronx, with the damage to two of the other cars forming the basis of the criminal mischief charge. Defendant moved to dismiss the action on speedy trial grounds. The motion was denied. The court held the Bronx District Attorney's Office narrowly met their burden to establish their diligence on the record. The People disclosed extensive discovery spanning multiple categories and did so before the discovery window closed. That they did not undertake more extensive efforts before May created a risk that any shortcomings would serve to invalidate their COC and declaration of readiness, requiring dismissal of this case. But the shortcomings, the court held, either individually or cumulatively, did not lead to a finding that the People did not exercise due diligence.

KINGS | DISPUTE RESOLUTION

UM Arbitration Not Stayed as Inadmissible Evidence was Submitted on Petition

Arguing that the respondent did not comply with the condition precedent of showing no available insurance coverage for the motor vehicle accident he was in, GEICO petitioned the court to stay uninsured motorist (UM) arbitration. The court noted that GEICO's motion papers contained several deficiencies. The petition contained allegations apparently made by GEICO's counsel based on information and belief. While the petition was verified by counsel, he did not state that he had personal knowledge of the contents and accuracy of the referenced ISO report. Further, there was nothing presented to properly authenticate the submitted ISO report as an admissible business record. As such, it was inadmissible and had to be disregarded. The court held GEICO failed to present admissible evidence that the vehicle striking respondent had insurance coverage. The petition to stay UM arbitration was denied.

SECOND CIRCUIT | CRIMINAL APPEALS

Second Circuit Affirms TVPA Verdict, Damages in Bond Trader Sex-Trafficking Case

Defendant bond trader recruited women to travel to NY and engage in sadomasochism with him in exchange for money. He employed assistants to lure women with promises of cash, fancy dinners, and first-class airline tickets to travel to his NY penthouse for sexual activity. Six plaintiffs brought a civil action against defendant, asserting claims under the Trafficking Victims Protection Act (TVPA) and state tort claims for assault, battery, false imprisonment, and intentional infliction of emotional distress. A jury found defendant liable under the TVPA and awarded \$500,000 in compensatory damages to each plaintiff. The jury also awarded \$120,000 in punitive damages to five plaintiffs and \$250,000 to one of them. Defendant appealed, arguing there was insufficient evidence to support plaintiffs' claims under the TVPA, the court delivered erroneous jury instructions, and the TVPA does not authorize punitive damages. The Second Circuit affirmed, holding the TVPA covers the scope of defendant's conduct, the jury instructions provided no basis for overturning the jury's verdict, the TVPA authorizes punitive damages, and the award of punitive damages here was appropriate.

U.S. - SDNY | TRADE SECRETS

Jury Trial Allowed on Investment Analyst's Unjust Enrichment Claim Over Financial Model

Plaintiff is an investment analyst who developed a financial model for Bank of NY Mellon (BNYM) defendants' tax-equity investments in wind energy projects. Plaintiff later stopped performing such work for BNYM and was replaced by Deloitte, although plaintiff continued to help BNYM evaluate new investments. Plaintiff alleged Deloitte's tool was essentially a "copy" of his model, and that BNYM saved money because it avoided paying Deloitte to create a full model from scratch. Plaintiff claimed BNYM terminated the relationship after he complained about Deloitte's use of his model. The Second Circuit affirmed dismissal of plaintiff's trade secret claims based on the "oral or implied-in-fact" contract between plaintiff and BNYM, but a dispute remained over whether BNYM may use the plaintiff's model for its own purposes. Plaintiff claimed BNYM paid him strictly for his consulting services but continued to use his model following the termination of the parties' relationship and was thus unjustly enriched. The instant court agreed that plaintiff is entitled to a jury trial on his unjust enrichment claim under the test articulated in *Granfinanciera* and *Tull*.

Court Grants Summary Judgment Allowing Foreclosure on Long-Defaulted Mortgage

Plaintiff Avail 1 LLC sought to foreclose on a property encumbered by a mortgage pursuant to a promissory note that has gone unpaid for almost six years. In 2013, defendant borrower executed a promissory note in favor of Sun Home Loans. To secure the note, defendant borrower executed a mortgage in favor of Sun Home's nominee. The note was subsequently passed from Sun Home to plaintiff. At the time the property was purchased, defendant borrower was married to his now ex-wife, defendant property owner. Although he no longer owns or resides in the property, defendant borrower continues to be the sole borrower on the note and mortgage and remains in default. Plaintiff later moved for summary judgment that it is entitled to foreclosure and to selling the property. The court granted the motion in full, determining that plaintiff made a prima facie showing that the sale and foreclosure of the property should proceed, while defendant property owner failed to show a dispute of material fact or that a reasonable juror could rule in her favor and defendant borrower has defaulted on the payment obligation.

U.S. - EDNY | INSURANCE LITIGATION

Insurer Awarded \$336,000 in Breach Of Contract Case Over Unpaid Premiums

Breach of contract action brought by plaintiff American Empire Surplus Lines Insurance Co. sought payment of unpaid insurance premiums under two policies issued to defendant Cyncal Steel Fabricators Inc. Plaintiff's premiums are computed as a percentage of the insured's "gross receipts," which it contended includes all receipts received by defendant during the respective policy periods. Following audits of defendant's gross receipts for the 2021 and 2022 policy periods, plaintiff informed defendant that it owed additional premiums of approximately \$336,000, which defendant refused to pay, asserting that "gross receipts" should be calculated differently. Defendant asserted that gross receipts should only be based on work performed during the policy period, excluding certain payments for work performed prior to the policy period. Plaintiff moved for partial summary judgment on its breach of contract claim. The court granted plaintiff's motion and held that plaintiff is entitled to \$336,029 in damages on its breach of contract claim, plus interest, finding no material factual dispute as to whether defendant owes the unpaid additional premiums.

U.S. - NDNY | EMPLOYMENT LITIGATION

Court Dismisses Nurse's CFAA Claim Over Employer's Access to Work Email

Plaintiff nurse filed a civil action against her former employer, Capital Region BOCES, alleging violations of her rights under the U.S. Constitution, the Americans with Disabilities Act, Section 504 of the Rehabilitation Act of 1973, the Computer Fraud and Abuse Act (CFAA), and state law. Plaintiff asserted defendant engaged in a "pattern of retaliatory behavior," including "harassment, false allegations, and ultimately, wrongful termination," that began after she "opted out of the union" and reported "incidents of student mistreatment and abuse by staff." Among other things, the court dismissed plaintiff's CFAA claim, in which she speculated that the change to her account password "without her consent or knowledge and the resulting tampering of her work email account may also implicate violations of the CFAA." The problem for plaintiff was that there is no plausible indication that defendant, whether through its IT personnel or some other administrator, lacked authorization to access and change the work email that it provided to plaintiff as a benefit of her employment, since authorized conduct, even if undertaken with an improper motive, does not violate the CFAA.
