NEW YORK | MEDICAL MALPRACTICE

Medical Malpractice Action Dismissed, Plaintiff Failed to Rebuff Expert Opinion

Plaintiff underwent the complicated surgical procedure known as Ivor-Lewis Esophagectomy for treatment of esophageal cancer. After the surgery, plaintiff was cancer free but had developed a foot drop and a wrist injury. Defendants moved for summary judgment. The motion was granted. The court held defendants submitted a prima facie case for dismissal via expert affirmations from three specialists: a thoracic surgeon, a pulmonologist, and an anesthesiologist. In opposition, plaintiffs failed to rebut defendants' expert opinions, since plaintiff's rehabilitation expert failed to address the specific assertions made by the defense experts, and failed to offer an opinion as to what defendants should have done to prevent the alleged injuries.

NEW YORK | TRUSTS AND ESTATES

Summary Judgment Denied and Granted In Action to Probate Will

Petitioner CUNY on behalf of Hunter College moved for summary judgment admitting a lost will to probate. Proponent was a residuary beneficiary under the propounded instrument. Respondent John MacGregor Blewer, Jr., (Objectant) moved pursuant to CPLR 3212 to deny probate and dismiss the petition. Objectant was the son and sole distribute of decedent and was disinherited under the propounded instrument. Petitioner's motion was and denied and granted in part. The court held objectant had failed in his opposition papers to raise a material issue of fact that required a trial. Proponent's proof provided competent evidence that the instrument sought to be probated was duly executed and was a copy of the instrument executed by decedent. However, trial was ordered to determine of decedent revoked the will.

BRONX | CRIMINAL LAW

Dismissal Granted as Prosecution Failed To Provide Discovery for Defendant

Defendant, who was charged with V.T.L. §511(1)(a) and related charges, moved to dismiss the accusatory instrument, arguing that the Bronx District Attorney's Office exceeded their statutorily allowed sixty-day speedy trial period, as their certificate of compliance (COC) was invalid and thus their statement of readiness illusory. Defense counsel argued that the People did not exercise due diligence in complying with their discovery obligations, as they furnished outdated and incomplete impeachment material for testifying officers prior to filing the COC. The motion was granted. The court found that the People did not meet their burden to establish that they acted with due diligence and made reasonable inquiries to comply with their discovery obligations. The People did not provide sufficient information about their efforts to ensure disclosure of complete and up-to-date CCRB material in their possession, both prior to the initial COC's filing and when Defendant first requested updated CCRB material. Additionally, the Court held that the People must disclose IAB records, including log attachments, for substantiated and unsubstantiated allegations.

KINGS | LITIGATION

Court Declines to Sign Order to Show Cause; Motion Must Be Incidental to Action

Pro se litigants proposed an order to show cause accompanied by affidavits and other papers. The relief sought was immediate restoration of full access to a terrace and the return of personal property. The location of the terrace was not set forth and neither was the property described. Actions of particular named individuals from whom relief was sought were not detailed. The order was denied. The court held Civil judicial proceedings must be prosecuted in the form of an action, except in special proceedings. In the current case, there was no action because neither a summons and complaint nor a summons with notice commenced the matter. Also, The litigants did not cite a provision of statute under which the matter might be commenced as a special proceeding.

QUEENS | TRUSTS AND ESTATES

Motion to Compel Arbitration Concerning CitiBank Accounts Denied By Court

Petitioner Abraham S. Mazloumi, Esq. was appointed as Temporary Property Guardian of LG. LG is a 79-year-old woman living in Queens who had suffered a debilitating stroke rendering her unable to manage her affairs. An Article 81 guardianship proceeding was brought to declare LG incapacitated by her niece, JB. During the underlying Article 81 investigation by the Court Evaluator, it was discovered that over a million dollars was removed from LG's various Citibank accounts. The court ordered a turnover proceeding for petitioner. Respondent Citibank then filed a motion to compel arbitration based on a deposit agreement signed by LG with the bank from 2007, and various other banking agreements that Citibank had with customers. The motion was denied. The court held Citibank actively participated in the Turnover Proceeding, by its attorney: appearing in court, interposing an answer, and participating in conferences and depositions. In conjunction with their failure to request arbitration, such participation is deemed a waiver.

RICHMOND | FAMILY LAW

Court Grants \$375,000 in Interim Counsel Fees to Defendant

In a matrimonial action defendant, already granted interim counsel fees in the amount \$237,487.62, had no access to marital assets, no independent source of income, had not been employed during the marriage due to a chronic medical condition and was wholly dependent on the court's pendente lite orders for basic support and legal fees. Defendant then sought an additional counsel fees award to address more than \$260,000 in counsel fee arears. Plaintiff had paid through July 2024 more than \$500,000 to his own legal team. Plaintiff argued that any further interim counsel fee award to the defendant should be treated as an advance against equitable distribution. Defendant's request for interim counsel fees was granted in the amount of \$375,000. The court declined to adopt plaintiff's theory, which would have impermissibly transformed interim litigation support into a preemptive property division and would have nullified the statutory presumption under DRL § 237 [a], rendering interim relief illusory, and invite monied spouses to leverage resource disparity as a tactical advantage.

SECOND CIRCUIT | CIVIL APPEALS

FRCP 54(b) Certification of Final Judgment On NYLL Claims Inappropriate

A June 2022 judgment, partially superseded by a July 4, 2023, partial judgment, awarded class-action plaintiffs relief in accordance with a jury verdict on their various claims under the New York Labor Law. On remand plaintiffs were granted dismissal of their still pending Fair Labor Standards Act claims. Plaintiffs' FLSA and NYLL claims arose from the same facts but have different parameters. Due to a federal policy against piecemeal appeals, Federal Rule of Civil Procedure 54(b) certification for a final judgment as to plaintiffs' NYLL claims was inappropriate in light of their reservation of right to reinstate their FLSA claims if they lost on appeal of their NYLL claims. Thus, no final judgment satisfied 28 USC §1291 and Rule 54(b). As a result, Second Circuit lacked jurisdiction to entertain the instant appeal from the decision of plaintiffs' NYLL claims.

U.S. - EDNY | ADMINISTRATIVE LAW

Case Is Remanded to SSA; Benefits Calculation Is Denied Judgment on the Pleadings

Plaintiff appealed defendant Social Security commissioner's denial of his application for Disability Insurance Benefits. In addition to seeking remand to the Social Security Administration—with a new administrative law judge—to evaluate his claim, plaintiff asked the court to declare him disabled and to remand action to the SSA for benefits calculation purposes only. District court remanded plaintiff's case to the SAA, with a new ALJ. However, it denied plaintiff judgment on the pleadings to the extent he sought remand for benefits calculation purposes only. Even if plaintiff's arguments about the current ALJ were meritorious, district court lacked authority to award benefits as a remedy. Also, his argument that the record was large and so one-sided in support of his claim of disability was underdeveloped and conclusory.

U.S. - WDNY | ADMINISTRATIVE LAW

ALJ Did Not Err in Finding Applicant Not Disabled, Had RFC to Perform Sedentary Work

Plaintiff's action under the Social Security Act (SSA) sought review of the Commissioner's determination, upholding an administrative law judge's decision, that she was not disabled. On competing motions district court granted the Commissioner judgment on the pleadings. The administrative law judge did no err when, in his five-step evaluation, he concluded that plaintiff's multiple, severe medically determinable impairments—and her mental impairments—did not meet or medically equal any impairment listed in 20 CFR Part 404, Subpart P, Appendix 1. The ALJ also correctly determined that plaintiff could perform sedentary work, with certain limitations. District court disagreed with plaintiff's assertion that the medical opinion of her treating physician was underemphasized in comparison to that of a physician who did not examine her. The court concluded that the ALJ's decision was not contrary to the substantial record evidence, nor resulted from legal error.

U.S. - NDNY | WAGE AND HOUR LITIGATION

FLSA Class Certified in Wage Action by Pizza Restaurant Chain 'Managers'

Former Little Caesar pizza restaurant employees Horner and Hudson sued defendants—a collection of business entities involved in franchise agreements with the pizza chain—alleging violation of the FLSA and NYLL by a common policy and practice by not paying them, or similarly situated employees, for all hours worked or overtime compensation, partly granting and partly denying plaintiffs' motion, district court conditionally certified an FLSA collective comprising all current and former managers of defendants employed in New York and classified as exempt at any time between Dec. 9, 2019, and the date of trial. Contrary to defendants' objections, the court determined that plaintiffs satisfied the commonality requirements for collective action. Also, plaintiffs' claims were sufficiently detailed to warrant conditional certification. They also submitted pay documents indicating that when they worked fewer than 50 hours in a week their "salary" was docked. Plaintiffs met their minimal burden of showing other similarly situated employees with respect to their job requirements and pay provisions classified as exempt by a common policy or scheme.

U.S. - EDNY | INSURANCE LITIGATION

Auto's Insurer Granted Judgment on Pleadings In Spousal Accident Coverage Case

Margaret Ricciardi alleged that she was negligently struck by a 2024 BMW being operated by her husband Daniel Ricciardi, causing her severe injuries. She later sued Daniel in state supreme court in Brooklyn. Presently, insurer State Farm sought declaratory judgment that it need not defend or indemnify its insured Daniel in the underlying state court action, and that its appointed counsel may withdraw from Daniel's representation therein. Denying the Ricciardis' motions to dismiss suit under FRCP 12(b)(6) district court granted State Farm judgment on the pleadings. State Farm argued that by declining SSL Insurance coverage under an original policy governing a 2023 BMW, extended to cover the 2024 BMW under an amended policy, it was not obligated to cover any damages stemming from the state action. District court granted insurer State Farm judgment on the pleadings pursuant to FRCP 12 b)(6). The amended policy was a continuation of the original policy and further concluded that Daniel opted out of SSL insurance coverage.
