NEW YORK | PERSONAL INJURY

Motion to Dismiss for Untimely Notice Of Claim Denied

Plaintiff brought a personal injury action arises from an incident that occurred when plaintiff allegedly tripped and fell due to a defective sidewalk joint located in front of 655 West 34th Street. Defendant moved to dismiss for failure to timely serve a notice of claim under General Municipal Law § 50-e. The motion was denied. The court held that plaintiff's good-faith efforts to notify the appropriate parties—by mailing a certified letter just twelve days after the incident—and his initial, belief that the City of New York was the only party requiring a notice of claim, did not warrant penalizing him with dismissal where the underlying claim was well-documented and the physical condition at issue remained available for inspection.

Personal Jurisdiction Not Needed to Recognize Foreign Judgment Under Faith, Credit Clause

In 2007 a \$668,404.38 default judgment was awarded against Simms and others in North Carolina. Judgment was assigned to Cadlerock in 2012. In 2016, Cadlerock sought to renew the judgment in a North Carolina court. That court issued a renewed default judgment in Cadlerock's favor in March 2017. Cadlerock's 2023 state court action sought summary judgment enforcing the 2017 North Carolina judgment. Supreme court in Westchester County determined it lacked personal jurisdiction over Simms, and thus dismissed Cadlerock's action. Reversing judgment below, Second Department held that New York need not hold personal jurisdiction over the defendant in order to have a foreign state's money judgment be recognized, and potentially enforced, in New York under the U.S. Constitution's Full Faith and Credit Clause. That clause made the valid North Carolina in personam judgment against Simms enforceable in all other states. Because Simms did not challenge the jurisdiction of the issuing North Carolina court, due process was not offended.

QUEENS | INSURANCE LAW

Dismissal of Action Granted as Pursuant To Pennsylvania Law

Plaintiff filed a complaint to recover no-fault benefits for health-related services rendered. The motor vehicle collision occurred in New York, but the vehicle's insurance policy was issued in Pennsylvania. Its owner/operator resided in Pennsylvania. The vehicle was garaged in Pennsylvania. Defendant requested dismissal on the basis that the insurance policy was duly canceled according to Pennsylvania law. The plaintiff opposed on the ground that the insurance policy was not canceled according to New York law. The plaintiff did not allege that the cancellation was improper under Pennsylvania law. The court granted dismissal since when there are coverage or cancellation issues involving policies which originate from other states, the laws of that other state prevails.

TRO, Preliminary Injunction Denied; Claim For Elder Abuse, Exploitation Not Recognized

Acting for himself ad as attorney-in-fact for his 87-year-old sister Jamila K. Butt, who lives in a nursing home, plaintiff Aziz alleged that Jamila was the victim of a fraudulent "power grab" by defendant—Jamila's daughter—who, among other things, secured TROs against Aziz, locked Jamila out of her bank accounts, and sold Jamila's home without her knowledge and against her wishes. In connection with his civil right lawsuit, Aziz moved for a preliminary injunction and an ex parte temporary restraining order. District court denied both motions. Aziz did not make a clear showing of irreparable harm or a likelihood of success on the merits to warrant entry of a TRO. A preliminary injunction would be inappropriate. Recently issued summonses have not yet been served on defendant. Similarly, Aziz was denied an ex parte TRO. His 42 USC §1983, due process, and First Amendment claims were unlikely to succeed because they were alleged against private individuals, even though each requires state action. Also, New York does not recognize a cause of action for elder abuse and exploitation and Aziz has not pointed to any statute authorizing such a claim.

NEW YORK | CRIMINAL LAW

OMH Found in Contempt for Failure To Transfer Patient

Petitioner, G.O., moved for an order holding the Office of Mental Health and Hygiene ("OMH") in civil and criminal contempt pursuant to Judiciary Law §§ 750 and 753, based on OMH's failure to timely transfer petitioner to an OMH facility, in accordance with the court's commitment order. The motion was granted. The court noted authority from the Appellate Division, Department, concluding that OMH failure to accept inmates for competency restoration constituted contempt. The court further determined that, at the hearing, the petitioner had established actual damages in the amount of \$100 per day that his transfer was delayed beyond March 27, 2025. The court cited the testimony of petitioner's forensic psychiatry expert, who opined that OMH would likely be able to obtain a force order to administer medication to the petitioner; and that, based on the past success of those medications, petitioner would likely be restored to fitness while in OMH custody.

KINGS | LITIGATION

Court Stays Proceeding for Name Change Of Petitioner

A petition for a name change requires a Declaratory Judgment that petitioner is Male C of the birth certificate indicating a date of birth in October 1963, which has never been legally established over his alleged 61 years of life. Petitioner allegedly claims to be Male C by birth with an undocumented name of PC which he had successfully maneuvered through his life since birth as PC based upon mere word of mouth even acquiring various governmental documents with varied dates of birth, including a Social Security Card, NYS Benefits Card and a marriage license. Because of this, the court stayed the proceedings. The court held the petitioner was unable to identify himself because his identity was never legally established. A social security card, nor a NYS Benefits card and a very limited IDCNY card, with inconsistent dates of birth, and no first name attached to the alleged birth certificate and criminal alias with differing dates of birth could not establish the legal identity of the petitioner.

Action Stayed Pending California Divorce Proceeding

Plaintiff, Katia Riquelme, was married to Robert O'Connor from 2005 until 2021. Katia commenced divorce proceedings against Robert in California in 2019, and they were divorced by a California court in March 2021. The California court did not divide Katia and Robert's assets in the judgment, though it expressly retained jurisdiction to do so. Katia commenced this action on April 2, 2025 – 65 days after Robert's death – alleging that she currently owned 50 percent of the shares of KA & B Properties Inc., an entity formed during her marriage to Robert. Katia now moved for a preliminary injunction. The court denied the plaintiff's motion for a preliminary injunction and stayed the action under principles of comity due to then pending California divorce proceeding in which division of the business and real and personal property had not yet occurred.

U.S. - EDNY | EMPLOYMENT COMPLIANCE

Court Explains Grant of Former Employer's Motion to Dismiss Claims Under FMLA

Hired in September 2021 Firuz sold ADT's security system to homeowners. That December, Firuz learned she was pregnant. Her manager denied her requests for disability support ad accommodations. Firuz disclosed her pregnancy on March 15, 2022 and was immediately placed on a performance improvement plan. Her manager fired her one week later, over the telephone, for mishandling client communications earlier that day. Firuz claimed that justification was fabricated, that she was fired because she was pregnant, and sued under Title VII of the Civil Rights Act, the ADA, and the Family and Medical Leave Act. The court granted ADT dismissal of Firuz's claims under the FMLA, with leave to amend. Firuz failed to state a claim that ADT interfered with her rights under the FMLA, or retaliated against her for exercising those rights. The court could not determine from her complaint's allegations whether Firuz made a request for leave under the FMLA and whether she would have been an eligible employee when her leave would have begun.

APP. DIV. | FAMILY LAW

Record Does Not Support Circumstances Preventing Removal of Youth's Case to Family Court

In April 2022 supreme court convicted 16-year-old defendant Lloyd F.—upon guilty plea—of attempted criminal possession of a weapon in the second degree. That same court's May 10, 2021, order granted the People's motion under CPL 722.23(1) to prevent the action's removal to Family Court. Removal to the Family Court's Youth Part terminates the criminal action and vests the Family Court with exclusive jurisdiction to determine if the adolescent is a juvenile delinquent. Reversing supreme court's judgment, Second Department concluded that under any reasonable interpretation of the phrase "extraordinary circumstances," as used in CPL 722.23(1)(d), the record did not support a determination that such circumstances existed to prevent the instant action's removal to Family Court. Defendant's possession of a loaded gun, in a high crime area, at 16 years old, standing alone, did not qualify as "extraordinary circumstances." As to additional evidence, defendant's alleged behavior marked the impetuosity, lack of maturity, and underdeveloped sense of responsibility characteristic of adolescent decision making.

QUEENS | LANDLORD TENANT LAW

Motion to Subpoena Granted; Petitioner Failed to Serve Respondent

In a commercial landlord tenant proceeding, respondent moved to quash a subpoena for financial records. Petitioner alleged respondent failed to tender payment pursuant to a commercial lease between the parties. The motion was granted. As petitioner did not serve the named party to the action, the motion to quash was granted. Petitioner presented an affirmation of service to evidence its proper service of the subpoena upon TD Bank. However, petitioner did not present any evidence that it served a copy upon respondent, as required by CPLR 2303(a) and CPLR 3120(3). Petitioner argued that the subpoenaed documents were already in petitioner's possession as a result of the subpoena, however petitioner was not relieved of or excused from its obligation to serve respondent.

SECOND CIRCUIT | ANTITRUST

Proposed SAC Alleges Horizontal Price-Fixing Conspiracy by Drug Makers

Plaintiff federally funded health centers and clinics filed a class action complaint alleging that defendant drug makers violated federal and state antitrust laws, and common law, through concerted action to restrict drug discounts offered to contract pharmacies. District court dismissed plaintiffs' first amended complaint and denied leave to file a second amended complaint. On appeal Second Circuit concluded that plaintiffs' proposed SAC pleaded enough facts to give rise to a plausible inference of a horizontal price-fixing conspiracy under Section 1 of the Sherman Act. Thus Second Circuit vacated district court's judgment and remanded action for the court to grant plaintiffs leave to file their SAC. Plaintiffs sufficiently pleaded parallel conduct. The proposed SAC plausibly alleged that defendants acted similarly in substance by restricting Section 340B Drug Discount pricing and raising prices for certain popular diabetes medications over the course of months. Thus defendants earned higher profits and avoided direct competition. The announced policy changes were also similar in timing. Defendants' policies.
