Dismissal Granted; Charges Dropped Against Defendant

Defendant was arraigned with a top charge of VTL § 1192 (3), an unclassified misdemeanor with a maximum sentence of imprisonment of 364 days. Defendant moved to dismiss the case. The motion was granted. The court held the Manhattan District Attorney's Office had not alleged that the defendant's brief absence delayed their ability to file an initial certificate of readiness beyond January 19, 2023. The record suggested that the People were not ready for trial because they had not yet filed a certificate of compliance, which did not depend on the defendant's presence. The fact that the People's witnesses were not physically present in the building was irrelevant to their ability to announce their readiness for trial.

QUEENS | LANDLORD TENANT LAW

Court Allows a Summary Proceeding Against Tenant at Sufferance Under RPL

In a reargument motion, the respondent conceded he was a tenant at sufferance but reargued the court's conclusion that he could be subject to a summary proceeding pursuant to Article 7 of the RPAPL. The respondent argued that a tenant at sufferance is not listed in RPAPL at all and therefore he could only be the subject of an ejectment action in Supreme Court. The court held that it is true a tenant at sufferance is not listed as a basis to commence any summary proceeding, however, RPL 228 which requires predicate notice to a tenant at sufferance, suffices to allow a summary proceeding. The court stressed that numerous cases permitted summary proceedings against tenants at sufferance where they were duly served pursuant to RPL 228. Further, the language of RPL 228 reasonably allowed summary proceedings and did not require an action in ejectment.

SECOND CIRCUIT | COPYRIGHTS

Former Congressman's Copyright Infringement Claims Are Barred by the Fair Use Doctrine

Former Congressman George Santos sued late-night show host Jimmy Kimmel, and the company that owns and broadcasts his show, for copyright infringement, state law breach of contract, and fraudulent inducement. Using various fictitious names, Kimmel had submitted to Santos requests for personalized videos through the Cameo platform. Santos fulfilled each request, and then Kimmel aired some of the videos on his show as part of a mocking series of segments called "Will Santos Say It." Second Circuit affirmed district court's dismissal of Santos's lawsuit. Santos's state law claims failed to state a claim, and his copyright claims were barred by the fair use doctrine. Second Circuit disagreed with Santos's assertion that Kimmel's use of the videos represented bad faith negating the fair-use doctrine's application as a defense. Santos's complaint contradicted any claim of a purpose by the defendants to supplant Santos's "commercially valuable right" in the videos. Nor did Santos suffer any market harm.

'Wells' Factors Favor Fee Award That Is Not Windfall; EAJA Award Must Be Refunded

While Hernandez's 2023 lawsuit was pending, his case was remanded to the Social Security Administration, and he was awarded attorney's fees of \$7,325.64 under the Equal Access to Justice Act (EAJA). The SSA later found Hernandez disabled since July 2020, and entitled to \$111,503.75 in past-due benefits. The SSA withheld \$36,132.25—25 percent of past-due benefits—for attorney fees. Granting counsel's motion under 42 USC §406(b), the court awarded Hernandez's lawyer \$13,362 in attorney's fees to be paid from the past-due benefits and required counsel to refund to Hernandez the \$7,325.64 under the EAJA. The Wells factors favored approving the fee award. Counsel's requested fee of 9.2 percent is much lower than the 25 percent cap. Nor was the fee award a windfall to counsel. Notably, the outcome of Hernandez's case was not restrictive to result in the award of any benefits, as evidenced by the administrative law judge's initial finding that Hernandez was not disabled, and the Appeals Council's denial of review.

Court Deems Statements Made By Defendant Not Within Hearsay Exception

Defendant was charged with assault in the third degree and related charges. Defendant objected to the Manhattan District Attorney's Office filing of a new accusatory instrument, asserting that the instrument did not meet the requirements for an information because it contained hearsay statements by the complainant. The court found that the hearsay statements made at the hospital five hours after the alleged incident did not meet the excited utterance exception to the hearsay rule. The court noted that there was a paucity of information in the instrument as to the complainant's condition and activities during the five-hour period. In turn, the new instrument was deemed a nullity, and the original misdemeanor complainant remained the instrument pending against the defendant.

RICHMOND | FAMILY LAW

Court Grants Maintenance and Child Support For Plaintiff

Arising from a matrimonial action, plaintiff moved for interim maintenance, interim child support, and interim counsel fees, and further sought an order directing defendant to bring current arrears on rent, gas, and electricity accounts for the marital residence. Defendant's opposition, which was largely conclusory, asserted that plaintiff was employable and exaggerated her caregiving obligations, and concluded that plaintiff should not be entitled to spousal maintenance, child support, or legal fees. The motion was granted. The court found the defendant's assertion that plaintiff was voluntarily unemployed lacked support in both fact and law. Plaintiff, a primary caregiver for multiple children, some with diagnosed ADHD and behavioral needs, was not merely unemployed but unemployable in the immediate term due to her domestic responsibilities and protracted economic dependence.

SECOND CIRCUIT | ANTITRUST

Sherman Act, CEA Claims of Conspiracy To Manipulate Sterling LIBOR Fail

Plaintiffs—an individual, investment fund, and limited partnership that traded in derivatives based on the Sterling LIBOR (Rate)—appealed from dismissal of their claims under the Sherman Act and Commodity Exchange Act (CEA) against several banks that allegedly conspired together to manipulate the Rate. District court found plaintiffs' claims failed for various reasons, including lack of antitrust standing and a plaintiff's lack of litigating capacity without having assigned its claims to a would-be substitute. Second Circuit affirmed district court's dismissal of plaintiffs' action. It determined that plaintiffs failed to allege actual injury under the Sherman Act or CEA. Despite alleging that defendants colluded to set artificial prices, plaintiffs did not identify any specific transactions where they suffered financial harm because defendants' price fixing had distorted the market. The instant case involved opportunistic, fluctuating manipulations that may have sometimes marginally propped Sterling LIBOR up and may have sometimes marginally suppressed Sterling LIBOR.

U.S. - EDNY | CREDITORS' AND DEBTORS' RIGHTS

Court Lacks Authority to Stay Underlying State Court Debt Collection Proceeding

On May 27, 2025, pro se plaintiff Mosley sued defendant (S&S) alleging violations of the Fair Debt Collection Practices Act (FDCPA) and New York General Business Law §349 in connection with S&S's efforts to collect a debt from Mosley through a state court proceeding. After she filed her complaint, Mosley moved for a preliminary injunction staying the state court debt collection proceeding. The court denied Mosley injunctive relief. No exception to the Anti-Injunction Act applied. Thus the court lacked authority to stay the underlying state court debt collection proceeding, order S&S to stop attempting to collect the debt, or to order S&S to withdraw the state court proceeding. Mosley did not articulate how her ability to collect money damages from S&S's alleged violation of the FDCPA would be impaired or defeated absent a stay of the state court debt collection proceeding. Nor was there any indication that the issues presented by the state court debt collection proceeding were previously presented to and decided by a federal court.

Motion to Dismiss Contracts Action Denied

In a breach of contract action, plaintiff Syndicate Group USA Inc. sought an order pursuant to CPLR 3212 for summary judgment in its favor on the claims asserted against LLC defendant Mission Mechanical LLC and individual defendant Marcus Harwell. The court denied the motion, without regard to the sufficiency of the opposition papers. The court found that the plaintiff provided no admissible evidence demonstrating that it performed its part of the agreement by paying the LLC defendant the agreed-upon purchase price and therefore did not meet its burden demonstrating as a matter of law that the LLC defendant breached the agreement and the obligation of the guarantor was not triggered.

WESTCHESTER | MEDICAL MALPRACTICE

Direct Verdict Motion Denied in Medical Malpractice Action

In an action alleging medical malpractice, at the close of plaintiff's testimony during a jury trial held, defendant moved for a directed verdict. The court granted the motion. The Court held that plaintiff's expert was unqualified to render an expert opinion as he failed to attest to a standard in New York, or even to a minimum standard applicable locally, statewide, or nationally. As a result, plaintiff was unable to prove, through expert testimony, that Dr. Berman departed from the standard of care when treating the decedent. The court held that the plaintiff's expert's testimony was speculative and was insufficient to establish that Dr. Berman deviated from accepted medical practice by failing to attempt a conservative approach prior to surgery and that such deviation was a proximate cause of plaintiff's injuries.

U.S. - SDNY | CIVIL RIGHTS

Probable Cause Existed to Arrest, Prosecute Motorist Over Forged Temporary License Plate

On Dec. 10, 2018, Waller bought a used car from a dealer and was provided temporary 30-day registration and license plate. At the time period's expiration he returned to the dealership where a staff member modified the temporary registration and license plate, by hand, to Jan.10, 2019. Later that day Waller parked the car, which lacked front and rear license plates, on a marked crosswalk. Uniformed NYPD officers approached. Waller gave Sergeant Klein the temporary license and registration with the handwritten modification. Waller was arrested after another officer recovered a burnt marijuana cigarette from the driver's area. A charge of criminal possession of a forged instrument in the second degree was later dropped. Waller later sued Klein, the NYPD, and other officers. District court granted defendants summary judgment dismissing Waller's complaint under 42 USC §1983. There was probable cause to arrest Waller for possessing a forged license and lacking a front license plate. There was also probable cause to prosecute Waller, and defendants were entitled to summary judgment on his malicious prosecution claim.
