NEW YORK | CIVIL PROCEDURE

Case Dismissed; Plaintiff Failed to Give Excuse as to Delay in Service of Motion

Plaintiff debt buyer brought a motion for a default judgment against defendants for the alleged unpaid balance of a student loan originated by nonparty Salle Mae Bank. The motion was denied and the action was dismissed as abandoned. The court held following the CPLR 3215(c) one-year rule then, plaintiff's application for a default was due no later than January 24, 2023. However, plaintiff did not serve the motion until June 2, 2025, 861 days late. While plaintiff sought leave based upon a combination of efforts to respond to legislative reforms, administrative delays, and law office failure, the court found that plaintiff had not met its burden for a reasonable excuse for delay.

RICHMOND | FAMILY LAW

Contempt Not Found Against Defendant Who Could Not Pay Support

In a matrimonial action, plaintiff moved for an adjudication of civil contempt against the defendant for alleged noncompliance with the court's directive issued on March 18, 2025. The order established a series of financial directives incumbent upon the defendant, which were to be satisfied within twenty days of said order. Defendant did not contest his failure to make any of the payments but argued that he is financially incapable of discharging the ordered obligations. Plaintiff's motion was denied. The court held defendant provided financial documentation, referencing existing debts and judgments, and identified a failed loan application as demonstrative of his impaired financial standing. Plaintiff offered no rebuttal evidence, nor did she demonstrate that defendant had refused to make partial payments or otherwise defied judicial orders with malice or disregard.

SECOND CIRCUIT | CRIMINAL LAW

Court's Decision to Seal Sentencing Exhibits Inadequately Explained

Greenwood pleaded guilty to certain charges in connection with a cryptocurrency scam. Before sentencing he submitted a partially redacted sentencing memorandum and exhibits, most of which the court sealed. Reporter Lee appealed district court's denial of his motion to unseal and unredact Greenwood's sentencing submission. Second Circuit partly vacated, and partly remanded, the district court's order. The court's findings justified the narrowly tailored redactions to Greenwood's sentencing memorandum, but did not adequately explain its decision to seal Greenwood's sentencing exhibits. Second Circuit agreed with Lee that the First Amendment right of access attaches to Greenwood's sentencing submissions and requires the court to make individualized findings to justify sealing. Unlike the narrow redactions in the sentencing memorandum, 34 exhibits were sealed in their entirety. The three categories of protected information identified by the district court do not explain the exhibits' full sealing.

U.S. - EDNY | CONSUMER PROTECTION

Promotional Terms for Gambling Site's Deposit Bonus Conspicuously Disclosed

Plaintiff's putative class suit alleged that gambling corporation DraftKings engaged in deceptive marketing to increase its sports betting platform by fraudulently and misleadingly promising new users a \$1,000 deposit bonus for signing up to its platform (Promotion). DraftKings later federally removed suit to district court. District court granted DraftKings' motion to dismiss suit for failure to state a claim under FRCP 12(b)(6). The Promotional Terms fully and conspicuously disclosed the requirements to be fully eligible for the full value of the Promotion. Before depositing funds into a DraftKings account a reasonable consumer would have seen the Promotional Terms that were displayed on the deposit screen. Thus, the Promotional Terms were fully disclosed to plaintiff. Further, a reasonable consumer would not be misled to think that merely signing up for a DraftKings account would entitle them to the full \$1,000 Deposit Bonus when the Promotional Terms specified that users can "receive up to \$1,000 in bonus funds."

KINGS | LANDLORD TENANT LAW

Petition Dismissed as No Agreement Existed About Alleged Rent

Petitioner commenced A nonpayment proceeding seeking to recover possession of the location located at 855 Louisiana Avenue. Prior to commencing the proceeding, Petitioner served respondent with a Thirty Day Rent Demand requiring respondent to pay \$ 19,848.50 or vacate the premises. Respondent, through a Guardia Ad Litem, moved to dismiss. The motion was granted. The court held respondent was correct in arguing that even if the court were to find that a 2009 agreement allowed for successive terms, petitioner could not maintain the proceeding as they did not produce an agreement, either express or implied, at the monthly rent alleged in the petition.

ULSTER | CIVIL PROCEDURE

Motion to Vacate Denied; Party Estopped From Contesting Service

The Town of Ulster sued Catello Viviani to compel him to repair or allow the Town to repair/remove unsafe structures at 338 Glenerie Boulevard. Viviani was served at 961 Orlando Street, an address he had previously sworn under oath was his residence in a separate lawsuit. Viviani defaulted, and the court granted the Town a mandatory injunction allowing it to remediate or demolish the unsafe structures. The Town properly served notice of entry. Months later, Viviani, through counsel, requested a conference but took no action to comply with the order. He filed a new action to block demolition, claiming he had received no notice. A temporary restraining order was briefly issued but later vacated when the court found the new action was an attempt to relitigate the already resolved matter. Viviani then moved to vacate the November 2024 Order for lack of personal jurisdiction. The court denied the motion, holding that Viviani was estopped from contesting service because he had sworn in July 2024 that 961 Orlando Street was his residence.

SECOND CIRCUIT | CRIMINAL LAW

Russian Citizen Fled U.S., Is Fugitive Not Entitled to Seek Indictment's Dismissal

Defendant Russian citizen Bardakova allegedly conspired with Russian industrial magnate Deripaska to evade U.S. sanctions emplaced after Russia's invasion of Ukraine's Crimean Peninsula by, among other things, traveling to California to arrange for Deripaska's partner to give birth to their son. While in California Bardakova lied to FBI agents about her ties to Deripaska. Bardakova left for Russia three days after the FBI interview. Indicted for conspiracy to violate the sanctions and for making false statements to the FBI, she has not returned to the U.S. District court denied Bardakova's motion to dismiss the indictment, deeming her a fugitive from justice who should be disentitled from relief in federal court. On interlocutory appeal, Second Circuit affirmed district court's denial of Bardakova's motion to dismiss the indictment. At a minimum, Bardakova constructively fled U.S. jurisdiction by committing a crime here before leaving and refusing to face prosecution. Also, district court did not abuse discretion in disentitling her from moving to dismiss the indictment.

U.S. - EDNY | SECURITIES LITIGATION

Guilty Plea Establishes Liability in Pparallel SEC Civil Action for Ponzi Scheme Fraud

The SEC alleged Simeon defrauded investors in a Ponzi-like scheme violating Section 17(a) of the Securities Act, Section 10(b) of the Securities Exchange Act, and Rule 10b-5. After Simeon's conviction in a parallel action and his failure to appear the SEC moved for default judgment. District court denied Simeon's motion for appointment of pro bono counsel and his motion to stay action. Additionally, the court denied the SEC's motion for default judgment, without prejudice, and ordered Simeon to answer the SEC's complaint within 30 days, regardless of his ability to retain counsel. The court noted that, unlike in criminal cases, there is no constitutional right to counsel in a civil case. Nor did Simeon satisfy the threshold requirement of demonstrating a meritorious defense. The SEC's claims were based on the same securities fraud scheme that Simeon pleaded guilty to in his parallel criminal prosecution for mail fraud. Simeon's guilty plea and plea colloquy in the criminal matter established his liability in the instant civil action. Thus, he is unlikely to have a viable defense to the SEC's civil claims premised on the same fraudulent scheme.

Court Finds Respondent was Tenant At Sufferance However Dismissal Denied

Petitioner purchased property following a foreclosure sale and maintained no privity with the former owner who never vacated the premises. The former owner, the respondent, moved seeking to dismiss the petition on the grounds the petition failed to sufficiently allege the respondent was a tenant at sufferance. The court explained that while a tenant at sufferance has been largely abrogated in the residential setting it still had relevance in the commercial setting. The court held there was sufficient evidence presented the respondent was indeed a tenant at sufferance, however the motion was denied since the petition overwhelmingly afforded the respondents with notice of the claims as well as the basis for the relief sought.

Summary Judgment to Foreclose on Property Denied

In an action to foreclose on a residential mortgage, plaintiff moved for summary judgment. Plaintiff sought to foreclose its mortgage on property located in Athens, NY. It asserted that defendant borrowed \$317,091 from JP Morgan Chase Bank, N.A. and executed a note. The court denied summary judgment because an issue of fact existed regarding the effect of an earlier assignment of a mortgage. The earlier assignment appeared to have transferred rights to the borrower's original mortgage rather than the consolidated mortgage which the parties had executed.

U.S. - SDNY | WAGE AND HOUR LITIGATION

NYLL Wage Claims Not Dismissed; Concrete Injury Plausibly Established

As Allied Universal (AU), defendant Universal Protection Services provides security services to sites throughout New York. In their putative class action plaintiff former AU security guards alleged violations of the FLSA, the NYLL, and breach of public works contracts of which plaintiffs alleged to be third-party beneficiaries. The court denied AU's motion to dismiss claims under NYLL §195—for deficient wage notices and wage statements—for lack of standing under FRCP 12(b)(1). Contrary to AU's arguments, plaintiffs plausibly established concrete injury in fact. By failing to provide wage statements accurately reflecting hours worked and wage notices stating overtime compensation policies AU "deprived employees of the ability to contest [AU's] calculations, allowed [it] to hide [its] wrongdoing, and necessitated the current litigation to vindicate plaintiffs' and class members' rights." AU's deficient Wage documentation hindered plaintiffs' ability to contest their compensation, resulting in delayed payment of all proper wages, causing plaintiffs to struggle to pay bills and to forego purchases.
