NEW YORK | ADMINISTRATIVE LAW

Court Denies Petition to Reject FOIL Request From Reporter

During respondent Office of the Attorney General's investigation into Catholic dioceses in New York, petitioner The Diocese of Buffalo produced to the AG approximately 25,000 pages of documents concerning the Diocese's internal investigations into abuse allegations. A reporter from *Buffalo News* submitted a FOIL request to the AG seeking those documents. The AG alerted the Diocese of the request. The AG rejected the Diocese's arguments concerning the applicability of an exemption as well as concerning the applicability of the separate law-enforcement exemption. The Diocese thereafter commenced an Article 78 proceeding. The petition was denied. The court rejected the Diocese's argument that the unavailability of the documents to competitors was alone sufficient to qualify the documents for the exemption. The court then determined that the Diocese had failed to adequately demonstrate that it had "competitors" within the meaning of the statute or it would receive significant competitive injury. The court also found the AG's decision was reviewable by a court, because the Diocese's challenge was framed as mandamus to review.

NEW YORK | PERSONAL INJURY

Dismissal Granted in Part in Motor Vehicle Accident Case

Plaintiff brought an action arising from a motor vehicle accident involving non-party Thomas Boichichio who experienced a seizure awareness and crashed into the rear of the vehicle occupied by the decedents Timothy Lafferty and Samantha Shaw, resulting in their deaths. Dr. Avila, a neurologist employed by Memorial, at the time of the accident, was non-party's doctor who treated him for seizures and asserted that non-party was seizure free to drive. Plaintiffs claim that, by reason of Dr. Avila's negligence in the course of rendering medical care, diagnosis, treatment, and services to Boichichio, the accident, occurred, resulting in deaths of Timothy Lafferty and Samantha Shaw. Defendants moved to dismiss. The motion was granted in part. The court held that the COVID-19 toll was inapplicable and dismissed plaintiff's claims, sounding in medical malpractice, negligence, wrongful death, and conscious pain and suffering. Furthermore, the court determined that the medical malpractice cause of action was not properly pled due to the absence of a physician-patient relationship between the defendant physician and plaintiffs' decedents, who were killed in a car accident.

Lafferty v. Avila, 805399/2022 (June 11)

APP. DIV. | CIVIL PROCEDURE

Service on School District Assistant Superintendent Was Service on School Officer

A retaining wall on defendant school district's land collapsed, endangering plaintiffs' properties to flooding if there was heavy rain. A heavy rain event occurred when Hurricane Ida struck. Because the retaining wall was not repaired plaintiffs' homes and properties were flooded by water cascading from defendant's property. Plaintiffs' process server personally delivered the summons and complaint at defendant district's office, handing both to Doggett who identified himself and told the process server that he was authorized to accept service of process. The district asserted a defense of, and sought dismissal for, lack of personal jurisdiction. Supreme court dismissed suit. It found Doggett not an officer of defendant school district under the Education Law and that service on him was not proper service on the district. Reversing judgment, Second Department concluded that personal service of a summons and complaint to an Assistant Superintendent for Curriculum & Instruction constitutes delivery to a "school officer" as defined in Education Law §2(13) so as to constitute personal service upon a school district.

Motion to Dismiss Child Victims Act Action Denied

Plaintiff commenced a Child Victims Act action seeking damages for alleged sexual abuse perpetrated against plaintiff when plaintiff was a minor. Defendant moved to dismiss the action. The motion was denied. The court held the CVA passed constitutional muster and comported with due process requirements. Every federal and state court that considered the issues decided it was constitutional. The court had concluded that the Legislature was responding to injustices created by a short limitation period for claims arising out of sexual abuse; to open a limited window of time to bring claims was the response to remedy the injustice.

Court Allows Plaintiff to Preclude Immigration Status

In a motor vehicle accident trial, plaintiff made a motion in limine to preclude any reference to his immigration status. In opposition, defendants contended that, given the current political climate and increased immigration enforcement, the possibility of deportation was not speculative. They therefore maintained that they should be permitted to introduce evidence regarding plaintiff's potential return to his country of origin, via deportation or by choice, and the likely reduction in future medical expenses that such a return would entail. The motion was granted. The court held that in light of the intensified political climate that has made the immigration status of individuals increasingly vulnerable, plaintiff might be at substantial risk of undue jury prejudice and inflammatory bias were evidence of his immigration status permitted at trial.

RICHMOND | FAMILY LAW

Motion to Reargue Denied; Attempt By Plaintiff to Relitigate Issues Adjudicated

In a post judgment matrimonial motion practice, plaintiff moved pursuant to seek leave to reargue and/or renew the court's prior decision and which adjudged plaintiff in civil contempt, directed the listing and sale of the former marital residence and awarded defendant counsel fees. The motion was denied Plaintiff contended that the court overlooked the absence of an explicit deadline in the Stipulation for consummation of the buyout; however, the D&O did not predicate the finding of contempt upon a deadline not present in the Stipulation, but rather on plaintiff's prolonged, willful inaction after her election to buy out defendant's interest—inaction that persisted even after defendant issued a written notice of default. The court found that plaintiff's motion was a transparent attempt to relitigate issues fully and fairly adjudicated and advanced no matter of fact or law that was overlooked or misapprehended, nor did it present new facts sufficient to warrant disturbing the Court's prior determination.

SUFFOLK | ADMINISTRATIVE LAW

Petition Granted to Annul Determination Of Board of Zoning Appeals

A proceeding brought pursuant to CPLR Article 78 by petitioners Leon Piskorz and Eva Stark against the Town of Smithtown Board of Zoning Appeals (BZA), the BZA members in their official capacities and Charles Muller, a property owner who was granted relief by the BZA. The petition sought to annul, vacate, set aside, and reverse the BZA's decision and determination to grant Mr. Muller's applications which was filed with the Smithtown Town Clerk. The petition was granted. The court held the Building Director determined that certificates of existing use (CEU) were necessary to legalize the structures on the parcel and that determination was not appealed to the BZA within 60 days. The application to reverse that determination was timely. Accordingly, the 2024 BZA Determination ruling that CEUs were not required was vacated and annulled.

SECOND CIRCUIT | CREDITORS' AND DEBTORS' RIGHTS

Parties' SPA Did Not Obligate Lender To Act as Dealer Registered With SEC

Auctus Fund loaned aerospace firm Xeriant over \$5 million by means of a convertible promissory note. When Xeriant did not repay the loan Auctus sought to collect by converting the debt into common stock. Xeriant rejected conversion, and sued for declaratory judgment that the parties' contract was void under §29(b) of the Securities Exchange Act because Auctus was not a registered broker as required by §15(a)(1). District court granted Auctus dismissal. The parties' agreement was not void because although Auctus failed to register as a dealer with the Securities and Exchange Commission, the contract did not obligate Auctus to act as a dealer. Affirming the district court's judgment, Second Circuit agreed that Xeriant failed to allege a sufficient claim for rescission of the parties' securities purchase agreement under §29(b). Nowhere did the parties' SPA require Auctus to sell converted shares on the market or convert the debt into shares. Neither the terms of the contract, nor its performance, required "a prohibited transaction."

Preliminary Injunction Halting Closure of 99 Private Job Corps Centers Issued

Congressionally established in 1964 the Federal Job Corps Program is today authorized under the Workforce Innovation and Opportunity Act, which states that "there shall be within the Department of Labor a 'Job Corps.'" On May 28, 2025 the DOL notified 99 private Job Corps centers that they needed to cease operations by June 30. Congressionally mandated protocols set forth in 29 USC §3209(j) were admittedly not followed before closure. Instantly, district court granted plaintiffs a preliminary injunction halting enforcement of actions to eliminate the Job Corps program, including halting enforcement of contract termination notices and stop work orders. The court determined that plaintiffs' rights arose through statute, not contract, and that it was undisputed that certain plaintiffs' injuries were caused by the defendants. Defendants exceeded their statutory authority by closing the 99 subject Job Corps centers without following statutory requirements. The injunction against defendants was nationwide and had full force and effect in the District of Columbia, where separate similar litigation is pending.

Sufficient Sentence Punishes Defendant, Deters Others From Similar Conduct

Defendant and two others conspired to sell cocaine and counterfeit money to an undercover NYPD officer. Upon defendant's arrest on Oct. 27, 2023, the undercover officer bought 1,023.61 grams of substances containing cocaine, and \$43,400 in counterfeit U.S. currency. On Aug. 22, 2024 defendant pleaded guilty to Count Two of a two-count indictment charging him with conspiracy to distribute and possess with intent to distribute controlled substances in violation of 21 USC §§841(b)(1)(C) and 846. Presently, the court sentenced defendant to 24 months in prison; three years supervised release with both the standard and special conditions of supervision; forfeiture of \$4,180; and a mandatory \$100 special assessment. The sentence was sufficient, but no greater than necessary, to accomplish the purposes of 18 USC §3553(a) (2). While noting that defendant had no prior convictions, the court recognized the seriousness of defendant's offense and concluded that the sentence imposed would justly punish defendant and deter others from engaging in similar acts. Notably, defendant faced a maximum of 20 years' imprisonment and a \$1 million fine.

U.S. - NDNY | CIVIL PROCEDURE

Default Judgment Denied; Delaying Default Judgment Would Not Prejudice Plaintiff

In addition to defendant A&H's failure to pay overtime plaintiff Waks accused A&H and defendant Kulzer with defamation per se—arising from Kulzer's statement to law enforcement, at A&H's behest, that Waks sexually abused a minor—and claimed intentional infliction of emotional distress as against both defendants arising from the same conduct. Although served, default was entered against Kulzer. Instantly, district court denied, without prejudice, Waks' motion seeking default judgment against Kulzer only. The court agreed with A&H that entry of default judgment while relevant claims against it were still pending raised the possibility of inconsistent judgments, and that Waks would not be prejudiced by delaying default judgment against Kulzer. Nor did Waks argue that there was no just reason to delay the issuance of a default judgment against Kulzer until the claims against A&H were resolved. The two claims asserted against Kulzer were also asserted against A&H. Because the claims against A&H are also based on Kulzer's statements, the claims against the two parties have a strong degree of inseparability.
