DECISIONS OF INTEREST

NEW YORK | PERSONAL INJURY

Claim Dismissed; State Entitled to Qualified Immunity

While responding to a multi-car accident with injuries, a New York State trooper became involved in a low-speed, side swipe accident with another vehicle on the Southern State Parkway. Claimant, the rear seat passenger in the ride-for-hire vehicle (Lyft) claimed that she was injured in an accident caused by the State trooper. The State sought summary judgment dismissal of the claim based primarily upon qualified immunity pursuant to Vehicle and Traffic Law 1104 and lack of jurisdiction. The court dismissed the claim, concluding that the trooper's actions were a mere miscalculation that did not amount to "reckless disregard," which required a showing of more than a momentary judgment lapse, thereby entitling the State to the qualified immunity provided by the Vehicle and Traffic Law. The court further concluded that the claimant failed to timely serve the Attorney General's Office in violation of the court's order, and that the manner of service also constituted a failure of subject matter and personal jurisdiction.

Court Orders Pendente Lite Maintenance From Father

In a matrimonial action, the court found that the father's claim that he should not be ordered to pay *pendente lite* maintenance to the mother because he allegedly earned nominal income from his clothing business while asserting that he paid more than \$57,000 in monthly expenses would be unjust or inappropriate and imputed to the father an income of \$689,884.08. The court found that the father was not being transparent about this income and/or access to financial resources. The mother alleged that the paternal grandfather had always provided the father with unlimited financial resources and that the paternal grandfather was funding the litigation after he was arrested for allegedly punching her in the face. The court found that there was no basis *pendente lite* to impute \$250,000 annually to the mother who had never worked during the nearly fifteen year marriage until she had started a pandemic-based PPE import business. The court ordered the mother to pay the statutory minimum for child support of the parties three children who live with the father in the marital residence.

U.S. - SDNY | PATENT LITIGATION

Court Construes Patent Claims in Action Over 'Blender Bottle' Lid

Trove Brand's 830 Patent and Design Patent concern the design of the lid to its "Blender Bottle," a shake bottle that mixes liquids with dietary supplements. Its operative June 11, 2024, amended complaint charged defendant with patent, trade dress and trademark infringement and unfair competition. After ultimately partly granting defendant's motion to dismiss on Feb. 21, 2025, the court construed the seven 830 Patent claims and the sole Design Patent claim remaining in dispute as of an April 8, 2025, *Markman* hearing. Although the parties did not oppose the court's construction of several claim terms, the court accommodated Trove's suggestions as to 'first protrusion' and "second protrusion." Defendants proposed construction of those claims was circular. However, in construing the Design Patent, the court declined defendant's invitation to determine which elements were functional or found in prior art. Such fact-sensitive inquiries should be undertaken only after discovery has ended.

Motion to Dismiss SAC Is Denied; Proposed Pleading Is Not Operative Filing

Wright sued defendants Mitsubishi HC Capital and Cummins Inc. on June 12, 2023. Before the court is Cummins' motion to dismiss Wright's proposed Nov. 22, 2023, Second Amended Complaint (SAC)—which is actually his proposed Third Amended Complaint—under FRCP 12(b)(6). Wright's Sept. 16, 2024, "Third Amended Complaint" did not comply with a judges directions, was not in proper form, and was not signed. District court denied Cummins' motion to dismiss, and remanded action to a magistrate judge to resolve case management issues. Wright's proposed amended complaints do not correct deficiencies noted by a magistrate judge, and continue to fall short of the requirements for a proper pleading. Thus Wright's motion to amend his SAC was denied. Cummins' pending motion to dismiss seeks dismissal of a proposed pleading not accepted for filing by the court and which does not supersede the Amended Complaint as the operative filing.

BRONX | CRIMINAL LAW

Criminal Action Dismissed; Prosecution Did Not Act With Diligence

Defendant, who was charged with violations of Vehicle and Traffic Law § 1192(3), (2) and (1), moved to dismiss the information arguing that the Bronx District Attorney's Office could not have been ready for trial when it certified disclosing discovery that may not exist. The prosecution filed a Statement of Readiness (SOR) and Certificate of Compliance (COC) certifying that they had turned over activity logs and body camera footage for several officers. The defense informed the prosecution that the logs and footage were missing for a particular officer. The prosecution stated that it believed that officer was included in error. Because the prosecution filed a COC certifying that they had disclosed discovery that may not exist, they did not act diligently, the SOR was illusory, and this case was dismissed as the time for filing a valid COC has passed.

ULSTER | ADMINISTRATIVE LAW

Violation of Open Meetings Law Allows Court To Annul Board Decision

Petitioners' challenged the disapproval of their project; subdivision approval seeking to separate the portion of a lot which was in the commercial district and allowed for future development of the portion of the property in the Residential District. The court found that the Town of Esopus Planning Board violated the Open Meetings Law when, on two occasions during public meetings, it recessed into a private consultation with its attorney. The court found that the presence of the Town Planner destroyed the attorney-client privilege because the planner was neither an employee of the Board, nor the "functional equivalent" of an employee. Accordingly, a violation of the Open Meetings Law did occur, and the disapproval of the project was annulled, and the matter was remitted back to the Planning Board for further proceedings.

Constitutional Rights as Parent Not Violated; Suit Against Foster Agency Dismissed

Sandoval sued foster agency on her own behalf and that of her three children for injuries the children allegedly suffered while under Abbott House's foster care. The children's claims were dismissed, so the sole remaining claim is on Sandoval's own behalf. Although the court, sua sponte, twice extended the deadline, Sandoval never responded to Abbott House's motion to dismiss suit under FRCP 12(b)(6). The court dismissed Sandoval's complaint, without prejudice. Sandoval failed to state a claim. She inadequately alleged that a liberty interest was infringed. State action was not specifically directed at interfering with the parent-child relationship. Thus, Sandoval's constitutional rights as a parent were not violated. Further, even if putting the children in hand-me-downs instead of new clothing purchased by Sandoval could qualify as a specific attack on the parent-child relationship, it was not "offensive to human dignity."

Email Exchange Did Not Start 30-Day Window to Federally Remove State Lawsuit

On Feb. 5, 2025, plaintiff Sibley sued defendants in state supreme court asserting claims, related to Meridian Wildlife Service's termination of his employment, under the ASEA, the ADA, the New York State Human Rights Law, and the U.S. Constitution. Defendant Meridian Wildlife Services federally removed suit on March 21. District court denied Sibley's motion to remand suit back to state supreme court in Schuyler County. Sibley had argued that Meridian's notice of removal was defective as filed more than 30 days after service. Instantly, counsels' emails as to acceptance of service did not create a binding agreement. Rather, the email exchange showed that the agreement was contingent on other factors and was not itself an agreement to accept/waive service. Accordingly, the 30-day removal window did not start until Feb. 15, 2025, when the summons and complaint were delivered to Meridian's counsel.

KINGS | PERSONAL INJURY

Summary Judgment Denied in Action Regarding Fall of Disabled Plaintiff

Plaintiff-mother was wheeling plaintiff-daughter in an adult wheelchair with no seatbelt. Plaintiff brought an action for injuries after plaintiff-daughter fell. Plaintiff moved for summary judgment. The court denied plaintiffs' motion for summary judgment on liability since the mother identified two different locations in front of defendant's property as the defect which caused the accident whereby the wheelchair tipped: a sidewalk defect and an elevated cellar door. However, the court granted dismissal of defendant's affirmative defenses of culpable conduct and comparative fault on the part of plaintiffs. Finally, the court denied defendant's motion to disqualify plaintiffs' attorneys, since there was no conflict of interest.

Summary Judgment for Breach of Contract Claim Granted in Pensions Actions

The court granted summary judgment to plaintiffs, former employees of St. Clare's Hospital Corporation whose pension benefits were reduced or eliminated due to the underfunding of the pension plan, on their breach of contract cause of action against their employer, but denied summary judgment to the moving defendants on the breach of fiduciary duty, NPCL and EPTL causes of action. The court found issues of fact as to whether the Corporation was the alter ego of the Roman Catholic Diocese of Albany and whether the individual officers and directors were entitled to qualified immunity under the Business Judgment Rule.

Auto Firm Is Denied Intervention in Dealerships' Action Against Former Partners, Banks

Auto dealerships and their owners sued the former business partners, banks, and accounting entities alleging they engaged in frauds and schemes to keep car sales proceeds contrary to the Civil RICO Act, and also that they misappropriated the dealerships' trade secrets in the car sales market at other competing dealerships. The Deo Defendants opposed intervention by Proposed Third-Party Intervenor Nissan Motor Acceptance Company LLC. The court denied Nissan's March 18, 2025, motion to intervene. It determined that Nissan's intervention motion was untimely. Nor did the record support Nissan's assertion that its application was timely. Allegedly given a security interest as early as Feb. 10, 2021, Nissan could have moved to intervene from the moment plaintiffs commenced action in 2023. Nissan's intervention could also prejudice the Deo Defendants, requiring additional motion practice and further amendment of an injunction. Nor did Nissan establish that its interest in the instant action would be impaired, and denial of intervention does not deprive Nissan of remedies available elsewhere.
