Fraud Claim Survives Defendant's Motion To Dismiss

Plaintiff brought a case involving a financing arrangement pursuant to which the parties expressly agreed to a particular structure where one of the defendants would receive accounts receivable in a collection account and which the plaintiff would have the ability to sweep, and the defendants pursuant to a wholly separate account, the pre-funding account, would extend credit to certain customers. Defendants moved to dismiss some of the claims. The motion was granted except as to the claim of fraud. The court held the fraud claims were based on his role perpetrating the alleged misrepresentations and mis-directions of funds and transfers to accounts and the collection account of defendant to which the plaintiff could sweep money.

BRONX | CRIMINAL LAW

Criminal Action Dismissed, Prosecution Failed to Produce Defendant to Court

Defendant was charged with one count of assault in the third degree under and related charges. Defendant moved to dismiss the information arguing that while the Bronx District Attorney's Office may have been ready for trial when it filed its statement of readiness, they did not act diligently to produce defendant to court. The motion was granted. The court held that defendant had a right to be present at any material part of the trial process, and although defendant had been moved from Rikers Island to a New York State facility, the prosecution was required to act with due diligence to produce defendant for her court appearances on the pending matter. The prosecution submitted orders to produce to the detaining facilities after it was clear that the previous orders had not been sufficient to produce defendant to court. The court deemed these efforts to produce insufficient. The prosecution was held not to have been ready for trial and to have exceeded its readiness time limit.

28 USC §2255 Sentence Relief Denied; Family History, Support Considered in Sentencing

On April 7, 2023, after a successful "safety-valve" proffer, petitioner pleaded guilty, under agreement, to participating in a conspiracy to distribute fentanyl. He faced up to 20 years' imprisonment, and his advisory Guidelines sentence range was 70 to 87 months in prison. Ultimately, he was sentenced to 60 months in prison. District court denied petitioner 28 USC §2255 sentence relief, rejecting his various claims of counsel's ineffectiveness at sentencing. The record showed that counsel's performance at sentencing did not fall below an objective standard of reasonableness. Further, petitioner suffered no prejudice. Contrary to his assertions, the court considered petitioner's family history and support in imposing sentence varying downwardly from the Guidelines range. That counsel did not specifically argue that the burden on petitioner's family warranted downward departure could not be characterized as falling below an objective standard of reasonableness. Also, the court "baked in" petitioner's safety-valve proffer into its 70 to 87-month Guidelines range.

U.S. - EDNY | CIVIL RIGHTS

Missed Meals Not Constitutional Violation Or Sufficiently Serious Risk to Health

Currently housed at the Suffolk County Correctional Facility (SCCF) inmate Brown has a documented allergy to fish. On June 14, 2024, fish was served at meals at SCCF, absent an alternative leading him to experience, among other things, nausea, weakness, and migraines. The court construed Squire's action alleging violations of 42 USC §1983 as alleging a violation of the conditions of his confinement. Despite granting Squire leave to proceed in forma pauperis, the court dismissed his claims under 28 USC §§1915(e)(2)(B)(i)-(ii) and 1915A(b)(1). Brown's claim that he missed two meals, on the same day, with only limited alleged health effects did not amount to a constitutional violation nor constituted a sufficiently serious risk to his health. Further, Brown did not allege that any defendant acted with deliberate indifference when they gave him two meals he could not eat. The grievance form attached to Brown's complaint suggested that SCCF was not aware of his allergies until the day after the incidents allegedly occurred.

Court Grants Judgment of Foreclosure; No Meritorious Defenses From Defendant

Plaintiff brought an action to foreclose on a consolidated, extended and modified mortgage encumbering a parcel of commercial real property located at 2291 Adam C Powell Blvd. in Manhattan. The mortgage was given by Defendant 7th Realty Holdings to non-party Santander Bank, NA to secure a loan with an original principal amount of \$1,160,000. Plaintiff's motion for summary judgment and issuance of an order of reference was granted. Plaintiff then moved to confirm the referee's report of the amounts due and for a judgment of foreclosure and sale. The motion was granted. The court held it could not discern any meritorious issue raised by defendants in opposition to plaintiff's motion.

RICHMOND | CRIMINAL LAW

Court Designates Defendant as Level Three Sex Offender

Defendant was convicted of forcible touching and sexual abuse in the third degree. The defendant was then sentenced to one year of incarceration with an order of protection. The defendant was further advised that because of his prior criminal history, a conviction of in the instant matter required an assessment of the defendant under the Sexual Offender Registration Act ("SORA"). The court conducted a hearing to determine the defendant's appropriate designation level. The defendant was adjudicated a level three sex offender and designated a predicate sex offender. The court held that while the defendant identified factors not adequately taken into account by the Guidelines and the Board's recommendation, the defendant failed to establish, by a preponderance of the evidence, that a downward departure was warranted, and he was presumptively a level three sex offender pursuant to an automatic override addressing his prior felony sex crime conviction.

U.S. - SDNY | CIVIL PROCEDURE

Unopposed Dismissal Motion Granted; Complaint Did Not Assert Plausible Claim

In April 2023 plaintiff disrobed, while on the street, after consuming too much alcohol. Defendant officer Barbour allegedly accessed video footage thereof from the Greenburgh Police Station, and posted it absent plaintiff's knowledge or consent, in violation of plaintiff's constitutional rights and "contributed to cyber bullying" contrary to the Violence Against Women Reauthorization Act (VAWA). Instantly, the court granted the unopposed motion by Barbour and the Town of Greenburgh to dismiss plaintiff's complaint asserting constitutional rights violations and municipal liability under *Monell*, pursuant to FRCP 12(b)(6). Plaintiff's pro se 2024 complaint did not assert a plausible claim. He did not identify an official policy or practice by the Town that subjected him to a violation of his constitutional rights. Nor did his complaint tie the Town to Barbour's alleged conduct for purposes of the VAWA.

Prior Decision That Reimbursement of Fees, Costs Is Warranted Is Not Disturbed

Another magistrate judge's Jan. 5, 2023, order only partly granted plaintiff United Pool Distribution's motion to compel. That magistrate granted that portion of United Pool's motion seeking reimbursement of attorney's fees and costs incurred in making the motion. No agreement between the parties was reached as to the amount of reimbursement, prompting United's Jan. 19, 2023 fee application. Presently, district court denied defendant Custom Courier Solutions' request to reconsider the decision to award fees, and awarded United \$3,370 in attorney's fees. The cases reassignment was not itself a basis to revisit the prior magistrate's prior orders or to make de novo determinations as to issues already resolved. The court found no basis to disturb the prior magistrate's decision that reimbursement of fees and costs was warranted. Applying certain rate and hour reductions, district court found the \$3,370 fee award reasonable.

NEW YORK | TRUSTS AND ESTATES

Court Allocates Estate to Decedent's Distributees

Pursuant to the accounting in the estate of James M. Kay, the public administrator requested a determination of the identity of decedent's distributees. Objectant filed objections to the petition and objected solely to the public administrator's designation of her as an alleged distributee. A kinship hearing was held. The objectant was named a distributee based upon the proof submitted at the hearing and documentary evidence. The court ordered the public administrator to deposit one-half of the net estate with the Commissioner of Finance for the City of New York for the benefit of decedent's maternal distributees. The remaining one-half of the net estate shall be split into equal shares for the benefit of decedent's paternal distributee.

SUFFOLK | CLASS ACTIONS

Class Action Denied in Case Related To Graham Crackers

Plaintiff commenced a putative class action under GBL §§ 349 and 350, alleging that defendant misleadingly marketed its store-brand graham crackers as containing 8g of whole grain, when enriched flour was the predominant ingredient. Defendant moved to dismiss, asserting the labeling was not materially misleading and that plaintiff failed to plead actual injury. The court held that a reasonable consumer would not be misled, as the packaging clearly disclosed the amount of graham flour and the use of enriched flour. The court also found no plausible allegation that the \$2.39 product was priced above comparable alternatives. Because statutory damages under GBL §§ 349 and 350 constitute penalties, and plaintiff did not waive such recovery, the class action was barred. The motion to dismiss was granted, reaffirming that conclusory allegations of deception and speculative pricing harm are insufficient to sustain GBL claims or support class certification.

28 USC §2254 Relief Denied; Prison's Warden Is Only Proper Respondent

On Aug. 18, 2021, Squire was arrested for assault in the second degree and resisting arrest. He pleaded guilty to second-degree assault, and was sentenced to one-and-a-half to three years' incarceration. A prior petition for relief under 28 USC §2254 was dismissed due to failure to exhaust remedies in state court. His instant such petition named the Elmira Correctional Facility as sole respondent and challenged his custody arising from the Aug. 18, 2021, convictions. Although granted in forma paupers status, the court dismissed Squire's instant petition seeking §2254 relief. His petition named an improper respondent and was unexhausted. Nor did Squire substantially demonstrate that he was denied any constitutional right. The only proper respondent was the warden of the Elmira Correctional Facility. Nor did Squire appeal the grounds raised in his petition to the highest state court. He did not seek review from the New York Court of Appeals.
