DECISIONS OF INTEREST

NEW YORK | WRONGFUL DEATH

Dismissal of Wrongful Death Action Against State Denied

A Notice of Intention to File a Claim alleged that during the incarceration of Travis Robinson at Sing Sing Correctional Facility, Robinson was involved in an incident at Sing Sing which caused him to fear for his life. Robinson then approached a DOCCS staff for protection after the incident but was told that there was nothing that could be done if Mr. Robinson was unable to identify the person or persons involved in the incident. The State moved to dismiss the wrongful death claim. The motion was denied. The court found the allegations to be sufficiently specific to meet the jurisdictional pleading requirements of the Court of Claims Act. The allegations also provided a sufficiently detailed description of the particulars to enable the State to investigate and promptly ascertain the existence and extent of its liability for the alleged wrongful death.

Pruchnick v. State of New York, 142582 (March 11)

NEW YORK | CREDITORS' AND DEBTORS' RIGHTS

Court Allows Plaintiff to Amend Complaint And Add New Causes of Action

Plaintiff commenced a proceeding against defendant in connection with defendant's purported collection of a debt. Plaintiff argued that Defendant's utilization of a third-party vendor to send the collection letter to plaintiff gave rise to negligence, negligence per se and negligent misrepresentation, as well as violation of the New York General Business Law and the Fair Debt Collection Practices Act. Plaintiff moved to file an amended complaint, seeking to join two new parties as defendants and asserted five causes of action. Plaintiff's motion was granted. The court held that there was nothing to suggest that the proposed amended complaint would result in defendant being surprised or prejudiced, as the asserted five causes of action were the same substantive claims plaintiff alleged in its original complaint.

Harris v. Trueaccord Corp., CV-008320-23/NY (March 13)

KINGS | CIVIL PROCEDURE

Vacatur of Nearly Fourteen-Year-Old Judgment Denied

In support of a motion to vacate a nearly 14-year judgment, defendant and his plumbing company denied knowledge of a lawsuit until his bank notified him that his account was restrained. The motion to vacate was denied. The court held that the record contained three instances of confirmed mailings of papers to moving defendants yet never, until nearly 14 years after the judgment was entered, purportedly after a bank account was restrained, did moving defendants appear. The court further held that if the judgment plaintiff possessed was vacated, odds were that by the time the matter went to trial after the requisite discovery took place, she would not benefit from any successful verdict.

KINGS | CONTRACTS

Summary Judgment Denied; Plaintiff Failed To Meet Prima Facie Burden

Plaintiff commenced an action against defendant alleging twenty-five allegations of fact in support of three denominated causes of action. The first was for breach of contract, the second was for breach of a guaranty agreement, and the third was for unjust enrichment. Plaintiff Mantis Funding LLC sought an order granting it summary judgment against the defendants on its claims for breach of contract, breach of a guaranty agreement, and unjust enrichment. The court denied summary judgment finding the plaintiff failed to meet its prima facie burden to establish that the defendants breached the alleged agreement between the parties, without reaching the sufficiency of the defendants' opposition.

QUEENS | CRIMINAL LAW

Indictment Proper, Evidence Showed Gross Deviation From Expected Behavior

Defendant was indicted on charges of manslaughter in the second degree, criminally negligent homicide, reckless driving, and aggravated unlicensed operation of a motor vehicle in the third degree. Defendant moved by omnibus motion to either dismiss or for suppression of evidence. The motion to dismiss was denied. The court held the totality of defendant's actions as presented to the grand jury permitted logical inferences that his behavior evinced a gross deviation from the expected behavior of a reasonable driver in his situation, and that his conduct was a foreseeable and actual contributory cause of decedent's death. The evidence presented was both competent and legally sufficient to provide reasonable cause to believe he committed every element of the charges in the indictment.

ORANGE | MEDICAL MALPRACTICE

Summary Judgment Denied, EDTPA Does Not Apply to Conditions Other Than COVID

Plaintiff brought a case involving injuries allegedly sustained by the plaintiff-patient while in defendant's facility receiving medical treatment, alleging negligence, medical malpractice, lack of informed consent, and loss of consortium. Principally, plaintiff alleged that he suffered pressure ulcers and wounds while under treatment for COVID-19 in January 2021, which were caused by the defendant's negligence. Defendant moved for summary judgment arguing entitlement to immunity under the former New York Emergency or Disaster Treatment Protection Act ("EDTPA"). The court held that defendant was not entitled to immunity because the statute, as amended in August 2020, did not immunize health care services that were provided for conditions other than COVID-19.

SECOND CIRCUIT | IMMIGRATION LAW

Second Circuit Orders Transfer of Turkish Student to Immigration Custody in Vermont

This case arose from the arrest and detention of petitioner, a young Turkish graduate student who entered the U.S. legally pursuant to a valid student visa. In March 2025, law enforcement officers arrested petitioner near her home in Massachusetts without warning. Unaware of her location, petitioner's counsel brought a habeas petition in the District of Massachusetts, alleging she was detained based solely on an op-ed she wrote over a year before her arrest. However, when the petition was filed, petitioner had already been driven across state lines to Vermont and when the government eventually disclosed petitioner's location, she had again been moved, this time to a correctional facility in Louisiana. The petition filed in Massachusetts was transferred to the District of Vermont, and the district court ordered the government to transport petitioner from immigration custody in Louisiana to immigration custody in the District of Vermont. The Second Circuit denied the government's motion for an emergency stay of the transfer order, holding that it failed to meet its burden to justify such a stay.

U.S. - SDNY | BANKRUPTCY

Poor Drafting of Parties' Agreements Does Not Convert Debtor's Conduct Into Fraud

Atlantic City appealed bankruptcy court orders dismissing its adversary proceeding against debtor W. Wesley Drummon, who filed for protection under chapter 7 of the Bankruptcy Code. The City contended Drummon defrauded it, and sought to exclude the \$3 million it alleged Drummon owes it from discharge. The facts giving rise to this dispute stemmed from contracts between the City and an entity associated with Drummon. Among other things, the City argued the bankruptcy court erred when it granted Drummon summary judgment because it ignored disputed facts that establish Drummon defrauded the City. The instant court affirmed the bankruptcy court's orders, holding that while poor drafting of a Memorandum of Understanding and an Escrow Agreement led to unfortunate results for the City, that did not convert Drummon's conduct into fraud. The court also found no evidence Drummon engaged in willfully malicious conduct concerning the City. Finally, the court held the City's failure to specify facts as to which it wanted the bankruptcy court to draw an adverse inference was an appropriate basis for the bankruptcy court to deny its adverse inference motion.

The City of Atlantic City v. Drummon, 24-CV-1668 (May 7)

U.S. - EDNY | ANTITRUST

Court, Parties in Sherman Act Case Agreed On Threshold Relevant Market Requirement

The NA Soccer League alleged U.S. Soccer Federation and Major League Soccer violated Secs. 1 and 2 of the Sherman Act by conspiring to exclude plaintiff from the markets for Div. 1 and Div. 2 men's professional soccer leagues in the U.S. and Canada. After a jury returned a verdict for defendant, plaintiff moved for a new trial, arguing "the verdict form, jury instructions, and related orders improperly required the jury to reject [plaintiff's] claims unless it found that [plaintiff] proved one of its four specific relevant markets"; claiming the court made "seriously erroneous evidentiary rulings pertaining to the relevant market"; and alleging "the admission of a substantial amount of inflammatory and prejudicial evidence was a serious error that had a cumulative prejudicial effect and tainted the verdict." The court denied the motion. It noted that, as the parties and the court all agreed on the threshold relevant market requirement with respect to each count, the court instructed the jury that it needed to find as much. The court added that even had plaintiff not waived its challenges regarding the relevant market instruction, it was also wrong on the law as applied.

U.S. - EDNY | SECURITIES LITIGATION

Court Denies Request to Release Escrow Funds In Action Alleging Securities Law Violations

The Securities and Exchange Commission sued defendants Richard Xia and Fleet New York Metropolitan Regional Center LLC for violations of federal securities laws and sued the relief defendants for unjust enrichment as a result of defendants' alleged violations. Defendants submitted a request from non-party John Leo to allow funds held by Xia's former counsel in an escrow account to be transferred to Leo. The instant court denied Leo's request to modify the court's preliminary injunction order to release \$717,940 of frozen funds, concluding that Leo's statement that he intended to use the escrow account funds for "daily operations of the regional centers and defending any action filed against the Leo Entities," without more, does not satisfy the high burden for modifying a preliminary injunction. Similarly, the court held that neither Leo nor defendants demonstrated that releasing over \$700,000 of frozen funds would be in the best interests of the defrauded investors, especially since the Fleet EB-5 investors have the option of moving their investment to another regional center if Fleet is terminated from the EB-5 program.
