NEW YORK | CIVIL PROCEDURE

CA Law Applies in Action Where Defendant CA Lawyer Performed the Bulk of His Services

An action arose after the end of a 13-year relationship in which defendant Sweeney provided legal services to plaintiff. Plaintiff sued Sweeney and Avant Garden Management, asserting 10 causes of action that sought to recoup fees plaintiff paid them during those years. Sweeney and others later sued plaintiff and plaintiff-controlled entities in CA state court, a suit that was removed to CA federal court. The CA federal court dismissed the CA action due to lack of personal jurisdiction over defendants. Defendants filed counterclaims against plaintiff similar to the claims they asserted in the CA action. Plaintiff's sole remaining claim in his action sought a declaratory judgment on "whether and to what extent Sweeney is entitled to unpaid amounts now or in the future pursuant to any purported oral contingency agreement," which the court had held was an issue governed by CA law. The instant court held CA law applies to all claims in this action noting, among other things, that plaintiff went to CA to meet with Sweeney, a CA lawyer living in CA, whereupon they entered into an oral contingency fee agreement in CA under which Sweeney performed the bulk of his services in CA.

QUEENS | CRIMINAL LAW

Court Partly Grants Motion to Preclude Late-Disclosed Witnesses, Upholds COC's Validity

Defendant, who was charged with Assault in the First Degree and related charges, moved to invalidate the People's certificate of compliance (COC). After a series of supplemental COCs filed 14 days before trial, where the People added two EMS paramedics and representatives from the NYDMV and the NYCHA to their witness list, defendant contended the People provided belated discovery. The court granted defendant's motion, in part. The court held that the People acted in good faith, exercised due diligence, and made reasonable efforts to comply with their statutory obligations. However, the court granted defendant's motion for preclusion as to the two EMS paramedics because the People failed to explain their belated disclosure to add them to their witness list. Finally, the court found no basis to invalidate the COC on the ground the People failed to identify the DMV and NYCHA representatives who will testify at trial or their decision to add these witnesses to the People's list. Accordingly, the court held the material provided by the People in their supplemental COC was proper and in compliance with the procedures set forth in CPL §§245.60 and 245.50(1-a).

SECOND CIRCUIT | CIVIL APPEALS

Panel Upholds Fee Award Against Exxon For Unreasonable Remand Opposition

NYC sued Exxon in NY state court for deceptive advertising practices under NY state law. Exxon removed the case to the district court, which stayed the motion to remand to await decision in a similar case pending in this court in which Exxon was appealing a decision of the District of CT remanding to CT state court. After the Second Circuit affirmed the district court's order remanding the similar case, the district court in the instant case lifted the stay, denied the motion to remand, and invited the parties to re-brief the case with the benefit of the panel's decision in CT. NYC refiled its motion to remand and sought attorneys' fees and costs. The district court granted the motion for remand and awarded fees only with respect to five of the six grounds that Exxon had asserted as a basis for removal and only for Exxon's renewed efforts to oppose remand. The district court held Exxon had not acted reasonably in continuing to press arguments that had already been rejected in the CT decision. The Second Circuit affirmed, finding the district court did not abuse its discretion in awarding fees and costs, in part, for work done after the panel issued its decision in CT.

U.S. - EDNY | DISCOVERY

Interrogatory That Seeks Relevant Information On New Sales Tax Claims Is Not Overbroad

Plaintiffs commenced a class action lawsuit on behalf of themselves and others similarly situated against the GEICO defendants, asserting breach of contract and violations of New York General Business Law §349. Plaintiffs ultimately sought an order compelling defendants to provide substantive responses and documents in response to plaintiffs' document demands and interrogatories as well as to overrule defendants' objections. Plaintiffs contended that all of their document requests and interrogatories are relevant to their sales-tax claims and Federal Rules of Civil Procedure 23 class action allegations. Among other things, Interrogatory Number Two stated "[a]re there any differences among the GEICO Companies in how they determine the amount a Claimant is owed in sales tax, including whether the manner is different if the loss vehicle is owned, financed, or leased or if the Claimant is a third-party." The court granted plaintiffs' motion to compel, in part, concluding that Interrogatory Two is not overbroad and seeks relevant information as to plaintiffs' new claims regarding sales tax.

NEW YORK | EMPLOYMENT LITIGATION

Genuine Dispute Exists Over Whether Employee Was Treated Less Favorably Due to Age

Plaintiff, the former head of defendant's settlements department, alleged that her supervisor was biased against older employees, as evidenced by his reference to plaintiff as "legacy baggage" and describing employees who, like plaintiff, had been with the company for many years, as "dinosaurs." Plaintiff ultimately took a leave of absence, allegedly due to anxiety induced by her work environment. Upon plaintiff's return, she was given another negative performance review and was terminated and replaced by her younger colleague. Defendant moved for dismissal of the complaint, arguing it had a legitimate, non-discriminatory reason for firing her, specifically poor performance. The court held plaintiff failed to adequately rebut defendant's reason for firing her but found that she raised an issue of fact as to whether she was treated less well than other employees based on her age for the purposes of the NYS Human Rights Law. The court also found plaintiff failed to show she was denied benefits based on her disability, and that her retaliation claims based on her poor performance reviews also failed because the related issues pre-dated her medical leave and complaints to HR.

RICHMOND | FAMILY LAW

Court Sanctions Husband in Matrimonial Action \$5,000 for False Bigamy Accusation

In a suit that arose from a matrimonial action, wife moved for spousal maintenance, attorneys' fees, and sanctions against husband for allegedly filing false reports and family offense petitions constituting frivolous conduct, while husband moved for child support. Husband also accused wife of bigamy, leading to her arrest. The court held husband must pay \$5,000 as a sanction for egregious misconduct, as he failed to offer substantiating evidence that wife is a bigamist. The court noted that the fact that a matrimonial litigant would brand his spouse a bigamist during divorce proceedings, without evidence and in direct contravention of the parties' recent parenting agreement, is recklessness bordering on the unconscionable. The court added that imposition of sanctions is imperative and serves the function of compensating wife for injuries inflicted and deterring husband, and others similarly inclined, from employing falsehood and intimidation as litigation tactics. Finally, the court granted wife spousal maintenance in the amount of \$2,157 per month and attorneys' fees in the amount of \$14,500 and granted husband child support in the amount of \$1,525 per month.

SECOND CIRCUIT | ANTITRUST

Second Circuit Revives Health Centers' Antitrust Suit Over Drug Discount Restrictions

Federally funded health centers and clinics filed a class action lawsuit against drug manufacturers alleging violations of federal and state antitrust laws, and state common law, via concerted action to restrict drug discounts offered to contract pharmacies. A district court dismissed the first amended complaint and denied leave to file a second amended complaint. The instant appeal was about whether plaintiffs met the low pleading threshold for surviving a motion to dismiss. The Second Circuit held that plaintiffs' proposed second amended complaint pleaded sufficient facts to substantiate their antitrust allegations at the motion to dismiss stage. Accordingly, the panel concluded that the district court erred in denying plaintiffs' motion for leave to amend their complaint as futile and ultimately dismissing plaintiffs' complaint. Specifically, the panel found that the proposed second amended complaint pleaded enough facts to give rise to a plausible inference of a horizontal price-fixing conspiracy under Section 1 of the Sherman Act. As a result, the panel vacated the district court's dismissal of the complaint and remanded the case to the district court.

U.S. - WDNY | CIVIL RIGHTS

Plaintiff May Amend §1983 Claim Over Alleged Unauthorized Urine Test at Hospital

Plaintiff gave birth to a daughter at defendant Strong Memorial Hospital. She claimed that while she was in the middle of intense labor, defendant nurse took urine out of her catheter bag to test it for drugs. Plaintiff maintained the urine was taken against her wishes and without her consent. Plaintiff further maintained she specifically denied any urine screens and made a plan of care with her doctor that stated that no urine screens were required. Plaintiff alleged the nurse colluded with a social worker and performed the urine screen to have her newborn daughter removed from her care. Plaintiff also alleged the nurse told the social worker that plaintiff and her newborn baby had tested positive for cocaine, which was untrue. Plaintiff brought a civil rights action against defendants, alleging that they violated her constitutional rights. The court granted plaintiff's motion to amend her complaint as to her claims under 42 USC §1983 and denied all other motions, noting that it was unable to conclude that it is beyond a doubt that plaintiff would be unable to plead a set of facts that would entitle her to relief under §1983.

NEW YORK | ADMINISTRATIVE LAW

Towing Company's Suit Alleging Bribery, Conspiracy in License Renewal Denial Tossed

Plaintiff towing storage company brought an action to recover damages allegedly sustained when defendant New York City Department of Consumer Worker and Protection (DCWP) denied plaintiff's license renewal application. Plaintiff contended that the DCWP's decision was the product of bribery, misconduct, and a conspiracy between two individual defendants, the owner of a competing tow company and the former NYC Department of Buildings Commissioner. Among other things, the court dismissed all causes of action against the municipal defendants on the grounds that plaintiff already litigated the issue of the DCWP's decision not to renew plaintiff's license in two prior lawsuits, the agency's determination is supported by the record, and plaintiff failed to allege sufficient facts against the municipal defendants. The court added that this action must be dismissed against the DCWP because City agencies are not legally cognizable entities and therefore are not proper parties. The court also dismissed all causes of action against the individual defendants, holding that plaintiff failed to plead sufficient facts demonstrating disinterested malevolence and but for causation.

ORANGE | ADMINISTRATIVE LAW

Planning Board's Denial of Warehouse Permit Was Improperly Based on Community Pressure

Petitioners, the owners of the subject property within the Town of Wawayanda, challenged the Town of Wawayanda's Planning Board's denial of a special permit for construction of a warehouse facility, despite the Town's earlier determination that the project would have no adverse impact on the environment under the State Environmental Quality Review Act (SEQRA). Petitioners contended that the Planning Board improperly based its decision on generalized public opposition. The court held that the Planning Board's decision was arbitrary and capricious and not supported by substantial evidence given its prior comprehensive SEQRA determination on the same alleged concerns. The instant court granted the petition and annulled as arbitrary and capricious the Planning Board's determination denying petitioners' special permit. The court remitted the matter to the Planning Board to issue the special permit to petitioners. Among other things, the court found that the Planning Board, despite its prior precedent, appeared to have bowed exclusively to community pressure that accelerated after its detailed and comprehensive negative declaration.

U.S. - SDNY | CLASS ACTIONS

Conditional Certification Granted in Suit Over Unpaid Overtime at Zoni Language Centers

Plaintiffs, who worked as student services reps for Zoni Language Centers, sued on behalf of themselves and a putative class and collective under the Fair Labor Standards Act (FLSA) and NY and NJ state wage laws, asserting that Zoni and Vice President Julio Nieto, who sets policies for all Zoni schools subject to approval of Zoni president Zoilo Nieto, failed to pay them the appropriate minimum wage and overtime rates for their work and failed to pay commissions. Plaintiffs moved for an order "conditionally certifying" the case as an FLSA collective action, alleging they were required to meet certain performance goals that could not be met within just 40 hours in a week and that management had a policy of not paying overtime, which they understood applied to all hourly employees. In fact, one plaintiff attested Julio Nieto told her that if she needed to work over 40 hours per week to meet quotas she would not be compensated. The court granted the motion in part, holding plaintiffs satisfied the low burden for securing "conditional certification" for other student sales reps by attesting they were subject to a common policy of being required to work overtime without pay.
