NEW YORK | PERSONAL INJURY

Motion to Dismiss CVA Action Denied; Defendant Had Duty to Supervise Plaintiff

Plaintiff commenced a Child Victims Act (CVA) action seeking damages for alleged sexual abuse at the hands of two priests. Plaintiff asserted causes of action for negligence, negligent supervision and training of employees, and negligent retention of employees. Church of the Immaculate Conception moved for summary judgment and dismissal of the action. The motion was denied. The court held the facts showed that plaintiff was abused when he was a child and on the premises of the church. There was also reason for movant to know that the priest required detailed supervision based on the numerous transfers he had prior to coming to Immaculate Conception. Defendant was obligated to protect plaintiff against the foreseeable risk of harm by the priests to plaintiff on its premises. The court found that movant had a duty to plaintiff to supervise both plaintiff and the priest while they were on the premises of Immaculate Conception.

NEW YORK | CRIMINAL LAW

Motion to Dismiss Assault Charges for Speedy Trial Time Violations Denied

Defendant was arrested and charged with one count each of assault in the third degree, one count of aggravated harassment in the second degree, one count of attempted assault in the third degree, and one count of harassment in the second degree in New York County Criminal Court. Defendant moved to dismiss pursuant to speedy trial violations. The motion was denied. The court held the record reflected that the Manhattan District Attorney's Office was ready for trial on the date. Secondly, the court found the People's initial certificate of compliance (COC) to be valid, made in good faith after exercising due diligence. Once the People filed a valid COC, violations of their discovery obligations do not implicate their trial readiness. The belatedly disclosed video surveillance footage could not implicate speedy trial, and the People could not be charged for it. The People were attributed 82 days of time, well within the 90-day statutory allowance.

SECOND CIRCUIT | INSURANCE LAW

Panel Vacates GEICO Win After State Court Limits No-Fault Licensing Rule in Kickback Case

GEICO sued defendant and two of his acupuncture clinics, alleging they paid third parties "kickbacks" for referring patients eligible for no-fault insurance benefits to another defendant-owned clinic, which provided medical services and billed GEICO. The district court granted GEICO summary judgment, holding that the referral payments violated New York's professional conduct rules and the provider failed to meet a licensing requirement under the state's no-fault "Eligibility Regulation," 11 N.Y.C.R.R. §65-3.16(a)(12), thereby allowing the insurer to deny payment. The Second Circuit certified a question to the New York Court of Appeals asking whether referral kickbacks alone disqualify a provider from receiving no-fault payments under the regulation. The state court held the regulation permits denial of payment only when misconduct involves ceding control of a professional services corporation to an unlicensed individual, not merely paying for patient referrals. Because the district court relied on a broader interpretation, the panel vacated and remanded for further proceedings in light of the state court's clarification of New York law.

10th Pro Se Drug Injury Suit Dismissed; Filing Injunction for Repetitive Claims Imposed

Before the court was the 10th complaint filed by pro se plaintiff, who alleged injuries after taking Invega, a drug manufactured by a wholly owned subsidiary of Johnson & Johnson. Plaintiff also filed an application to proceed in forma pauperis (IFP). Defendant submitted a letter requesting a premotion conference in anticipation of a motion to dismiss under Federal Rule of Civil Procedure 12(b)(6) and further sought the entry of a filing injunction based on plaintiff's repeated litigation of the same underlying allegations. The court granted plaintiff's IFP application for the limited purpose of resolving its order but dismissed the complaint pursuant to 28 U.S.C. §1915(e)(2)(B)(i) and (ii), which require dismissal of IFP actions that are frivolous or fail to state a claim, as well as under Rule 12(b)(6) for failure to plead a plausible claim for relief. Citing plaintiff's repeated filing of substantially similar actions concerning alleged injuries from Invega despite prior dismissals, the court further imposed a narrowly tailored filing bar, prohibiting plaintiff from filing any additional related actions without first obtaining leave of court.

NEW YORK | LANDLORD TENANT LAW

Commercial Holdover Proceeding Dismissed; Identical Action in Another Court

In a commercial nonpayment proceeding, the court granted the respondent tenant's motion to dismiss a commercial holdover proceeding after determining that a related action involving the same lease dispute was already pending in the Supreme Court of the State of New York. The court found a substantial identity of parties and claims between the two matters and concluded that dismissal was warranted under CPLR 3211(a)(4) to avoid duplicative litigation. Petitioner's counterclaims in the Supreme Court Action, particularly those for ejectment and attorney's fees, were not adjudicated. Petitioner's memorandum of law in opposition stated that they have filed a motion to withdraw their ejectment counterclaim. Based on the court's reviewing of the New York State Supreme Court filing system in the related Supreme Court Action, the motion was not decided. The landlord's cross-motion seeking fees and sanctions was denied.

BRONX | CRIMINAL LAW

Court Denies Dismissal of Sexual Harassment Charge, NYCDoc Not Subject to Discovery

Defendant, an incarcerated person on Riker's Island, allegedly slapped the buttocks of a corrections officer on September 23, 2025. The misdemeanor complaint was filed, and the defendant was arraigned on October 6, 2025. At arraignment, the court deemed the complaint to be a misdemeanor. Defendant sought to invalidate the Bronx District Attorney's Office's certificate of compliance because the People allegedly belatedly disclosed or failed to disclose discovery from the New York City Department of Corrections (NYCDoc). The court denied the motion to invalidate because the People's initial discovery obligation under CPL 245.20(1) requires disclosure of items and information possessed or constructively possessed by the prosecution, the police or a law enforcement agency. Under CPL 245.20(2), NYCDoc was only an administrative agency and not law enforcement. Thus, any alleged discovery failures could not invalidate the People's certificate of compliance.

Court Confirms Arbitration Win in \$6 Million Bitcoin Hack Dispute; Challenge Untimely

Petitioner claimed to have lost nearly \$6 million worth of Bitcoin he maintained on a server provided by DigitalOcean, as a result of a 2021 hack of DigitalOcean's internal network. Over two years after the hack, petitioner brought an arbitration against DigitalOcean before the American Arbitration Association (FAA), arguing DigitalOcean was grossly negligent. An arbitrator issued a final award in favor of DigitalOcean, holding that its terms of service placed responsibility for securing data stored on its cloud services on the customer, not the company, and crediting DigitalOcean's expert testimony that its cybersecurity measures were reasonable and that petitioner failed to take adequate steps to protect his cryptocurrency. Petitioner now argued the award should be vacated for manifest disregard of the law, arbitrator bias and an unfair proceeding. The instant court granted DigitalOcean's cross-motion for summary judgment to confirm the award, concluding that the petition was untimely because it was not served within the FAA's three-month deadline and, in any event, failed on the merits under the highly deferential standard governing review of arbitration awards.

U.S. - NDNY | GOVERNMENT

Citing Unlawful Appointment, Court Upholds Disqualification of Acting U.S. Attorney

The court denied the federal government's motion for a stay pending appeal of an earlier order that quashed two grand jury subpoenas issued to the Office of the New York State Attorney General and disqualified John A. Sarcone III from participating in related investigations. The subpoenas, which concerned civil enforcement actions brought by the state against President Trump and the National Rifle Association, had been personally directed by Sarcone while purporting to serve as Acting U.S. Attorney. In its earlier ruling, the court found Sarcone's appointment unlawful under the Federal Vacancies Reform Act because he was not the First Assistant when the vacancy occurred and could not lawfully assume acting status through a general delegation of authority. The court held the federal government failed to show a strong likelihood of success on appeal or irreparable harm absent a stay, noting that the government could continue the investigations through properly authorized officials. The court further found that granting a stay would injure the state by reinstating an official who lacked lawful authority.

Court Finds for Plaintiff \$7,454 for Defendant's Negligent Repairs

Plaintiff Eleanor Thomas testified that she was the owner of a 2014 Nissan pathfinder. Her vehicle stalled and she called GEICO emergency roadside assistance who referred defendant Snap Towing to assist and tow her vehicle. When defendant Snap arrived, plaintiff tried to explain to Snap that the key would not start the vehicle. Defendant Snap towed her vehicle to an auto repair shop, defendant Manhattan Auto Repair at 552 West 48 Street in Manhattan. After she waited several days, she received a telephone call from defendant Manhattan's employee who told her she needed a new transmission and it would cost \$5,659 to repair. Plaintiff's car continued to break down and she had to get it fixed again. Plaintiff sued defendant for \$12,568.23. Judgment was awarded to plaintiff in the amount of \$7,454. The court held plaintiff established that Manhattan was liable for negligent repairs to plaintiff's vehicle pursuant to Vehicle and Traffic Law § 398-e[2][a][i], as it failed to fix the vehicle's key start issue despite plaintiff's complaint that the only issue was that the key would not start her vehicle and returned plaintiff's vehicle with rear-end damage.

Court Imputes Child Support Calculations On Father in Matrimonial Hearing

The Commissioner of Social Services filed a petition on behalf of Daisha R to establish support for Daisy born December x, 202x and Datura born January x, 202x. The father's registries reflect that Daisha R and Byron D are the parents of Daisy and Datura. On September 18, 2025, an attorney was present representing the Commissioner of Social Services. Byron D was present waiving counsel, and Daisha R was not present. Byron D stated that he stopped working a couple of weeks ago at Mxxx Security at \$17 an hour and there were a couple of months where custody was shared 50/50 with Daisha R. The court directed the Commissioner to have Daisha R participate for the next appearance to address custody and support. The court held that Byron's D child support would be \$25 from January 2026 to October 2026 and then after \$197.85 weekly. The court held the record lacked too many facts that would not be filled with assumptions to grant the Commissioner's application of imputing minimum wage income to Byron D.

U.S. - SDNY | COPYRIGHTS

Copyright, Unfair Competition Claims Over Electrical Outlet Faceplate Design Dismissed

Metro Light & Power LLC alleged that defendants, which manufacture competing electrical outlet face plates for furniture, infringed its copyright in a flush-mounted bezel face plate design. The court dismissed Metro's federal copyright and New York unfair competition claims, determining that the design was a "useful article" feature that could not be separated from the functional outlet and therefore was not eligible for copyright protection. The court also concluded that the complaint failed to plausibly allege consumer confusion or bad faith misappropriation. The court further rejected Metro's attempt to base its claim on copyrighted photographs of the face plate, finding that this was an impermissible attempt to obtain copyright protection for the underlying product design. However, the court granted Metro limited leave to amend its complaint to pursue a narrower copyright theory based on allegations that defendants copied images from Metro's website and used those images in internal systems or sales materials, which the court noted could constitute unlawful reproduction under the Copyright Act.
