NEW YORK | CLASS ACTIONS

Court Dismisses Plaintiff’s Class Action Against Police for Lack of Standing

In a proposed class action, plaintiff sought a declaratory judgment and permanent injunction against the New York City Police Department on behalf of himself and all others similarly situated. The proposed class consisted of all people who are or will be handcuffed by the NYPD at their criminal court arraignment in New York City based on the NYPD’s arraignment restraint policy. The City moved to dismiss. The court granted the City of New York’s pre-answer motion to dismiss a proposed class action. The court held that the procedural requirements set forth in *People v. Clyde* and *People v. Best* were only applicable at a fact finding, did not apply to the NYPD, and did not apply prior to arraignment. As pled, the plaintiff lacked standing, and his claims were not ripe.

NEW YORK | TRUSTS AND ESTATES

Petition Granted; Respondent Did Not Raise Issue of Fact Regarding Trustees’ Claim

The trustees of the trusts created under the will of Catherine H. Carpenter for the benefit of Helen H. Beekman and Samuel H. Hinckley petitioned the court for an order allowing them to withdraw rent deposits in the amount of \$286,125, as well as any remaining balance held by the New York City Department of Finance, Treasury Division. The petition was granted. The court held nothing in respondents’ answer raised an issue of fact that required a trial of the trustees’ claim to the funds at issue. The court noted, in addition, that there was no pending litigation between the parties in the court, the last proceeding having been determined by decree dated May 1, 2025.

KINGS | PERSONAL INJURY

Court Denies Motion; Action Had Been Pending for Four Years

Plaintiff was a foster child in a family who worshipped at St. Joseph. In 1985 to 1988, when plaintiff was ten to twelve years old, she was a parishioner and a catechism student at St. Joseph. As a catechism student, plaintiff had contact with Father Offenheiser. Offenheiser began grooming plaintiff shortly after her arrival at St. Joseph. Offenheiser was aware that plaintiff was in foster care and went out of his way to provide special instruction by isolating plaintiff from her peers. Defendant submitted an answer. The court conducted an *in camera* review of Offenheiser’s personnel file and ordered much of the material defendant had redacted produced. Defendant failed to comply with court order. Defendant moved to vacate or modify the order. The motion was denied. The court held there was no basis to issue a stay. The Diocese had already deliberately failed to comply with the court order, and the action now pending for four years, was still struggling to complete discovery and reach a note of issue.

Summary Judgment Denied to Both Parties In De Novo No-Fault Insurance Action

Following adverse No-Fault insurance arbitration awards of arbitrators Cathryn Ann Cohen and Steven Rickman, American Transit Ins. Co. (ATIC) commenced a de novo action pursuant to Insurance Law § 5106(c). ATIC and the health care provider, Gentle Care Acupuncture P.C. each moved for summary judgment. The court denied Gentle Care’s motion because its attorney who submitted an affirmation did not attest to personally mailing the subject NF-3 claim forms or to receiving the appurtenant NF-10 denials, and his listing of claim form amounts conflicted with the amounts on the claim forms. The court denied ATIC’s motion because in each instance the respective NF-10 denial was issued more than 30 days after the respective claim form was received, contrary to Insurance Law § 5106(a)’s 30-day deadline to process a No-Fault claim.

American Transit Insurance Company v. Gentle Care Acupuncture P.C., 513843/2023 (July 11)

KINGS | INSURANCE LITIGATION

Summary Judgment Denied, Plaintiff Suffered Severe Injuries Qualified Under Statute

It was alleged that plaintiff sustained a qualifying serious personal injury under Insurance Law § 5102 (d) in one or more of the following categories: fracture; permanent loss of use; significant limitation of use; and the 90/180-day specifically, the Bill of Particulars alleged that, as a result of the underlying accident, plaintiff injured their cervical spine, lumbar spine, and left knee. Defendant moved to dismiss. The motion was denied. The court held plaintiff’s foregoing submissions were sufficient to raise triable issues of fact as to whether plaintiff sustained a serious injury as a result of the underlying accident and were sufficient to overcome defendant meeting their prima facie burden. Expert opinion, based upon examinations conducted both shortly after the accident and recently, was that plaintiff suffered significant, quantified restrictions in their range of motion; plaintiff’s injuries were permanent in nature; and plaintiff’s injuries were caused by the underlying accident.

SUFFOLK | LITIGATION

Court Continues Restraints on Landlords Pending Ongoing Litigation

Plaintiff SiteOne Landscape Supply, LLC petitioned the court by way of Order to Show Cause seeking a Temporary Restraining Order and Yellowstone injunction. The Defendants, Narrow Way Realty LTD., 3 Girls 1 Boy, LLC, and Don Caroleo Ventures, LLC opposed the application in all respects. The court decided to continue the temporary injunction and the restraints on the landlords. The court held the complexities of the lawsuits moved the court to consider and order different relief as to which the court deemed just and proper.

SECOND CIRCUIT | DISPUTE RESOLUTION

UBS Knowingly Relinquished Right To Arbitrate by Acting Inconsistently Therewith

Plaintiff foundation trustees’ claim under the Investment Advisers Act and New York law alleged the UBS Defendants breached their fiduciary duties to the Foundation in their management of Foundation investment funds. After UBS was denied dismissal or a stay under the Colorado River abstention doctrine it moved to compel arbitration. That motion was denied. District court found plaintiff presented sufficient evidence to place the validity of the arbitration agreement at issue in trial. The Second Circuit affirmed the district court’s denial of the UBS Defendants’ motion to compel arbitration on the ground of waiver. By their actions, including by affirmatively seeking a resolution of their dispute in the district court, the UBS Defendants waived their right to compel arbitration. Applying the Supreme Court’s 2022 decision in *Morgan v. Sundance Inc.* the Second Circuit concluded that the UBS Defendants knowingly relinquished the right to arbitrate by acting inconsistently with that right.

U.S. - SDNY | CIVIL PROCEDURE

Deceptive Practices Class Suit Dismissed For Lack of Standing

Plaintiffs’ class suit against KOS Inc. under General Business Law §§349 and 350—and for breach of express warranty—alleged that KOS markets and sells its plant protein powder products (Products) as “nature-powered” “organic” “wellness” and “superfood” products when in actuality the Products contain dangerously high levels of PFAS chemicals. Plaintiffs bought the Products in reliance on defendant’s marketing and advertising. Granting KOS’s motion, the district court dismissed plaintiffs’ first Amended Complaint for lack of standing and did not reach the merits of plaintiffs’ claims. The court gave plaintiffs until Aug. 29, 2025, to file a Second Amended Complaint. Plaintiffs’ allegations did not assert injury under a price-premium theory. Nor did they adequately allege that they bought Products containing PFAS chemicals. They offered insufficient details concerning their alleged independent testing of the Products. They did not aver facts supporting the testing, nor mentioned any facts about what that testing entailed or the testing’s methodology or the component tested.

U.S. - WDNY | CREDITORS’ AND DEBTORS’ RIGHTS

FDCPA Violated, but Only \$500 in Statutory Damages Is Awarded

In 2021 Lowe filed a complaint alleging violation of the Fair Debt Collection Practices Act. He later sought default judgment against defendant Capital Link Management (CLM). The court granted Lowe’s motion for default judgment, but awarded him \$500 in statutory damages instead of the \$1,000 that he requested. His complaint adequately alleged CLM’s violation of the FDCPA. However, the facts of the case did not warrant an award of \$1,000 in statutory damages. CLM’s violation consisted of a single text message, and nothing indicated that the communication with Lowe’s client was intentional. The court found an award of \$500 appropriate for the damages occasioned by the invasion on Lowe’s privacy by the communication to a third party. Lowe may submit his request for attorney’s fees within 30 days of the date of the court’s decision and order.

U.S. - EDNY | PUBLIC RECORDS

‘Judicial Document’ Not Sealed; Presumption Of Public Access Not Overcome

Following resolution of the instant action, plaintiff sought to seal an otherwise public record—a prior decision in another unrelated action that was filed instantly in support of a prior motion to dismiss. The plaintiff’s instant (third) unopposed motion seeks relief identical to that previously denied. The court denied plaintiff’s motion to seal. Plaintiff did not overcome the instantly strong presumption of public access. Plaintiff failed to justify any “exceptional circumstances” to disturb the prior rulings. Consideration of the *Lugosch* factors yielded the same result. The document sought to be sealed—an exhibit for a motion to dismiss—was a “judicial document,” regardless of the dismissal motion’s subsequent withdrawal. The documents in question had been publicly accessible since Nov. 12, 2024, and were relevant when the dismissal motion was ripe for ruling. Among other things, the claimed reputational harm that would occur if the seal motion were denied was not among the “countervailing interests” weighing against public access.

U.S. - SDNY | ATTORNEY COMPENSATION

\$1 Million in Attorney’s Fees Awarded But Costs Not Backed With Receipts

In September 2024, the court granted defendant Hybrid Promotions and its codefendants summary judgment, and attorney’s fees—pursuant to the Lanham Act as prevailing parties—and costs in defending the instant decade-old action. Defendants sought an award of \$1,159,166.12 from plaintiff The Fashion Exchange (TFE). As with defendants’ motion for attorney’s fees, TFE neither opposed nor responded to their fee application. The court awarded defendants and counsel Tarter Krinsky & Drogin (TKD) \$1,099,146.45 in attorney’s fees but denied defendants’ application for costs. In 2019 and 2020 another judge determined that TKD’s rates for its attorneys were reasonable. The now-increased rates that TKD requests in its application are still reasonable and within the range of acceptable rates in commercial matters in recent cases in the Southern District. However, the court reduced the hourly rate for TKD’s paralegals to \$150. So too were the 33.4 hours expended by law students and temporary attorneys. Despite requesting over \$44,000 in costs, defendants provided no receipts substantiating the costs. Nor did they file a notice of taxation of costs with the Clerk of Court.
