APP. DIV. | CRIMINAL LAW

Judgment Reversed, Conviction Vacated; Indictment Dismissed for Lack of Probable Cause

Supreme court's Oct. 25, 2018, judgment convicted defendant, upon guilty plea, of three counts of first-degree assault and two counts of first-degree attempted robbery. Defendant was arrested based on his similarities in dress to a person shown on video surveillance of the vicinity shortly after the alleged crime occurred. The figure wore distinctive pants. However, the victim described the perpetrator as wearing a black nylon jacket. Only the pants linked defendant to the crime. Video footage of the alleged crime was "murky" and inconclusive. The distinctive pants were not apparent, and the investigating detective described the assailant's clothing as "dark." Defendant was arrested by the Department of Homeless Services at the shelter in which he lived based on video stills of the figure in pants provided by police, before any confirmatory process. Reversing judgment and vacating conviction, First Department dismissed the indictment against defendant for lack of probable cause. There were no details about the circumstances of defendant's arrest. Nor was probable cause asserted before the hearing court.

NEW YORK | PERSONAL INJURY

Court Finds Defendant Sufficiently Pleaded Cause of Action for Negligence

Plaintiff commenced an action seeking to recover damages for personal injuries sustained as a result of alleged sexual abuse by Reginald Archibald, a pediatric endocrinologist, who provided medical screenings and other medical services for young boys who attended a program called the "Clubhouse", run by defendant. Defendant moved to dismiss for failure to state a cause of action. The motion was denied. The court held the complaint stated that plaintiff was introduced to Archibald in 1978 when plaintiff first attended defendant's Clubhouse and was required by defendant to undergo a physical examination which led to his sexual abuse and injury. The complaint further explained that plaintiff complained about the sexual abuse to the counselors, staff members, and to a supervising staff member. The court held despite defendant's contentions, plaintiff sufficiently pleaded a cause of action for negligence.

QUEENS | LANDLORD TENANT LAW

Motion to Dismiss Denied; Eviction Granted For Petitioners

In a non-payment summary proceeding involving a commercial tenancy, respondent moved for summary judgment. Petitioners opposed and cross moved for judgment of possession, a warrant of eviction without a stay, and a money judgment. Petitioners' cross-motion was granted. The court held that respondent's motion was not supported by any individual with personal knowledge of the facts. Petitioners established their *prima facie* entitlement to summary judgment, respondent did not file opposition, nor had any evidence been proffered to refute petitioners' contentions. Petitioner's cross-motion was awarded a judgment in the amount of \$679,630.08.

U.S. - SDNY | CIVIL PROCEDURE

Court Explains Why Job Suit Plaintiff Cannot Proceed Under Pseudonym

Sumitomo Mitsui Banking Corp. conducted HR oversight over plaintiff's former employer Sumitomo Finance and Leasing. Plaintiff's lawsuit against both alleged unlawful termination, civil rights and RICO violations, privacy and HIPAA violations, and coercion to sign a prior settlement agreement. Contrary to statute and rules, plaintiff filed his complaint against defendants under a pseudonym. Contemporaneously he moved to proceed under a pseudonym, and to seal personally identifying information. The court denied both motions, and warned plaintiff that his pro se lawsuit would be dismissed if he did not file a complaint in his own name by Sept. 2. The balance of interests weighed strongly against anonymity, and plaintiff lacked a substantial privacy interest that outweighed the presumption of openness in judicial proceedings. Also, none of the information that plaintiff requested to seal is permitted to be redacted without leave of the court. Thus he must seek court permission to redact his name, address, telephone number, and any other "sensitive history." The court did not find good cause to issue a protective order.

NEW YORK | PERSONAL INJURY

Summary Judgment Partially Granted In Personal Injury Action

On defendant's motion for summary judgment and dismissal of both plaintiffs' complaints on the grounds that plaintiffs' alleged injuries fail to satisfy the serious injury threshold within the meaning of Insurance Law 5102 (d), the court granted that portion of the motion seeking summary judgment with respect to the serious injury categories of permanent loss of use of a body organ, member, function or system and 90/180 days and denied that portion of the motion seeking summary judgment with respect to the serious injury categories of permanent consequential limitation of use of a body organ or member and significant limitation of use of a body function or system. The Court also held that issues of fact concerning plaintiffs' three-year gap in treatment were sufficient to preclude summary judgment on this issue based upon the determination of plaintiffs' treating physician that plaintiffs reached maximum medical improvement from their respective treatments and that further treatment was likely not to make any progress to alleviate or to cure the conditions.

NEW YORK | CIVIL PROCEDURE

Order to Vacate Judgment Denied as Defendant Failed to Argue It Was Improperly Served

Defendant brought an Order to Show Cause to vacate the judgement entered against defendant in the amount of \$2,017.21. Defendant Allstate Insurance Company argued that the above stated judgment should be vacated as plaintiff, Max Way Medical PC, served the Summons and Complaint upon an incorrect or improper party. Plaintiff argued that even if defendant was the incorrect party to be served, that did not constitute a reasonable excuse as to why defendant did not timely answer the Summons and Complaint. The order was denied. The court held defendant failed to demonstrate that service was improper based on it being an improper defendant and that it was served outside of the city of New York. Defendant explicitly acknowledged receipt of the Summons and Complaint while stating that it searched its files pertaining to the claim number provided by the plaintiff in the Summons and Complaint.

SECOND CIRCUIT | CIVIL RIGHTS

Plaintiff Acted as Private Citizen, Not Court's Clerk When Cooperating in Misconduct Probe

Long previously served as the Clerk of the Town Justice Court of the Town of New Lebanon. She sued the Town and former Town Justice Byrne, alleging they fired her unlawfully because she cooperated with an investigation by the New York State Commission on Judicial Conduct into Byrne's suspected judicial misconduct, in violation of her First Amendment rights and rights under §75-b of New York's Civil Service Law. Second Circuit reversed the Northern District's dismissal of Long's claims, and remanded action for further proceedings. Long's complaint adequately alleged that when she cooperated with the Commission's probe that she acted as a private citizen and not pursuant to her work responsibilities as Court Clerk. That Long's conduct involved, in significant part, a decision not to speak, did not strip her of First Amendment protection. Civilian analogues to Long's conduct also supported the proposition that Long's conduct was not related to her job responsibilities. The complaint supported an inference that Long cooperated with the Commission's investigation out of a sense of civic duty.

U.S. - NDNY | CONTRACTUAL DISPUTES

Amended Tortious Interference Pleadings State Existence of Valid Employment Contracts

Plaintiff hospital (St. Joseph's) sued defendants for contract breach and antitrust violating the Sherman Act. Defendants counterclaimed for breach, tortious interference with contract, and for injunctive and declaratory relief. The court dismissed the tortious interference counterclaim, with leave to amend. Presently, the court denied St. Joseph's motion to dismiss the amended tortious interference counterclaim under FRCP 12(b)(6) for failure to state a claim. Defendant NAPA's tortious interference counterclaim alleged St. Joseph's improperly induced clinicians into ceasing their employment with NAPA contrary to non-compete provisions within their employment contracts. Instantly, the court found NAPA's new pleadings in connection with its amended counterclaim for tortious interference with contractual relations sufficient to plausibly allege the existence of valid employment contracts.

NEW YORK | MEDICAL MALPRACTICE

Motion to Add Party in Dental Malpractice Action Granted By Court

In an action to recover damages for dental malpractice, the plaintiffs moved for leave to file and serve a supplemental summons and amended complaint: correcting the name of the party previously identified as Midtown Manhattan Dental, P.C., to reflect that its full name is Midtown Manhattan Dental, P.C., individually and doing business as Midtown Dental Group; adding Carnegie Hill Dental Aesthetics, P.C., Individually and doing business as Midtown Dental Group, as a party defendant, and; dropping, from the action, those defendants identified as Midtown Manhattan Dental Downtown, P.C., Midtown Manhattan Dental East, P.C., and Midtown Dental Group Central Park South, P.C. The motion was granted. The court held the plaintiffs established that the new party was involved in the relevant dental treatment to the same extent as the existing, related party that did business under the same trade name.

KINGS | MEDICAL MALPRACTICE

Plaintiff's Testimony in Medical Malpractice Trial Not Hearsay, Court Rules

Plaintiff commenced an action alleging medical malpractice and injuries she sustained as a result of shoulder surgery performed by defendant in 2017. During direct examination of plaintiff at trial, two questions were posed which elicited responses objected to by defendants' counsel on hearsay grounds. Objections were made to plaintiff's repeating what doctors told her about her hand condition after she experienced symptoms following the complained of shoulder surgery. The court overruled the objections and allowed the testimony. The court reasoned that hearsay is an out of court statement offered to prove the truth of the matter asserted in the statements. The testimony was not offered for the truth of the matters asserted, but rather to explain the context for plaintiff's chosen treatment path following the 2017 shoulder surgery.

SECOND CIRCUIT | CRIMINAL LAW

Evidence Supports Conviction for Securities, Other Frauds; No Entitlement to New Trial

A trial jury convicted Hild of securities, wire, and bank fraud as well as conspiracy. He was sentenced to 44 months in prison. The trial evidence established that Hild and his co-conspirators at Live Well Financial Inc., where Hild was CEO, engaged in a multi-year scheme to fraudulently inflate the value of a portfolio of bonds used as collateral to secure cash loans. Affirming district court's judgment of conviction, the Second Circuit rejected Hild's argument that he was entitled to a new trial because *Ciminelli v. U.S.*—decided after his trial—invalidated one of the theories of fraud on which the jury was instructed. Second Circuit concluded that sufficient evidence supported Hild's conviction and that he was not otherwise entitled to a new trial. Among other things, on various occasions Hild directed Live Well employees to take steps to avoid discovery of the fraud scheme.
