Wrongful Confinement Claim Remains Dismissed Despite Prison Reform Amendments

Claimant Pedro Diaz moved to renew dismissal of his wrongful confinement claim against the State, arguing prison reform amendments effective Dec. 19, 2025, and enacted in chapter amendments in 2026, removed Court of Claims Act §10 deadlines and applied because his appeal was pending and should fall within the change. The claim had been dismissed after the court found it accrued on Oct. 23, 2022, when Diaz was released from solitary confinement, requiring service of a notice of intention or filing by Jan. 21, 2023; Diaz served his notice on Feb. 12, 2024, warranting the court's decision. The State opposed, arguing the amendments applied prospectively only to custody periods ending on or after the effective date. The court agreed and denied renewal. It held Diaz failed under CPLR 2221(e) to show a change in law that would alter the prior jurisdictional dismissal or finding anything similar to what was requested. The court reasoned the amendments retained the 90-day limitations period, created only a two-year post-release window for qualifying claims, and did not revive claims already time-barred before Dec. 19, 2025 which then required dismissal of the complaint.

Paving Contractor Dismissed From Scooter Crash Suit Over Roadway Plates

Plaintiff Roberto C. Salazar sued Tri-Messine Construction Company Inc. and Brooklyn Union Gas Company after his electric scooter struck stacked steel roadway plates near Wayne and Alaska Streets in Staten Island on May 23, 2023, causing him to fall and sustain injuries. Salazar moved for partial summary judgment on liability, while Tri-Messine sought summary judgment dismissing the complaint and for cross-claims. The court granted Tri-Messine's motion and denied Salazar's motion. It held Tri-Messine owed no duty because the evidence showed National Grid owned and placed the plates. Tri-Messine did not control them and Tri-Messine first performed paving restoration at that location on May 24, 2023, after the accident. The court rejected plaintiff's and National Grid's arguments as speculative, finding nearby work and an equivocal deposition statement did not create a triable issue. However, Salazar's liability motion against National Grid was denied because factual issues remained over whether the plates were open and obvious, inherently dangerous or a trap for the unwary.

Trademark Owner Wins TRO Against Online Sellers of Alleged Counterfeit Products

Sport Dimension Inc. won a temporary restraining order (TRO) against 12 online sellers accused of marketing allegedly counterfeit children's flotation devices using its registered PADDLE PALS trademark after the court found the company showed a likelihood of success on its Lanham Act infringement and false designation of origin claims. The company presented evidence that the defendants, who sold products through Walmart and Temu storefronts, allegedly used identical or nearly identical "Paddle Pals" or "Paddle Pal" branding on competing flotation devices, creating a strong likelihood of consumer confusion. The order also freezes defendants assets and permits expedited discovery to identify the sellers' true identities and locate assets potentially subject to recovery. However, the court denied, without prejudice, the company's request to serve the foreign-based defendants by email, finding it had not exercised sufficient diligence to establish that the sellers' physical addresses were unknown and therefore had not shown that service outside the Hague Service Convention was appropriate.

U.S. - SDNY | INSURANCE LITIGATION

No Strong Inference of Broker's Fraudulent Intent, But Insurance Suit Proceeds

An insured may proceed with negligence, breach of fiduciary duty and malpractice claims against an insurance broker over alleged misrepresentations about health insurance coverage, but his fraud claim was dismissed for failure to satisfy the heightened pleading requirements of Rule 9(b). Plaintiff alleged the broker persuaded him to switch from an existing health plan by assuring him a new policy would cover expensive medications and physical therapy and that he could return to his prior plan if dissatisfied. After the new plan allegedly denied coverage, plaintiff claimed he incurred thousands of dollars in monthly out-of-pocket costs and was unable to regain his former coverage. The court rejected defendants' jurisdictional challenge, finding the allegations of ongoing-uncovered medical expenses sufficient to satisfy the \$75,000 amount-in-controversy requirement for diversity jurisdiction. However, the fraud claim failed because, although plaintiff adequately identified the alleged misrepresentations, the speaker, and the resulting reliance and damages, it did not allege facts giving rise to a strong inference the broker knew the statements were false when made.

NEW YORK | CRIMINAL LAW

Attempted Murder Defendant Wins Suppression of Firearm Found in Backpack

Defendant Justin Millar, charged with attempted murder, firearm offenses and related crimes after allegedly firing at an unknown person near Church and Utica Avenues in Brooklyn and striking a bystander in the leg, moved to suppress a gun recovered from his backpack, his clothing and statements. After a combined Mapp/Huntley/Dunaway hearing, the court granted suppression in part. It found Officer Jeffrey Deleon's testimony about receiving and radioing a detailed suspect description not credible, relying instead on radio runs and body-camera footage showing only a vague description of a Black male with an afro. The court held officers had a founded suspicion permitting inquiry, and Millar's flight after being told he matched a firearm description elevated the encounter to reasonable suspicion justifying pursuit, detention and an external frisk. However, the People failed to justify Deleon's later intrusive search inside the backpack after another officer's frisk produced no result. The firearm, clothing and precinct statements were suppressed; defendant's statements remained admissible.

Lost Profits Do Not Justify Injunction In Competing Bars Dispute

Plaintiff Mikaila Fargnoli and defendants Richard David and Kristopher Kasmarcik jointly owned RMK Association LLC and Confluence Properties II LLC, which opened Stadium 138 in Binghamton. After David and Kasmarcik formed K&D Hospitality LLC to operate nearby Blazin' Saddles, Fargnoli sued, alleging the competing bar violated non-compete provisions, harmed Stadium 138 and warranted injunctive closure. She also sought to vacate resolutions removing her from RMK and Confluence. RMK, Confluence, David, Kasmarcik and K&D separately sought injunctions barring Fargnoli from interfering with Stadium 138's operations. The court denied all preliminary injunction requests. It held Fargnoli failed to show irreparable harm, likelihood of success or equities favoring closure; because lost profits were compensable by money damages, factual disputes remained over competition and causation and closure would affect nonparties. The court similarly found RMK, Confluence and defendants alleged economic injuries remediable by money damages. Fargnoli's removal challenge was also denied because her authority and standing to sue for the LLCs remained unresolved on the record.

Settlement Agreement, Statute of Limitations, Prior Judgment Bar Tom Brady Photo Claims

Vox Media LLC defeated a pro se plaintiff's copyright infringement and breach of contract suit arising from the alleged unauthorized use of a 2016 photograph depicting Tom Brady in the Hamptons with the Boston Celtics after the court dismissed the amended complaint. The plaintiff alleged that Vox subsidiary SB Nation and employee Bobby Manning infringed his copyright by publishing the image and further claimed Vox breached a settlement agreement resolving an earlier lawsuit by continuing to use the photograph without authorization. The court dismissed the breach of contract claim with prejudice, concluding that the plaintiff failed to identify any provision of the settlement agreement requiring Vox to remove the photograph or otherwise establishing a contractual obligation that had been violated. The court also agreed with Vox that the copyright infringement claim was untimely under the applicable statute of limitations and barred by res judicata because it arose from the same underlying dispute resolved in the prior litigation or could have been asserted there. As a result, the court found the amended complaint failed to state any viable claim for relief.

U.S. - EDNY | INSURANCE LITIGATION

Policy's 2-Year Suit Limitation, Service Delay Do Not Bar Fire Insurance Claims

Homeowners may pursue breach of contract claims against Liberty Insurance Corporation over alleged underpayment of two fire losses after the court ruled that neither the policy's two-year suit limitation nor a 13-day delay in service required dismissal. The plaintiffs alleged Liberty failed to fully indemnify them for damage caused by separate fires at their New York residence despite coverage under their homeowners policy. The court held the action was timely because the policy required only that an action be "started" within two years of the loss, and under New York law an action is commenced by filing a summons with notice, which the plaintiffs did before the deadline. The court also excused the late service of process, finding an extension was warranted because the delay resulted from ongoing settlement discussions, Liberty had notice of the claims, and it suffered no meaningful prejudice. However, the court dismissed the plaintiffs' claim for consequential damages, concluding the complaint alleged only underpayment of covered losses and failed to plead separate foreseeable damages beyond the policy benefits recoverable for breach of contract.

Limited Snow Removal Contract Did Not Owe Duty to Injured Pedestrian, Dismissed From Case

Plaintiff Viktoriya Vorontsova sued Deck 86th Street-2630 LLC, James Avellini and Darp Tow Inc. after slipping on Dec. 19, 2020, outside a Dunkin Donuts-Baskin Robbins in Brooklyn following a snowstorm. Darp Tow, which had plowed the premises on Dec. 17 under an oral, call-by-call agreement, moved for summary judgment, arguing it owed plaintiff no duty and was not asked to return or salt the area. The court granted the motion. It held Darp Tow was a limited snow-removal contractor and plaintiff failed to establish any Espinal exception imposing liability to a third party. The court reasoned Darp Tow did not launch an instrument of harm or increase the risk, because evidence showed snow melted naturally and any refreezing was speculative. Plaintiff had no interaction with or reliance on Darp Tow, and the contractor did not entirely displace Deck's duty to maintain the premises or the surrounding areas.. Plaintiff's contrary claims about inadequate walkway cleaning and piled, unsalted snow on a sloped driveway were deemed unsupported by the record established. The complaint was dismissed in its entirety.

Red Hook Local Laws Annulled Over SEQRA Review Failures

Petitioner Red Hook Boat Club Inc., which operates a private Hudson River boat club in the Town of Red Hook, brought its third Article 78 proceeding challenging town actions allegedly advancing condemnation of its property for a public park. After a prior ruling found SEQRA violations in Local Law No. 1 of 2025, the town enacted Local Laws B and C of 2025 and issued a negative declaration, finding no significant adverse environmental impacts. The court granted the petition. It held the town's negative declaration and the enactments, later Local Laws 3 and 4 of 2025, had to be annulled because the town failed to demonstrate strict compliance with SEQRA. The court reasoned that, although it prepared a lengthy narrative, the record showed consideration only of traffic and historical/archeological impacts tied to public park use, omitted the full environmental assessment form and did not establish review of other relevant environmental concerns under governing SEQRA regulations. Accordingly, the negative declaration was arbitrary and capricious, and both local laws were set aside.

U.S. - SDNY | EMPLOYMENT LITIGATION

Single-Employer, Economic Reality Allegations Sustain FLSA Wage Suit

A former Jackpot Deals employee may proceed with claims that three affiliated discount stores and their owner violated federal and New York wage and hour laws after the court found the complaint plausibly alleged both a single integrated employer and individual liability. Plaintiff alleged he worked at multiple store locations under the direction of the owner, who assigned his work, set his schedule and compensation, paid him in cash regardless of hours worked, and ultimately terminated his employment. Rejecting defendants' motion to dismiss, the court declined to consider tax documents submitted in support of the motion because they were incomplete, unauthenticated and outside the pleadings, making them inappropriate for judicial notice at the dismissal stage. The court found plaintiff sufficiently alleged common ownership, shared operations, employee transfers and centralized control to support application of the single-employer doctrine. It also held the allegations satisfied the Fair Labor Standards Act's (FLSA) economic reality test for individual liability by describing the owner's direct control over hiring, work assignments, compensation and termination.

In Suffolk County, the “clerk of the court” is the Suffolk County Clerk for the purposes of CPLR 304 and 306-b (see, County Law Sec.525 sub. 1).

The clerks at the courthouses cannot accept papers filed for the purposes of commencing an action or special proceeding. Papers improperly filed with the clerks at the courthouses will not be transferred to the County Clerk for filing and will, instead, be returned to the litigant.

Be advised, papers improperly filed with the clerks at the courthouse may not be deemed a “filing” which tolls the running of the applicable statute of limitations.

Please take notice that no request for Judicial Intervention or its copies will be accepted by this court unless stamped on its face is the County Clerk’s certification that the fee for its filing has been paid. This office will not transmit fees for Requests for Judicial Intervention or Index Numbers to the County Clerk. In instances where a fee for a Note of Issue is required present practices will continue.
