NEW YORK | CIVIL PROCEDURE

NYPH’s Motion to Disqualify Plaintiff’s Husband as Counsel Denied

The court denied New York Presbyterian Hospital’s motion to disqualify attorney Kenneth F. McCallion and his firm from representing plaintiff Susan W. McCallion in a medical malpractice action. The plaintiff alleges negligent IV placement and management during a hospital admission caused infiltration and a later MRSA infection. After plaintiff’s original counsel was replaced, her husband, McCallion, appeared as counsel. The hospital argued he was a necessary witness because he was present during portions of plaintiff’s treatment and possessed relevant knowledge concerning her condition, complaints, discharge and damages. The court held that disqualification was unwarranted under Rule 3.7 of the Rules of Professional Conduct because the defendant failed to show McCallion’s testimony was strictly necessary. The court reasoned that his involvement was limited, his knowledge was largely speculative or cumulative, and the same information could be obtained from medical records, treating physicians, and the plaintiff herself. It further found disqualification would impose substantial hardship and disrupt judicial economy. The motion was denied without prejudice.

NEW YORK | FAMILY LAW

Ex-Husband Wins Clarification of NYC Pension Rights

In a long-running matrimonial action, the plaintiff sought to modify a 2022 equitable distribution order involving the defendant’s public pensions. The parties agreed that the order mistakenly referred to the defendant’s New York State pension when the pension litigated at trial was actually her New York City Employees’ Retirement System pension earned during service with a district attorney’s office. The plaintiff also sought 50% of the marital portion of the defendant’s separate New York State and Local Retirement System pension and moved to strike the defendant’s later filings. The court held that correction of the pension designation was warranted but denied the request for a share of the state pension and denied the motion to strike. The court reasoned that CPLR 5019(a) permits correction of clerical errors so an order conforms to the original adjudication, and the record showed only the city pension was litigated and valued. Awarding an interest in the state pension would constitute an impermissible substantive modification. The court corrected the order and allowed further briefing.

NEW YORK | INSURANCE LITIGATION

Medical Provider’s No-Fault Claim Fails Against Incorrect Insurance Company

Plaintiff Healthcare Provider sued Allstate Insurance Company, alleging it was responsible for payment under the applicable insurance policy. Allstate moved to dismiss for lack of jurisdiction or, alternatively, for summary judgment, contending it did not issue the policy covering the claimant and that the policy was issued instead by Allstate New Jersey Property and Casualty Insurance Company, a separate entity. The court held that Allstate Insurance Company was entitled to summary judgment dismissing the complaint. The court found that defendant established a prima facie case through affidavits and policy records showing it had not issued a policy to the assignor, while the New Jersey affiliate had issued the relevant coverage. Plaintiff failed to raise a triable issue of fact, relying only on conclusory assertions regarding the relationship between the companies. The court also determined that questions concerning claim submissions or denials were immaterial because the dispositive issue was whether the defendant was the proper insurer. The court granted summary judgment and dismissed the complaint in its entirety.

NEW YORK | TRUSTS AND ESTATES

Trusteeship Bid Rejected Where Petitioner Was Not Beneficiary Under Decedent’s Will

Petitioner Dr. Pankaj K. Phadnis sought letters of trusteeship and related relief for an alleged “Indian Public Charitable Trust” that he claimed was created under the decedent’s will. He asserted that he was a creditor of the estate and sought appointment as trustee to conduct discovery and recover assets allegedly misappropriated in India by respondent Nusli Wadia, who had served as administrator of the decedent’s Indian estate. Respondent cross-moved to dismiss, arguing lack of standing, forum non conveniens, and jurisdictional defects. The court held that dismissal was warranted. The court reasoned that India was the more appropriate forum because the purported trust assets, alleged misconduct, and related litigation were all centered there. It further found that petitioner lacked standing because he was neither a beneficiary under the will nor a person interested within the meaning of the SCPA. His claimed interest in charitable causes similar to those identified in the will was legally insufficient. Accordingly, the court granted respondent’s cross-motion to dismiss.

KINGS | PERSONAL INJURY

Directed Verdict Dismisses Cyclist’s Negligence Suit After Plaintiff Declines to Testify

In a personal injury action arising from an alleged 2019 bicycle accident, plaintiff Jessica Best claimed a tractor trailer driven by Michael Moynahan crossed into a Brooklyn bike lane and struck her, causing injuries. Her husband, Kevin Blackburn, asserted a loss of consortium claim. At trial, both plaintiffs appeared pro se. Blackburn testified he did not witness the collision, while Moynahan testified he never struck Best. Best herself did not testify and had no recollection of the incident. The court held defendants were entitled to a directed verdict under CPLR 4401 because plaintiffs failed to establish a prima facie case. The court reasoned that no evidence showed Moynahan negligently caused the accident. Blackburn’s observation of a truck tire in the bike lane did not prove contact with Best or causation. Any inference that the truck struck her would be speculative, especially given alternative explanations for her fall. Construing the evidence most favorably to plaintiffs, the court found no rational jury could find negligence or proximate cause. The complaint was dismissed.

NASSAU | TRUSTS AND ESTATES

Trust and Deed Defeat Claim That Decedent Died Intestate

In a surrogate’s court proceeding, Richard Colgan sought to prevent the sale of real property formerly owned by his mother, Helen Colgan, claiming she died intestate and that he held a one-half ownership interest with his sister, Jeanine Colgan. Richard filed a complaint and a notice of pendency against the Mineola property. Jeanine moved to dismiss, producing a trust, deed, and will executed in June 2025 showing that the property had been transferred to a trust, that Jeanine was sole beneficiary and successor trustee, and that Richard had been expressly disinherited. The court held that dismissal was warranted under CPLR 3211(a)(1) and (7) and that the lis pendens must be canceled. The court reasoned that documentary evidence conclusively refuted Richard’s central allegation that the decedent died without a will and retained ownership of the property. Title rested with the trust, and even if intestacy ultimately applied, a fiduciary could still sell the property absent unanimous beneficiary consent. Accordingly, the complaint was dismissed and the notice of pendency was discharged.

SECOND CIRCUIT | CONSTITUTIONAL LAW

Panel Upholds \$4.8M Nassau County Fine; Excessive Fines Clause Protects Business Entities

The Second Circuit upheld a \$4.8 million civil penalty Nassau County imposed on the owner of Roosevelt Field Mall for failing for two years to submit financial information required under the county’s Annual Statement of Income and Expenses Law. The panel held that the Eighth Amendment’s Excessive Fines Clause protects business entities, including corporations and trusts. The court nevertheless determined that the fine was not grossly disproportionate because the Trust knowingly failed to comply with a law aimed at improving commercial property assessments, the law specifically targeted income-producing properties and the penalty represented only a fraction of the property’s value. The court also rejected the Trust’s procedural and substantive due process claims, concluding that an Article 78 proceeding provided an adequate means to challenge the fine and improving assessment accuracy supplied a rational basis for the law. The court also affirmed the denial of sanctions against the county, holding that the alleged misrepresentations involved immaterial factual disputes.

U.S. - SDNY | INSURANCE LITIGATION

Insurers Have No Duty to Defend Ghost Gun Seller Over Intentional Conduct

Insurers Granite State Insurance Co. and Berkshire Hathaway Specialty Insurance Co. have no duty to defend or indemnify KM Tactical in lawsuits alleging it marketed and sold firearm kits used to assemble untraceable “ghost guns.” Applying Missouri law, the court held the suits did not allege an “occurrence,” defined by the policies as an accident, because KM Tactical allegedly intentionally marketed and repeatedly sold unfinished frames and receivers while failing to control its sales, including to customers seeking to evade gun control laws. The resulting financial harm to NY from increased gun violence, law enforcement costs and other expenditures was reasonably foreseeable and therefore did not constitute an accident. KM Tactical’s negligence arguments and alleged reliance on ATF guidance did not alter that conclusion as they did not negate the allegations of intentional conduct or make the resulting injuries unforeseeable. Since no covered occurrence was alleged, the court did not reach whether the suits sought damages “because of” bodily injury or property damage.

U.S. - EDNY | CIVIL RIGHTS

RICO and ADA Claims Dismissed for Failure to Plead Fraud or Denial of Court Access

Plaintiff’s RICO and ADA claims arising from alleged housing conditions and purported manipulation of documents in state court proceedings were dismissed. Plaintiff argued private parties, attorneys and court personnel formed an enterprise that engaged in wire fraud and extortion by submitting, suppressing or manipulating court documents. However, he failed to identify the allegedly fraudulent communications, speakers, timing or substance with particularity required for fraud claims. His extortion theory also failed as he did not allege that defendants obtained any of his property, and litigation activity, including the pursuit of allegedly meritless litigation, did not constitute extortion. Further, his ADA claim failed because he did not plausibly allege his disability prevented him from accessing or participating in state court proceedings. Finally, his proposed accommodation was not reasonable, as requiring in-person clerk review of electronically filed documents before they appeared on the public docket would fundamentally alter normal filing procedures and interfere with other litigants’ access to the courts.

U.S. - SDNY | SECURITIES LITIGATION

RICO Claims Survive on Pump-and-Dump Allegations; Memecoins Lack Common Enterprise

Pump.fun operator Baton Corp. and its founders must face RICO claims alleging they operated a “pump and dump” scheme that favored insiders at the expense of ordinary memecoin traders, while related claims against the Solana defendants were dismissed. Plaintiffs alleged insiders obtained selected tokens before public trading, coordinated promotions to drive up prices and then sold into retail demand, causing traders billions of dollars in losses. The court found two plaintiffs adequately pleaded substantive RICO and conspiracy claims against Baton and its founders but dismissed the Securities Act claims alleging that 20 Pump.fun tokens were unregistered securities. Plaintiffs had standing to pursue those claims only for FRED and GRIFFAIN, the two tokens they purchased, and those claims failed under *Howey* because the complaint did not plausibly allege a common enterprise. Although purchasers’ assets entered token-specific bonding curves, their fortunes were not tied to the success of an underlying venture; individual traders could profit while others lost depending on when they bought and sold.

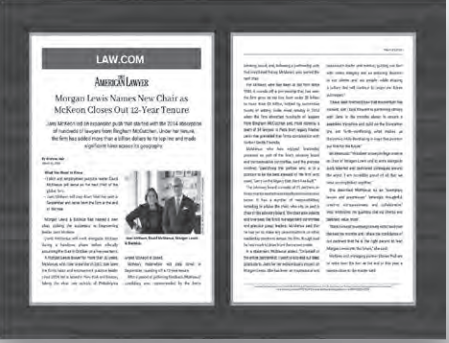
