NEW YORK | PERSONAL INJURY

Motion to Dismiss Claim for Sexual Abuse Granted By Court

Claimant Paul H. commenced a Supreme Court action against various governmental and non-governmental entities. Claimant alleged that the various defendants were negligent because he had been sexually abused while in their care and custody. According to claimant, he commenced the action against them while under the mistaken belief that he was in those parties' custody at the time of the alleged incidents in the 1970s. Defendant moved to dismiss. The motion was granted. The court held defendant demonstrated that claimant commenced an action well outside of the Child Victims Act revival window. No court has found that the revival window closed on any date after November 12, 2021.

NEW YORK | CIVIL PROCEDURE

Motion to Compel Acceptance of Answer Granted By Court

Plaintiff's action was commenced on March 11, 2025. Service of process was made by the NYC Sheriff's office on defendants on April 30, 2025. Defendant filed its answer on May 1, 2025. In its Answer, defendant asserted an affirmative defense of lack of personal jurisdiction. Plaintiff did not submit any opposition to the motion. Defendant moved to compel acceptance of its answer. The motion was granted. The court held the delay for the answer was administrative and de minimis, not willful. The answer set forth a meritorious defense and was served in good faith. Plaintiff had not demonstrated any prejudice arising from the short delay in court docketing.

KINGS | CRIMINAL LAW

Court Denies Reducing Defendant's Sentence Under Domestic Violence Survivor's Act

Defendant, in a criminal action, moved to be sentenced under the Domestic Violence Survivor's Act. The Act allows courts to impose reduced alternative sentences in certain cases involving domestic violence. The motion was denied. The court held whatever abuse defendant suffered could not have been a significant contributing factor to his criminal behavior, because according to defendant, he was not guilty. In both his pre-sentence interview with probation, and in papers attached as exhibits to his own motion, the defendant declared his innocence and blames the crime on his former paramour.

KINGS | CIVIL PROCEDURE

Default Judgment Denied for Lack Of Personal Jurisdiction

Plaintiff sought an order pursuant to CPLR 3215 to enter a default judgment against two defendants Dame Mbaye and Mary Malek for rent arrears, lost revenue, and repair costs. Defendant Dame Mbaye, proceeding pro se, sought an order pursuant to CPLR 3211 (a) (8) dismissing the complaint for lack of personal jurisdiction. The court granted the defendant Mbaye's motion, finding that because of an active order of protection filed by Malek against Mbaye, Malek was not a person of suitable age and discretion to receive service on Mbaye's behalf. Consequently, the plaintiff's motion for default judgment as against the defendant Mbaye was denied.

NASSAU | FAMILY LAW

Court Orders Sole Custody Of Child to Mother

J. T. (Father) and R. S. (Mother) each filed a petition seeking to modify an order of custody and parenting time of the child of the proceedings is J. J. T. The ordered that the Mother have sole custody of the child. The court found that the father had not only failed to encourage and foster a relationship between the mother and child but actively alienated the child from the mother. The court held this demonstrated a flawed understanding of being a custodial parent and warranted extreme action. The court could not allow the father to be alone with the child as he had completely convinced the child that the mother was bad when there was no evidence of anything negative about the mother.

WESTCHESTER | LABOR LAW

Court Grants and Denies Plaintiff's And Defendants' Motions in Labor Law Action

Plaintiff was injured at a work site when he fell from an aluminum extension ladder. Plaintiff sued the owner, owner's agent and the general contractor asserting multiple violations of the Labor Law. Both parties moved for summary judgment. Plaintiff's motion for summary judgment was granted on his Labor Law § 240 (1) claim and so much of his Labor Law § 241 (6) claim as was premised on Industrial Code § 23-1.21 (b) (4) (ii) since plaintiff made a prima facie showing warranting relief. Defendants/third-party plaintiffs' motion for summary judgment under Labor Law § 241 (6) was granted in part as to the remaining sections of the Industrial Code asserted by plaintiff, and denied as to so much of plaintiff's Labor Law § 241 (6) claim as was premised on Industrial Code § 23-1.21 (b) (4) (ii). The Court also denied defendants' motion for summary judgment under Labor Law §§ 240 (1) and 200.

SECOND CIRCUIT | CRIMINAL LAW

Convictions Upheld; Restitution Order Vacated; \$25M Payment to Tracks Exceeded Authority

As part of two different conspiracies licensed veterinarian Fishman developed undetectable performance enhancing drugs that trainers later administered to their race horses. He and salesperson Gianelli were convicted for participating in a conspiracy to make and distribute misbranded or adulterated drugs with intent to defraud or mislead in violation of 22 USC §§331 and 333(a)(2). Both appealed. Affirming both convictions, Second Circuit vacated Fishman's restitution and forfeiture orders. It concluded that §333(a)(2) does not limit the requisite intent to defraud to any particular categories of victims. Instead the essential requirement is that the intent to defraud relate to §331. The Circuit also determined that district court exceeded its authority when it ordered Fishman to pay \$25 million in restitution to racetracks. Nor did Congress intend §334 to operate as a civil forfeiture statute subject to enforcement in a criminal proceeding and 21 USC §853, the substitute property forfeiture provision.

U.S. - SDNY | CIVIL RIGHTS

State Inmate May Amend Amended Complaint To Add First Amendment Retaliation Claim

In February 2020, while an inmate at Bedford Hills Correctional Facility (BHCF), Baker sought medical treatment of a stomach-area rash at the Bedford Hills Regional Medical Unit where nurse Powell gave her purportedly unwanted sexual attention and kissed her. Baker made a Prison Rape Elimination Act complaint about her interactions with Powell, which BHCF superintendent Lamanna allegedly ignored. Powell later allegedly threatened and raped Baker. Baker's action under 42 USC §1983 alleged constitutional rights violations arising from sexual assaults endured while a BHCF inmate. The court allowed Baker to amend her Amended Complaint (AC) to add a First Amendment retaliation claim against Powell but otherwise denied her motion as to all other proposed amendments. Former BHCF officials Velez and Nunez could not be added as defendants as they lacked a "unity of interest" with each other or the Complaint's other named defendants. There was no 42 USC §1983 vicarious liability, and Baker could not use FRCP 15(c)(1) (A) to bring Velez and Nunez into the instant litigation.

State Inmate Granted Appointed Counsel For 42 USC §1983 Rights Lawsuit

Plaintiff state inmate Moorer asserted a claim under 42 USC §1983 that defendant McCann violated his constitutional right to equal protection by applying DOCCS Directive 4914—relating to grooming standards—in a racially discriminatory manner. On Feb. 24, 2025, the undersigned granted plaintiff's motion to depose four state inmates. She later granted McCann's motion to depose two of the inmates telephonically by May 10, 2025. McCann did not respond to Moorer's May 19 motion for appointment of counsel nor filed a dispositive motion following the close of fact discovery. Presently, balancing the five factors expressed in *Hendricks v. Coughlin*, the undersigned magistrate judge granted Moorer's motion for appointment of pro bono counsel. Plaintiff's claim was likely to be of substance, and he showed inability to investigate facts critical to his case. Making a full scope appointment pursuant to Local Rule Of Civil Procedure 83.8(e)(1), appointed counsel shall represent plaintiff Moorer until final judgment is entered or issues designated by the court have been resolved.

U.S. - NDNY | TAX

Tax Lawsuit Untimely; Sovereign Immunity Renders U.S. Immune From Lawsuit

In January 2019 Johnston and Bishop split custody of their minor child L.N., who has lived exclusively with Johnston since Dec. 16, 2019. Johnston's tax return for 2019 claimed a \$3526 earned income tax credit; a \$1400 additional child tax credit; and a \$1551 income tax withholding. Johnston never properly contested the audit under which, on May 31, 2021, the IRS reduced her withholding by \$864, disallowed her tax credits, changed her filing status to single, and issued a \$640.91 tax refund. Johnston's instant July 14, 2025, complaint argued her entitlement to the additional child and earned income tax credits. Instantly the undersigned magistrate judge recommended dismissal of Johnston's complaint, without prejudice and with leave to amend, for lack of subject matter jurisdiction. Johnston's tax lawsuit was untimely, and its sovereign immunity rendered the United States immune from suit. Johnston's failure to file an administrative lawsuit within the statute of limitations articulated in *Houghmaster v. U.S.* was fatal to her claim.

U.S. - EDNY | INSURANCE LITIGATION

Lift's Maker Granted Judgment on Claim For Breach of 'Insurance Provision'

Mattheos was injured when the aerial work platform of the boom lift he was working on collapsed suddenly. He sued the lift's maker JLG Indus. Inc. and RLM Indus. Inc. which made and sold the "jib links" that support the lift's platform. Asserting negligence, Mattheos claimed defendants breached warranties about the quality of the jib links, whose defects caused his injuries. In turn, JLG asserted cross-claims against RLM for contribution, indemnification, and contract breach. Only partly granting summary judgment, the court granted JLG judgment on its cross-claims for breach of the "Insurance Provision," and found that RLM must defend JLG from and against any and all "Losses" that JLG sustained and will sustain in the instant litigation. Despite promising to procure general commercial liability coverage, naming JLG as an additional insured, with coverage equal to or greater than \$1 million primary and \$4 million excess, RLM obtained a primary general commercial liability policy with a limit of \$1 million per occurrence and a commercial liability umbrella policy with a limit of \$2 million per occurrence.
