DECISIONS OF INTEREST

NEW YORK | PERSONAL INJURY

Defamation Action Dismissed; Article Constituted Communication in Public

Defendant published an article that concerned a recent Consent Order Cross River Bank entered into with the FDIC. Plaintiff commenced a defamation action, alleging that the article inaccurately suggested that the Bank's financial future was imperiled, when the order was actually limited to certain violations of fair lending laws. The court granted defendant's motion to dismiss as the article constituted a communication in a public forum and concerning a matter of public interest and Cross River Bank could not identify a substantial basis for commencing the action. The court found that the many of the alleged defamatory statements were simply reports of the Consent Order protected by Civil Rights Law Section 74, the article as a whole was substantially true, and many of the individualized statements were pure opinion and thus immunized from liability.

NASSAU | FAMILY LAW

Court Grants Split of Parental Custody And of Marital Funds

Plaintiff and defendant were formerly married. Plaintiff brought issues before the court concerning custody and parenting time, child support, spousal support, equitable distribution, including husband's separate property claims and counsel and expert fees. The court held where parents have demonstrated a clear inability to co-parent, it was in the court favor to award a division of legal custody in a manner intended to consider the strengths of each parent. In addition, the wife was entitled to one-half the sums transferred from a bank account held jointly by the husband and his sister as said account contained commingled marital funds.

U.S. - SDNY | IMMIGRATION LAW

Alien Enemies Act Was Not Validly Invoked By the Presidential Proclamation

Petitioners were initially detained in the Orange County Jail, located in the Southern District of New York. In March 2025, they were transferred to a U.S. Immigration and Customs Enforcement (ICE) detention facility in Texas, to be deported to El Salvador, but were pulled off an airplane after a writ of habeas corpus on behalf of themselves and a similarly situated class and moved for a TRO against removal. The instant court granted petitioners' motion for a preliminary injunction against removal and granted petitioners' motion for class certification. The court held that the Presidential Proclamation, in mandating removal without due process, contradicts the Alien Enemies Act (AEA). The court added that since respondents have not demonstrated the existence of a "war," "invasion" or "predatory incursion," the AEA was not validly invoked by the Presidential Proclamation.

U.S. - SDNY | IMMIGRATION LAW

Plaintiffs Do Not Have Third-Party Standing To Assert Claims on Asylum Refugees' Behalf

This matter involved non-white minorities (asylum refugees) who are seeking asylum in the U.S. after leaving Latin American countries and entering the country through Texas and Florida. In response to this influx of asylum refugees into its borders, Texas began busing groups of asylum refugees to NYC and other large cities. Following the establishment of a humanitarian program, each of the counties enacted Emergency Orders prohibiting the public accommodation and transportation of asylum refugees within the counties' territorial limits. Plaintiffs moved for preliminary injunction seeking to enjoin the enforcement and utilization of certain emergency orders issued by the defendant counties and the use of local municipal laws by defendants to harass, punish, and prevent plaintiffs from providing public accommodation, transportation, and other resources to certain refugees seeking asylum in the U.S. The court denied plaintiffs' application for preliminary injunction and, among other things, dismissed, with prejudice, all claims asserted on behalf of the asylum refugees on the basis that plaintiffs lack third-party standing.

Palisades Estates EOM LLC v. County of Rockland, 23-cv-4215 (May 5)

NEW YORK | LANDLORD TENANT LAW

Court Grants Discovery for Respondent Challenging De-Regulation

Petitioner commenced an eviction proceeding seeking to retake possession of the premises based upon substantial violation of respondent's rent-stabilized lease. Petitioner did so while maintaining another holdover proceeding commenced September 2023 in which petitioner claimed the premises was exempt from rent-stabilization. Petitioner then moved in June 2024 to amend its petition in the current proceeding to reflect exempt status, which was granted. As a result, respondent filed an amended answer challenging the alleged exempt status. Respondent argued leave to conduct discovery should be granted where there was an ample need. The motion was granted. The court held petitioner had the burden of proving proper deregulation when it's challenged; the information sought by respondent would be necessary to establish proper deregulation at trial.

SUFFOLK | CONSUMER PROTECTION

Dismissal Granted; Consumers Could Not Be Misled By Wrong Label

Plaintiff sued Beaumont Products alleging that the company's Sealer & Finish floor product was deceptively labeled to suggest a 32-ounce bottle would cover 1,000 square feet. The complaint, filed by attorney Spencer Sheehan—known for similar lawsuits—, was not verified by the plaintiff. In lieu of answering, the defendant moved to dismiss asserting that the label was not materially misleading, and that plaintiff failed to plead any actual injury. Dismissal was granted. The court found that a reasonable consumer would not likely be misled under the circumstances, as the product's label accurately stated the quantity and there was no evidence contradicting its stated coverage. Furthermore, plaintiff did not allege that the product cost more than comparable alternatives or that he sustained any quantifiable loss. Because plaintiff sought statutory damages under General Business Law §§ 349 and 350 without waiving them, the claims could not proceed as a class action.

Fired Lawyer Plausibly Supports Replevin Elements in Case Over Plaintiff's Dropbox Files

Plaintiff William Gottlieb Management Co., (WGM) retained defendant lawyer to perform legal services. In 2017, during the course of the engagement, WGM provided defendant with "a user login and access to the WGM Dropbox Professional Account," including various shared folders. The WGM Dropbox "is stored in 'the Cloud.'" In 2018, WGM terminated defendant's services. However, WGM did not change or revoke his login credentials, and did not take any other steps to restrict defendant's electronic access to the shared folders in the WGM Dropbox. In 2018, defendant sued WGM in state court for legal fees. In 2020, WGM filed the instant action, alleging defendant violated the Stored Communications Act and breached a common-law duty of care to his former client when he "accessed, viewed, added, edited, and/or deleted files and folders" within the WGM Dropbox, using his WGM-authorized login credentials, at various times in 2019. The court granted defendant's motion to amend his counterclaim, finding it provides detailed factual allegations that plausibly support the necessary elements of a replevin claim, including that he demanded the return of his property and was refused.

U.S. - SDNY | CIVIL PROCEDURE

Legislative Privilege Doctrine Bars Depositions of Legislators, Legislative Aide

Plaintiffs, which operate online food delivery services like DoorDash and Grubhub, all of which are based outside of NY, brought an action challenging the constitutionality of an ordinance passed by the NYC Council during the COVID-19 pandemic that imposes price caps on the commissions charged to restaurants by plaintiffs. Plaintiffs moved to compel defendant City of New York to produce witnesses in response to Plaintiffs' deposition notices. Specifically, Plaintiffs sought to compel Fed. R. Civ. P. 30(b)(1) depositions of two NYC Council members and the chief of staff to one of the members; and testimony pursuant to a Fed. R. Civ. P. 30(b)(6) deposition notice. The City opposed the motion to compel primarily arguing that the depositions of the legislators and legislative aide were barred under the legislative privilege doctrine. The court denied plaintiffs' motion to compel, concluding that plaintiffs' interest in disclosure in this private civil lawsuit does not rise to a level sufficient to overcome the competing public interests in ensuring that legislators devote their full attention to their legislative duties and in avoiding chilling legislative deliberations.

NEW YORK | LITIGATION

Judgment Found for Claimant in Small Claims Abuse Action

Claimant, appearing self-represented, commenced an action to recover damages as a result of an assault and battery. The court conducted a non-jury trial. Claimant testified on her own behalf and presented one witness. Claimant introduced twenty exhibits. The court entered judgment in favor of claimant. The court held claimant demonstrated entitlement to damages in the amount of \$10,346.23. The court found a judgment in the amount of \$10,000. The court found that claimant sustained her burden of proof by a preponderance of evidence. The court found that claimant testified credibly. It was undisputed that claimant had informed defendant prior to their first date that she suffered trauma from past sexual and domestic abuse. It was also undisputed that claimant never asked, nor did she consent to, defendant choking her or yanking her hair during their sexual encounters.

ULSTER | TRUSTS AND ESTATES

Court Allocates Interest in LLC to Residuary Beneficiaries

A proceeding was brought concerning objections to the final accounting of Susan Schafer as executor of the Estate of Stephen Schaffer. The last will and testament of Stephen Schaffer was admitted to probate in May 2016. A petition for judicial settlement of interim account was filed. The executor identified a crucial issue in the administration of the estate: the principal asset of decedent's residuary estate was his 1/24th interest in a family limited liability company, but decedent's power to transfer it was severely constrained by the terms of the LLC operating agreement. The Court found that allocating the interests in the LLC in the void bequests to residuary beneficiaries qualified to receive them was in the best interest of everyone.

U.S. - SDNY | DISPUTE RESOLUTION

Court Confirms Arbitration Award That Holds Company CEO Liable for Fees, Costs

This dispute arose from an agreement between the parties involving sharing of millions of arrest records and mugshot photos to build up petitioner Clearview AI Inc.'s facial recognition technology. Petitioner moved the NY Supreme Court to confirm its arbitration award against respondents Investigative Consultants Inc. and its CEO, Donald Berlin. Respondents removed the case to federal court and cross-moved to vacate, modify, or correct the award as it, among other things, held Berlin personally liable for a part of the attorneys' fee award. The instant court granted petitioner's petition to confirm, determining that the arbitrator adequately explained his reasoning for holding Berlin liable, as it found that "Berlin is properly a party to this arbitration, and he undoubtedly participated in the proceedings in a way that increased costs and fees, including participating in the events that led to [the court's] costs order." Further, while the arbitrator held Berlin was not personally liable for petitioner's affirmative claims, he held that Berlin was jointly and severally liable to petitioner on the costs incurred by petitioner as a result of respondents' counterclaim.
