Order Denying ACS’s Preclusion From Using Videotape of Interview as Evidence Upheld

In 2023 respondent father’s children were interviewed by a Safe Horizon employee at the Manhattan Child Advocacy Center. The videotaped interviews were observed by a detective from the NYPD’s Special Victims Unit and representatives from the Manhattan District Attorney’s Office and Child Protective Services. On Oct. 10, respondent was arrested and charged with first-degree sex abuse and endangering the welfare of a minor. Charges were dismissed on July 15, 2024, due to lack of witness cooperation. On Oct. 1, 2023, the Administration for Children’s Services commenced action under Family Court Act Article 10 alleging that respondent sexually abused both of his daughters. Respondent moved to preclude ACS from introducing the videotape or a transcript of the interviews. First Department upheld supreme court’s Nov. 29, 2024, order denying his preclusion motion. The videos were not official records and papers related to the father’s arrest or prosecution. The interviews were taken in the regular course of the CAC’s business and not in conjunction with law enforcement related to respondent’s prosecution.

NEW YORK | REAL ESTATE

Court Holds Plaintiff is Entitled to Receiver Under Mortgage

Plaintiff sought to foreclose on a mortgage encumbering a parcel of improved real property located at 224 Centre Street in Manhattan. Plaintiff commenced the action wherein it was alleged defendants defaulted in repayment of the note. Plaintiff moved pursuant to RPL §254[10] and RPAPL §1325[1] for the appointment of a temporary receiver of the rents of the mortgaged premises. Mortgagor and guarantor defendants opposed the motion. The motion was granted. The court held it was undisputed that the parties’ mortgage provided that plaintiff may apply for the appointment of a receiver and plaintiff pled that defendants defaulted in repayment of the indebtedness, a default event under the loan documents.

SUFFOLK | LITIGATION

Court Grants Injunctive Relief Against Cannabis Dispensary

Plaintiff brought a dispute concerning the operation of a cannabis dispensary. Plaintiffs consisted of the owners and managing association of a group of commercial condominiums. Defendant, SRM, was the owner of an individual condominium unit and the defendant Strong Strains was a tenant at that location operating a retail cannabis dispensary. Strong Strains had obtained the necessary license and permit from the State of New York and the local municipality to operate such a business. Plaintiffs moved for a preliminary injunction preventing the continued operation of the cannabis facility. The court held the plaintiffs, if denied injunctive relief, would suffer from a continuous use of Unit 19 in a manner which violated a covenant and which would result in the harm described.

U.S. - EDNY | DISPUTE RESOLUTION

Arbitration Compelled; Agreement’s Existence, Signature’s Authenticity Established

Duran was an employee of a Taco Bell food outlet between 2021 and 2024. She became pregnant in early 2024. After informing general manager Sarate of her pregnancy, and seeking a work accommodation Duran learned she was taken off the work schedule. After a later call with store manager Karim and a human resources employee, Duran alleged she was fired. Her present action against Taco Bell, Sarate, and Karim alleged gender and pregnancy-based discrimination and retaliation. Defendants moved to compel arbitration on grounds that Duran signed an arbitration agreement, provided as Defendants’ Exhibit A. Duran claimed never to have signed an arbitration agreement, and contested the exhibit’s authenticity. The court granted defendants’ motion to compel arbitration. Through preponderant evidence, defendants established the existence of an arbitration agreement signed by Duran, and the authenticity of her signature. Although she disputed the arbitration agreement’s authenticity, Duran did not seriously contest that the agreement covered her six causes of action against the defendants.

NEW YORK | CONTRACTS

Summary Judgment Partially Granted In Breach of Contract Action

In an action arising from an agreement to provide testing samples during COVID-19, the plaintiffs, Drexel Distribution Inc. and Drexel Distribution Inc. sought \$1,654,222.00 in unpaid invoices. Drexel moved for partial summary judgment on its breach of contract cause of action or, in the alternative, for summary judgment on its unjust enrichment and quantum meruit causes of action, and damages in the amount of \$462,506.00. The defendant, Prophase Diagnostics, Inc., opposed the motion. The motion was granted in part as to the first cause of action, with reduced damages of \$125,235.00. The court held Drexel established its *prima facie* entitlement to judgment as it established the existence of a contract, the party’s performance under the contract, the opposing party’s breach of the contract, and resulting damages.

NEW YORK | MEDICAL MALPRACTICE

Court Grants Plaintiff’s Motion for Extended Discovery

Plaintiff brought an action sounding in medical malpractice concerning a 77-year-old female with uterine cancer who was undergoing chemotherapy treatment at Memorial Sloan Kettering Medical Center. The allegations against Syosset Hospital concerned an alleged failure to notify her treating oncologist that she had a syncopal episode and/or a failure to administer proper prophylactic treatment. Plaintiff sought an order vacating the 90-day notice and extended time for discovery and filing the Note of Issue. The motion was granted for more time for discovery but denied as to everything else. The court held that plaintiff had provided a reasonable excuse for delaying the prosecution of the matter. The court also found that upon reviewing the moving papers, the plaintiff was now ready, willing, and able to proceed with discovery.

SECOND CIRCUIT | CIVIL RIGHTS

Second Amendment Challenge to City’s Concealed Carry License Regime Fails

Plaintiffs brought Second Amendment challenges to New York’s concealed carry license regime. Relevantly they contested the ban on carrying firearms in “sensitive locations”—Times Square, the New York City subway system, and the Metro-North rail system; New York’s ban on open carry; and, the requirement that a State concealed carry license holder apply for and receive a City-specific permit in order to carry a firearm in the City. Second Circuit affirmed district court’s March 13, 2023, order denying plaintiffs a preliminary injunction against the subject provisions’ enforcement. Plaintiffs were unlikely to succeed on the merits. Based on the preliminary record before it, Second Circuit determined that the government showed that each of the challenged provisions fell within the country’s historical tradition of gun regulations, and thus did not violate the Second Amendment. The Supreme Court has repeatedly confirmed that laws forbidding the carrying of firearms in sensitive places are presumptively lawful regulatory measures.

Early Termination of 10 Years’ Supervised Release Is Explained

In September 2017 defendant Sullivan pleaded guilty, under agreement, to one count of knowing possession of prepubescent child pornography. His guideline imprisonment range was 97 to 121 months. For several reasons the court found six months’ incarceration a reasonable sentence. However, it imposed a 10-year term of supervised release. Early termination of supervised release was denied in 2022, and again in 2024 without prejudice to renewal on or after April 25, 2025. Although defendant’s second motion made a strong claim, militating against early termination was the nature and circumstances of his offense. Presently, the court granted defendant’s third application for early termination of supervised release pursuant to 18 USC §3583(e)(1). Importantly, the Probation Department confirmed his compliance with his conditions of supervision, and passage of his most recent truth verification test. The court, which viewed defendant’s case as unique, found early termination warranted. He succeeded in sex-offender treatment, and engaged in extraordinary efforts to volunteer, educate himself, and maintain employment, substantiating his rehabilitation.

NEW YORK | CONTRACTUAL DISPUTES

Summary Judgments Denied; Issue of Fact Whether Managers Were Suborned

In an action involving a derivative claim asserted by 111 W57th Investment, LLC on behalf of 111 West 57th Partners LLC and its wholly owned subsidiary 111 West 57th Mezz 1 LLC against defendant 111 W57 Mezz Investor LLC, plaintiff alleged that defendant breached the implied covenant of good faith and fair dealing inherent in a March 28, 2017 Pledge and Security Agreement (“PSA”). Defendant moved for summary judgment, and plaintiff moved for partial summary judgment as to liability. Both motions were denied. The court held the evidence demonstrated at the very least an issue of fact as to whether defendant suborned the managers of 111 West 57th Mezz 1 LLC, Michael Stern and Kevin Maloney.

NEW YORK | LANDLORD TENANT LAW

Summary Judgment to Collect Rental Arrears Denied

Plaintiff, Ved Parkash commenced an to recover alleged rental arrears in the amount of \$16,514.25 plus attorney’s fees in the amount of \$3,302.85. Defendant, Juan Bautista filed its alleging a general denial. Plaintiff moved for summary judgment. The motion was denied. The court held plaintiff had not met its burden of demonstrating entitlement to judgment as a matter of law. The defendant had successfully raised triable issues of fact requiring resolution at trial. Defendant had submitted an affidavit in which he argued he vacated the apartment on 5/2021, the entire \$20,553 debt was paid off, and that he was compelled to vacate the apartment due to loss of employment during the COVID-19 pandemic.

U.S. - SDNY | CREDITORS’ AND DEBTORS’ RIGHTS

Lack of Jurisdiction Sinks Suit Over Dunning Letters; No Injury Confers Standing

Defendants’ letters to plaintiff in their attempts to collect on credit card debts exceeding \$15,000 in aggregate allegedly violated the Fair Debt Collection Practices Act (FDCPA). They were either incorrect; failed to disclose a pending lawsuit in state court; or, failed to meaningfully demonstrate that plaintiff’s account had been reviewed before the letter was sent to plaintiff. Granting defendants’ motions the court dismissed plaintiff’s action without prejudice, for lack of subject matter jurisdiction. Among other things, plaintiff failed to demonstrate an injury in fact sufficient to confer Article III standing. Plaintiff did not allege that he suffered any monetary or physical injury as a result of the letters from two defendants. Plaintiff also appeared to argue that an injury automatically arises where a defendant misleads a plaintiff into believing that a debt collection action meaningfully involves an attorney when in fact it does not. Other courts facing similar “attorney involvement” claims have determined that such claims, alone, are insufficient to allege an injury in fact.
