KINGS | MOTOR VEHICLE TORTS

Default Judgments Denied; Lack of Jurisdiction And Service Against Defendants

Plaintiff Ignatius Romany, in an action related to a care crash, sought an order granting leave to enter a default judgment on the issue of liability against defendants Rigo Limo-Auto, Corp and Yasmin Santiago. Although the motion was unopposed, the court denied the motion, without prejudice. With respect to defendant Rigo Limo-Auto, Corp., the court found that because service of the commencement papers occurred well beyond the 120-day period required by CPLR 306-b, the court lacked jurisdiction over the defendant. With respect to defendant Yasmin Santiago, because the court found that the plaintiff failed to demonstrate the exercise of due diligence before attempting service and compliant pursuant to CPLR 308 (4).

Dismissal Denied; Statement of Fire Marshal Was Not Hearsay

Defendant was charged with filing a false report to the New York City Police Department. Defendant moved to dismiss arguing that Brooklyn District Attorney's Office failed to hand over proper discovery. The motion was denied. The court held the statement of a fire marshal in the accusatory instrument did not constitute hearsay since the references to the NYPD complaint and insurance records were not offered for the truth of the matters asserted therein. It was further held that the hearsay statement of the fire marshal that the informant told him that defendant paid him to move the vehicle that was allegedly stolen, was properly cured by the informant's supporting deposition stating that he read the accusatory instrument and the facts stated therein were true to his personal knowledge.

Petition Against 12-Year-Old Denied In Interest of Justice

The Presentment Agency commenced a juvenile delinquency proceeding by filing a petition charging Logan R., then age 12, with twelve counts that included manslaughter in the second degree, criminal possession of a weapon in the second degree, assault in the second degree, criminally negligent homicide, and reckless endangerment in the second degree. The court was asked to decide whether the petition charging the 12-year-old with second degree manslaughter, criminally negligent homicide, criminal possession of a weapon, and related offenses should be dismissed in the furtherance of justice. The petition was denied. The court held it believed that it was manifestly unjust where the events of the situation commenced with the incredibly irresponsible lapse in judgment by an adult that the only person who should take the fall is the 12-year-old.

QUEENS | CRIMINAL LAW

Unjust Delay By Prosecution Allows Court To Dismiss Case

Defendant was charged with operating a motor vehicle while intoxicated. Defendant moved to dismiss. The motion was granted. The court held the defense was deprived, for a significant period following two judicial orders of critical impeachment material necessary to meaningfully investigate an officer's background, to prepare for effective cross-examination at a hearing, and make informed decisions regarding trial strategy or potential plea negotiations. The delay, extending over several months after the court explicitly ordered disclosure of records "related to the subject matter of the case" fundamentally hampered the defense's ability to challenge the lawfulness of the police conduct and the officer's account of the events, undermined the fairness of the proceedings and violating CPL 245.20, and 30.30.

Motion to Dismiss Granted; Claimant Failed To Make Administrative Appeal

Claimant brought an action in Small Claims Court against Con Edison. Claimant was seeking \$4,982.39 in claimed overcharges. Claimant asserted that the utility cut the electric wires to his house, and he suffered spoiled food, plus loss of Airbnb. Defendant brought a motion to dismiss as the Public Service Commission, as an administrative agency, has primary jurisdiction over utility billing matters. Furthermore, after a complaint, claimant received a \$5,000 billing credit. Claimant replied that the \$5,000 did not compensate him for his damages. The court granted dismissal as claimant failed to pursue an administrative appeal through the Public Service Commission.

Court Pierces Statutory Cap to Incorporate Respondent's Pro Rata Share

Petitioner J.V. filed a child support petition against respondent S.P. She sought a child support award above the statutory cap. The court found it necessary and appropriate to pierce the statutory cap for the sole purpose of incorporating S.P.'s pro rata share of the average of the child's competitive cheerleading expenses proven at trial. Were the court not to do so, the court held the child would have unfairly suffered the economic burden of her parents' separation. The court also ordered S.P. to maintain health insurance for the child, to pay his pro rata share of the child's unreimbursed medical expenses and child care, and to maintain a life insurance policy with the child as the beneficiary.

SECOND CIRCUIT | SECURITIES LITIGATION

Transactions Cannot Be Paired as Suits; Are Premised on Same Invalid Legal Theory

Related appeals considered a novel theory of liability for short-swing profits under Section 16(b) of the Exchange Act, which requires corporate insiders to disgorge all profits realized from paired purchases and sales, within a six-month period, of any equity security of an issuer with which they have an insider relationship. Appellant, allegedly a shareholder of the Estée Lauder Companies Inc. and who allegedly owns common stock of Altice USA Inc., sought to impose Section 16(b) liability by pairing sales by controlling shareholders with share repurchases by corporations they control. However, the Second Circuit found that the identified transactions are different in kind because of the peculiar nature of shares repurchased by an issuer under Delaware law, and these differences make Section 16(b) impossible to apply, let alone to apply mechanically. As the transactions, therefore, cannot be paired, the panel affirmed the judgments dismissing appellant's complaints. The panel noted that while the facts in the two cases are parallel, and the legal theory advanced in them, identical, both suits are premised on the same invalid legal theory.

U.S. - SDNY | COPYRIGHTS

Copying of Plaintiff's Work Was Not a Fair Use; Plaintiff Entitled to Default Judgment

Plaintiff photographer appealed from a district court dismissal of her claim of willful copyright infringement against defendant pursuant to Sec. 501 of the Copyright Act. Her complaint alleged defendant infringed upon her rights when it published a photograph authored by her on its website without her authorization. Defendant did not answer the complaint and did not appear in court. On plaintiff's motion for default judgment, the district court ordered defendant to show cause why the court should not grant the motion. Having received no response from defendant, the court sua sponte ordered plaintiff to show cause why defendant's use of plaintiff's photograph did not constitute fair use. The district court then dismissed plaintiff's complaint with prejudice on the ground that defendant's publication of plaintiff's photograph constituted fair use. The Second Circuit reversed and remanded with instructions to enter a default judgment in plaintiff's favor, finding that since no valid reason to support the district court's conclusion that defendant's copying of plaintiff's work was a fair use, the court had no reason to deny plaintiff's motion for default judgment.

U.S. - SDNY | CONSUMER PROTECTION

Plaintiffs Sufficiently State an NYGBL Claim Over Coca-Cola's Alleged False Labeling

Defendant Coca-Cola sells fruit punch with a label that reads "No Preservatives Added." Plaintiffs alleged the label is false because the fruit punch contains citric acid, which they asserted is a preservative. Plaintiffs sued under NY General Business Law (NYGBL) §§349 and 350 as well as for breach of express warranty and unjust enrichment. The court denied defendant's motion to dismiss for failure to state a claim, concluding plaintiffs stated a claim under the NYGBL since their complaint contains specific, non-conclusory allegations that the product contains citric acid, the FDA has described citric acid as a preservative in similar contexts, and citric acid has preservative qualities when used in food and beverages. In short, the complaint alleges sufficient facts from which the court can plausibly infer that citric acid "functions as a preservative in the product." The court noted plaintiffs are not required to plead facts giving rise to an inference of scienter in order to state a claim pursuant to §§349 and 350 and that it is enough, for purposes of the NYGBL, for plaintiffs to allege citric acid is a preservative and is present in the product.

U.S. - SDNY | BANKRUPTCY

Court Dismisses, as Time-Barred, Bankruptcy Code, Constructive Conveyance Claims Over LBO

This action arose from the 2014 leveraged buy-out (LBO) of fashion retail company The Jones Group Inc., which sold popular brands such as Nine West and Anne Klein to retailers across the country. In 2024, a private equity firm acquired Jones Group via a merger with one of its subsidiaries, and it renamed the surviving company Nine West Holdings Inc., which eventually went into bankruptcy. Plaintiffs, consisting of a litigation trustee, those representing unsecured creditors, and others, brought consolidated actions against officers, directors, and shareholders of Jones Group, claiming breach of fiduciary duty, fraudulent conveyance, unjust enrichment, and other state law claims arising out of the bankrupting, and bankruptcy, of the company in connection with the LBO. The instant court granted the remaining defendants' motion for summary judgment, in part, as to the time-barred litigation trustee's Bankruptcy Code Section 544(b) claims and the time-barred indenture trustee's state-law constructive conveyance claims. The court, however, denied summary judgment as to the remaining intentional fraudulent conveyance claims.

U.S. - SDNY | CIVIL PROCEDURE

Defamation Claim Fails; Alleged Statements Are Either True, Privileged from Suit, or Both

This action was the latest in a 15-year-long series of disputes between plaintiff and defendants Major, Lindsey, & Africa LLC (MLA) and Allegis Group, Inc. Plaintiff worked for MLA as a legal recruiter until 2009, when MLA terminated her for allegedly misappropriating confidential information about MLA's clients and selling that information to its competitors. Plaintiff subsequently petitioned for Chapter 7 bankruptcy. A year later, plaintiff's trustee in bankruptcy sued MLA and some of its employees in state court for an alleged sexual assault that occurred while plaintiff was still working at MLA. Plaintiff now alleged defendants defamed her in an article discussing her sexual assault action, as well as in their legal briefs in state and bankruptcy court. The instant court granted defendants' motion to dismiss the complaint, as it failed to state a claim for defamation because defendants' alleged statements were either substantially true, privileged from suit, or both. The court also found, among other things, that plaintiff failed to state a claim for abuse of process because defendants are not alleged to have done more than issue lawful writs for legitimate purposes.
