NEW YORK | CONTRACTUAL DISPUTES

Court Finds Plaintiff's Actions Were Consistent With Contracts

Plaintiff brought an action arising out of an alleged breach of an agreement of the purchase and sale of future receivables. Plaintiff moved for summary judgment and to dismiss defendants' affirmative defenses. Defendants opposed the motion and cross moved to dismiss the complaint. The plaintiff's motion was granted. The court held the plaintiff satisfied the court that their actions were consistent with the contract requirements, and that the estimated time for completion of the agreement by its very wording of "estimate" did not set a finite term.

Fora Fin. Warehouse, LLC v. EZ Star Corp., 156265/2024 (July 22)

RICHMOND | TRUSTS AND ESTATES

Temporary Restraining Order on Real Property Vacated

Respondent sought to have the court grant a preliminary injunction preventing petitioners from selling real property of the Estate at issue. Respondent alleged that an attempt of petitioners to sell the real property, at a price alleged to be below fair market value, while an objection to petitioners' final accounting was pending constitutes irreparable harm. Respondent had failed to offer clear and convincing evidence demonstrating that petitioners' attempt to sell the real property at issue would constitute irreparable harm, as any injury would be economic and could be remedied by monetary damages. Petitioners successfully argued that respondent offered no credible evidence of irreparable harm. The court held that since there was no clear and convincing evidence of irreparable harm to respondent's beneficiary interest in the Estate from Petitioners' attempt to sell the property at issue, the motion for a preliminary injunction was denied and the temporary restraining order issued by the court on the property was vacated.

SECOND CIRCUIT | EMPLOYMENT LITIGATION

Rulings on FRBNY Covid 19 Vaccine Policy Exemptions Explained

In 2021 the Federal Reserve Bank of New York (FRBNY) adopted a policy requiring all employees to be vaccinated against Covid 19 unless they were granted a religious or medical exemption. Plaintiffs' requests for religious exemptions were denied, and their employment was ultimately terminated. District court granted FRBNY summary judgment on plaintiffs' federal claims. There was no genuine dispute that plaintiffs lacked sincerely held religious objections to FRBNY's vaccination policy, and that the policy did not conflict with plaintiff Diaz's professed religious beliefs. Second Circuit partly affirmed, partly vacated, and remanded district court's judgment. The court correctly granted summary judgment on plaintiff Gardner-Alfred's claims, but material factual issues precluded summary judgment on Diaz's claims. nor did the court abuse its discretion in granting the FRBNY discovery sanctions. Plaintiffs repeatedly neglected their discovery obligations, withheld relevant documents, and ignored court orders.

U.S. - NDNY | CIVIL PROCEDURE

Entry of Default Based Solely on Failure To Litigate, Is Vacated

Doe sued Rees for the unconsented to, non-consensual disclosure of an "intimate visual depiction" and also asserted claims including intentional infliction of emotional distress, defamation, and fraudulent transfer of property to avoid judgment. Plaintiff Doe sought default judgment while defendant Rees moved to vacate the entry of default and to stay proceedings. The court granted vacatur of the entry of default but otherwise denied both parties' motions. The entry of default was based solely on defendant's failure to litigate. Rather, defendant's conduct, by itself, was not so egregious that his vacatur motion must be denied. Also, plaintiff did not demonstrate prejudice resulting from the delay. She did not point to any specific loss of evidence or witnesses. After careful consideration of all relevant factors, default was vacated. Defendant was warned that continued disregard of court orders and rules, or of discovery processes could lead to sanctions, including a default judgment.

NEW YORK | MEDICAL MALPRACTICE

Claim for Vicarious Liability Allowed To Proceed Even Without Specific Identification

In a medical malpractice action, defendants moved for summary judgment. In support of their motion, defendants submitted the affirmation of Dr. Alexander McMeeking, M.D., a board-certified Internist and Infectious Disease physician. He opined, defendant doctor did not depart from good and accepted standards of medical care as to the diagnosis and treatment of plaintiff's fungal infection and did not proximately cause plaintiff's alleged injuries. The court affirmed that a claim for vicarious liability against a defendant hospital could proceed even if the initial bill of particulars lacked specific names of individual employees. The court ruled that the subsequent identification of these employees during discovery, coupled with the plaintiff's expert affirmation, was sufficient to establish such a claim.

NASSAU | LITIGATION

Small Claims Action Dismissed By Court

Plaintiff commenced a small claims action against defendant corporation, an insurance brokerage. Counsel for Defendant, Ability Service Agency, Inc., moved on behalf of his client for an order seeking dismissal of the matter for a lack of subject matter jurisdiction; or, in the alternative dismissing the complaint on the ground that documentary evidence conclusively established a defense to the asserted claim. The case was dismissed. The court held based on the clear and unambiguous language of the signed application, executed by both the plaintiff and the defendant broker, that the application was dispositive of the plaintiff's claim against the defendant broker.

SECOND CIRCUIT | CRIMINAL LAW

Court Acted Within Its Discretion in Denying Compassionate Release

Rodriguez is serving two concurrent life sentences after being convicted of two murders, including a 14-year-old, and related drugs ad firearms offenses. District court denied him compassionate release. Even if he had shown extraordinary, compelling circumstances compelling sentence reduction, the seriousness of his offense and the need to protect the public weighed against reducing sentence. Second Circuit held that district court acted well within its discretion in denying compassionate release. Thus his appeal lacked an arguable basis in law or in fact, and was dismissed as frivolous under 28 USC §1915(e)(2)(B)(i). the Circuit also denied Rodriguez's motion for appointment of counsel, and his motion for a certificate of appealability. The 18 USC §3553(a) sentencing factors weighed against reducing sentence. In addition to the two murders, and other offenses of conviction, Rodriguez committed numerous infractions while in custody, including possessing a dangerous weapon, fighting, and assault. Rodriguez raised no arguable basis for challenging the district court's judgment.

U.S. - WDNY | CIVIL PROCEDURE

Denial of Appointment of Interim Class Counsel Is Explained

Plaintiff's putative class suit against defendant insurer GEICO Indemnity asserted a claim for breach of contract based on GEICO's failure to pay sales tax as part of the "Actual Cash Value" (ACV) for total loss vehicles. Instantly, the court denied plaintiff's motion to appoint three law firms—Feinstein Doyle Payne & Kravec LLC, Vozzolo LLC, and Normand PLLC—as co-lead interim class counsel. Plaintiff did not show how appointment of interim class counsel would benefit the instant litigation, or how the interests of the putative class would be best served by appointing plaintiff's counsel to that role. Nor did plaintiff show appointment of interim class counsel necessary. Plaintiff's counsel are the only attorneys litigating this action on behalf of a single named plaintiff. Consequently, there is no need to clarify responsibility for protecting the interests of the class during precertification activities.

Shiloah v. GEICO Indem. Co., 6:24-CV-06447 (August 12)

NEW YORK | PERSONAL INJURY

Case Dismissed as There Was No Prior History of Violent Incidents at Theatre

Plaintiff commenced this action seeking damages for personal injuries allegedly sustained on June 3, 2017, at The Hudson Theatre located at 139-141 West 44th street in Manhattan when she was struck in the back of the head with a playbill by a man sitting behind her while attending a play. Plaintiff asserted a sole cause of action for negligence against defendants Ambassador Theatre Group, LLC. Defendants moved for summary judgment. The motion was granted. The court held there was nothing in the record indicating any history of prior incidents of violence or criminal activity at the Theatre, nor any other facts indicating that defendants should have been on notice of any potential violent activity, including between the parties at issue.

PUTNAM | CRIMINAL LAW

Motion Denied; Improper to Reopen Previously Decided Issues

In 2018, defendant was convicted, after a jury trial, of burglary in the first degree and bail jumping in the second degree. The allegations stem from an incident on August 28, 2014, when defendant arrived unannounced at the home of his aunt. On that day, defendant suddenly entered the victim's house through an open garage door and began violently attacking the victim by punching and kicking her. The trial court sentenced defendant to a determinate term of 14 years in prison. Defendant unsuccessfully appealed his convictions. Defendant filed a CPL article 440 motion, arguing that his trial attorney rendered ineffective assistance of counsel by failing to call any of his family members to testify at trial. The motion was denied. The court held that an evidentiary hearing was improper here to reopen previously decided issues. In so holding, the court reasoned that the elements of the crime of burglary in the first degree were all established by the proof beyond a reasonable doubt.

U.S. - EDNY | INSURANCE LITIGATION

Uber Passenger Exited Car Before Crash; Insurer Properly Denied Coverage

On Jan. 11, 2020, plaintiff Mbo was driving for Uber when another vehicle crashed into his car. He had just completed his Uber ride and his passenger had completely left the car. Defendant supplemental insurer Old Republic denied Mbo coverage plaintiff was not transporting a "passenger" at the time of the accident. The court granted Old Republic summary judgment. On the undisputed facts, Mbo was not "transporting passengers" when his car was struck by the other vehicle. The accident unambiguously fell outside the scope of Old Republic's supplemental insurance policy to nonparty Uber. There is no ambiguity that a policy that applies only when a driver "is transporting passengers" does not apply to a driver, like Mbo, whose passenger has already left the car. Once a driver safely delivers his passenger to his destination, the act of "transportation" is over.
