NEW YORK | TRUSTS AND ESTATES

Letters of Administration Given to Public Administrator; Petitioners Unable to Cooperate

Decedent was survived by her two daughters. The daughters had equal rights to administer the estate. The will was probated in Greece. The daughters petitioned the court for the letters of administration to marshal decedent's assets in New York and to relinquish the apartment to the landlord. It was alleged the back rent owed on the apartment was greater than the value of decedent's assets. The letters were administered to the Public Administrator of New York. The court held that the sisters were unable to cooperate with each other on the matter.

Will of Magdalini Jacobs, 2023-4451 (May 29)

KINGS | LANDLORD TENANT LAW

Eviction Dismissed; Portable Voucher Did Not Exempt Tenant From Rent Regulation

Petitioner commenced a holdover proceeding after service of a 90 day notice of termination. Petitioner alleged that the premises was not subject to rent regulation as the building was built after 1974 and that there was no 421-A or J-51 tax abatement in place. Petitioner moved to amend and respondent moved to dismiss. Respondent's motion to dismiss was granted. The court held respondent's portable voucher did not regulate the amount of rent which can be charged for the unit or dictate the terms of an eviction such as a unit within a HUD based section 8 building, NYCHA complex, HPD regulated housing or rent stabilized/rent regulated units. Petitioner's arguments that the premises was exempt because respondent has a portable section 8 voucher lacked any basis in the law.

RICHMOND | PERSONAL INJURY

Court Grants Motion as Defendants Failed to Show Up for Deposition

Plaintiff brought a case to recover for personal injuries sustained by plaintiff when her automobile was allegedly struck by a truck operated by its employee and owned by defendant Island Redi Mix, Inc. Plaintiff moved pursuant to CPLR § 3126 to strike defendants' answer based on the grounds that defendants failed to appear for deposition. The motion was granted. The court held plaintiff was prejudiced not merely by delay, but by the inability to conduct meaningful examination of defendants' version of events, operational practices, and potential admissions.

RICHMOND | CRIMINAL LAW

Charges Dismissed; Prosecution Failed to Show Defendant's Intention to Damage Car

The Richmond District Attorney's Office charged defendant with one count of criminal mischief in the fourth degree. Defendant moved to dismiss. The motion was granted. The court held that because the alleged act in the accusatory instrument failed to establish the specific intent to damage the complainant's car, the conscious objective to damage the property of another would have to be established by surrounding circumstances, however, the People's information failed to allege any surrounding circumstances demonstrating that the defendant walked around the complainant's car with the conscious objective to scratch it.

WESTCHESTER | FAMILY LAW

Modification Order Denied as It Would Not Be in The Child's Best Interest

In a proceeding seeking to modify a prior order of sole custody to the mother, the court declined to modify the prior order. The court found there had been no substantial change in circumstances to warrant a hearing, despite the mother's move out of state with the children, where the factors that led to the prior award of sole custody continued to exist. The court possessed sufficient information to determine that a modification of custody would not be in the children's best interests.

GREENE | CONTRACTS

Breach of Contract Claim Dismissed, Complaint Set Forth Quantum Meruit Cause of Action

In a breach of contract action, defendant was a homeowner who hired plaintiff to perform work on her fire-damaged residence. After cleaning the exterior and preparing the wood for the application of new stain, plaintiff texted defendant a photo of the stain applied to a small portion of the house. Defendant approved the color and plaintiff spent the next couple of days applying the stain. Defendant appeared in person and decided she disliked the color. A dispute ensued and defendant terminated the contract. When plaintiff sued for breach of contract, defendant counterclaimed. Plaintiff moved for summary judgment and defendant cross-moved for summary judgment. The court found that the contract was unenforceable due to the GBL 771 violations. However, the court found that the complaint set forth the elements of a quantum meruit cause of action. The court dismissed the breach of contract claim and otherwise denied both summary judgment motions.

U.S. - SDNY | CONTRACTUAL DISPUTES

Warehouser Is Entitled to \$1.6 Million On Its Unjust Enrichment/Reasonable Value Claims

Plaintiff Prompt Apparel's state court action against defendants Chic Home Design and YX1 Logistics, arising from Prompt's warehousing agreement (Agreement) with Chic, was removed to federal district court on the basis of diversity jurisdiction. Instantly, district court found Prompt entitled to \$12,500 in damages—plus 9 percent per annum statutory prejudgment interest from Aug. 14, 2023—based on preponderant evidence that Chic breached the Agreement, in July 2023, by failing to pay a \$12,500 invoice for work relating to goods shipped to Bed Bath and Beyond. After terminating the Agreement following reasonable 69-day notice, Prompt continued to provide warehousing services to Chic, the reasonable value for which—\$0.43 per cubic foot—it was entitled to recover for invoices until Jan. 1, 2025, but not thereafter. Accordingly, Prompt was entitled to recover \$1,603,662.36 on its unjust enrichment/reasonable value claims for the reasonable value of its warehousing services from November 2023 through January 2025, taking into account payments made by Chic. There was no basis to award Prompt contract breach damages as against YX1.

Judge, Licensing Officer, Entitled to Immunity In Suit Over Concealed Carry Permit Denial

In March 2017 former New York City police officer Morales was charged with Driving While Intoxicated and Refusal to Take a Breathalyzer Test. That April he pleaded guilty to Driving While Ability Impaired by the Consumption of Alcohol. Disciplined by the NYPD, Morales retired on Oct. 1, 2017. His NYPD Retired Police Officer identification card was marked "NO FIREARMS." Defendant Everett, a state court judge in Westchester County denied Morales's later application for a concealed-carry pistol permit, concluding that Morales's disciplinary history with the NYPD rendered him unfit. The court dismissed Morales's lawsuit against Justice Everett in his capacity as licensing officer. Second Circuit precedent holds that a judge acting as a licensing officer acts in a quasi-judicial capacity and is entitled to judicial immunity. Morales's references to judges acting in an administrative capacity were dicta not compelling a different conclusion. Thus Morales's claims against Justice Everett in his individual capacity were barred by judicial immunity. Justice Everett was also entitled to immunity under the Eleventh Amendment.

U.S. - EDNY | DISCOVERY

Estate's Administrator Not Entitled To Discovery; Plausible Claim Not Yet Pledged

Gallego administers the estate of Figueroa (Decedent). His action against Tandem Diabetes Care arose from Decedent's use of its t:slim X2 insulin pump (X2 Pump). His complaint alleged the X2 Pump was defective because it could not withstand droppage; that that defect was due to Tandem's deviation from requirements set by the Federal Drug Administration; and that the defect caused the Decedent's death, in that the Pump, which showed signs of being dropped, stopped delivering insulin. The court dismissed Gallego's March 2025 amended complaint for failure to state a claim and on preemption grounds. His negligent defective design and wrongful death claims were dismissed without prejudice, and he was granted 30 days to replead them. Instantly, the court denied Gallego discovery and directed him to file a second amended complaint. Gallego has not yet pleaded a plausible claim for relief, and thus is ineligible for discovery. Even if discovery was proper, the court was not convinced that ordering Tandem to provide the broad list of requested documents would comply with the FRCP's requirement that discovery be relevant and proportional to case needs.

U.S. - NDNY | CIVIL APPEALS

Action Stayed Pending Appeal as to NYLL's Applicability to Federal Immigration Detainees

Defendant Akima Global Services (AGS) operates the Buffalo Federal Detention Facility pursuant to contract with ICE. The Voluntary Work Program allows immigration detainees to be paid for labor performed while detained. ICE reimburses AGS one dollar daily per each VWP-participating detainee, who are paid directly by AGS. No contract, rule, or law prevents AGS from paying detainee workers more than the minimum \$1 per day. In addition to unjust enrichment and claims under the Trafficking Victims Protection Reauthorization Act, plaintiffs asserted claims under the New York Labor Law, including violation of the NYLL's minimum wage requirement. On March 31, 2025, the court denied AGS and its codefendants summary judgment. Instantly the court stayed action pending interlocutory appeal of a novel question of state law; whether the NYLL applies to federal immigration detainees. The NYLL's applicability is a purely legal threshold question—on which there is substantial ground for difference of opinion—that will determine if plaintiffs have a cause of action under the NYLL.

U.S. - WDNY | ADMINISTRATIVE LAW

Reasons for ALJ's Decision Inadequate, Insufficient to Understand ALJ's Analysis

In 2022, after a five-step sequential analysis, an administrative law judge (ALJ) found plaintiff not disabled since its alleged Jan. 1, 2018, onset date. Among other things, the ALJ found that plaintiff's severe medical impairments did not medically equal a listed impairment, and that plaintiff had residual functional capacity (RFC) sufficient to perform past relevant work as a land surveyor. Plaintiff Jay M.'s action sought review of the Social Security Commissioner's decision that he was not disabled. On competing motions the court denied the Commissioner judgment on the pleadings and only partly granted plaintiff such judgment. Unable to "fathom" the ALJ's rationale in light of record evidence, district court vacated the Commissioner's decision and remanded action for further proceedings. The reasons provided for the ALJ's decision were inadequate. The ALJ's conclusory finding based on raw data was not "sufficiently discernable" to allow the court to understand the ALJ's analysis or to ensure that the ALJ employed proper standards. No medical record evidence supported the ALJ's RFC determination.
