Retainer Agreement Does Not Clearly Reflect Law Firm Would Charge Client for Lexis Fees

Plaintiff, a law firm that previously represented defendant in prior litigation, brought a declaratory judgment action asking the court to interpret a section of the retainer agreement between the parties concerning “out of pocket” costs and disbursements and sought a declaration that the retainer agreement allowed the firm to bill defendant for charges associated with its use of the Lexis search engine. Defendant denied that the retainer agreement allowed for the charging of Lexis fees as disbursements and asserted counterclaims for, among other things, breach of the retainer agreement. The court held that the retainer agreement did not clearly reflect that plaintiff would be charging defendant for the law firm’s Lexis fees associated with conducting legal research. Further, the court found that plaintiff did not submit any evidence substantiating the Lexis charges it sought to recover, and plaintiff’s billing invoices did not reflect billable entries corresponding with “legal research” charges. The court held that defendant was entitled to the return of \$38,748.10, the portion of the costs and disbursements that had been charged to her for plaintiff’s Lexis charges.

KINGS | PERSONAL INJURY

Motor Vehicle Accident Plaintiff Fails to Provide Competent, Current Medical Evidence

Plaintiff, who sued for personal injuries allegedly sustained in a motor vehicle accident, failed to list claimed categories of serious injury in his bill of particulars. Still, the court discerned permanent injuries were claimed. The court granted defendant’s motion for summary judgment asserting plaintiff did not sustain a serious injury and dismissed the complaint, holding that defendant’s IME doctor made out a prima facie case that there was no dismemberment, no total loss of use of a body part, and no permanent consequential limitation of a body part. Further, findings of limitations less than 20% were not consequential; another plaintiff’s doctor’s exam reports were neither affirmed nor recent; a goniometer was not used to record range of motion; conflicts between the two doctors’ findings were not explained; there was no showing of a permanent consequential limitation; and plaintiff did not show dismemberment or total loss of use of any body part. Finally, the court found that plaintiff’s affidavit failed to show that there is an issue of fact as to permanent consequential limitation of use of a body organ or member, since competent medical evidence is required.

SECOND CIRCUIT | IMMIGRATION LAW

Board of Immigration Appeals Provides Insufficient Justification for Clear Error Finding

Petitioner, a native and citizen of El Salvador, sought review of a Board of Immigration Appeals (BIA) decision vacating an immigration judge’s grant of his claim for relief under the Convention Against Torture (CAT) and the BIA’s denial of his motion to reconsider. Petitioner contended the BIA erred by finding that the immigration judge committed clear error in granting him CAT relief and failing to provide a sufficient justification for that finding. The Second Circuit granted the petition and remanded to the BIA, concluding that the BIA provided insufficient justification for its clear error finding. The panel noted that the BIA’s conclusion that an expert witness’ testimony is generalized or anecdotal failed to consider that his testimony was corroborated by various sources in the record that report intentional and systematic torture, including by beating and killing suspected gang members in and outside of prisons, and by starving prisoners and subjecting them to life-threatening prison conditions. The panel added that the BIA also did not grapple with evidence that the Salvadoran government has suppressed public information of its actions.

Indictment Sufficiently Alleges Materiality In Action Over Fraud, Money Laundering, FARA

In 2024, a grand jury returned a 10-count indictment against defendant and her husband, charging them with offenses relating to fraud, immigration, money laundering, and the Foreign Agents Registration Act (FARA). Defendants moved to dismiss, arguing the indictment failed to sufficiently allege facts supporting the offenses charged in counts eight through 11. Before the court could rule on defendants’ motion to dismiss, the government filed the first superseding indictment (S-1) on Feb. 4, 2025. The Court denied defendants’ renewed motion to dismiss the S-1 on May 5, 2025. The government then filed the second (S-2), third (S-3), and fourth (S-4) superseding indictments on June 25, 2025, Sept. 4, 2025, and Oct. 2, 2025, respectively. Defendants’ motion to dismiss was renewed as to each indictment. The instant court denied defendants’ motion concluding, among other things, that the indictment sufficiently alleged materiality as to counts eight and nine, and that the S-4’s allegation that kickback payments continued into 2021 is enough to survive dismissal because any date in 2021 falls within five years of Oct. 2, 2025, when the S-4 was filed.

NEW YORK | LEGAL MALPRACTICE

Time-Barred Counterclaim Arising from Same Transactions Can Be Maintained as an Offset

Plaintiff sought to recover unpaid legal fees owed by defendant, its former client, which it had represented as borrower in an action concerning the sale of property. Defendant asserted counterclaims for breach of fiduciary duty, unjust enrichment, and breach of contract, arguing the sought fees arose from representation “marred by unwaivable conflicts of interest” as, in 2014, 2016, and 2018, plaintiff simultaneously acted as counsel for him and the lender in connection with mortgage loans secured by defendant’s interest in the subject property. The representation ended on Jan. 28, 2020, and so the statute of limitations for professional negligence expired on Jan. 28, 2023. Since defendant filed his counterclaims on May 7, 2024, claims seeking affirmative damages or judgment beyond the amount demanded by plaintiff are clearly time-barred. However, the court determined that defendant correctly invoked CPLR §203(d), which permits a defense or counterclaim arising from the same transactions or occurrences upon which the complaint depends to be maintained as an offset, even if time barred as an independent action.

Court Dismisses Some of Plaintiff’s Claims After Underlying Action Is Discontinued

Plaintiffs sued to recover damages for fraud in the inducement and breach of contract in relation to the still outstanding and uncollected \$10 million real estate advance for development/reconstruction of a commercial building. Plaintiffs also asserted additional claims sounding in unjust enrichment, constructive trust, and declaratory relief in connection with the transaction. Plaintiffs’ \$10 million advance, via defendants, was part of a larger \$28.3 million investment which defendants pooled into CFA Broad Lender LLC, from plaintiffs and others, and allegedly invested in the underlying property. In a separate action brought by CFA against defendant 520 Broad Street Propco LLC, CFA obtained against Propco a judgment in the principal sum of \$39,681,186.62. After the instant motions were filed but before they were fully submitted in May 2025, the CFA-Propco judgment was vacated, and the underlying action was discontinued with prejudice. The court now granted defendants’ pre-answer motion to dismiss to the extent that it dismissed, with prejudice, some of plaintiffs’ claims for fraud in the inducement, unjust enrichment, constructive trust, and declaratory relief.

SECOND CIRCUIT | SECURITIES LITIGATION

Court Erred in Dismissing Class of Investors’ Exchange Act Claims in Securities Action

Representatives of a class of investors who purchased American Depository Shares in Abengoa appealed from a district court dismissal of their claims under sections 11 and 15 of the Sec. Act of 1933, 10(b) and 20(a) of the Sec. Exchange Act of 1934, and SEC Rule 10b-5. Plaintiffs alleged Abengoa manipulated its financial records to conceal its liquidity crisis, contributing to the firm’s bankruptcy. The Second Circuit held the court erred in dismissing plaintiffs’ Sec. Act claims, finding that plaintiffs’ claims were filed within the one-year statute of limitations and that the district court failed to credit plaintiffs’ allegations from confidential witnesses and from Spanish criminal proceedings, which gave rise to the plausible inference that defendants violated section 11. Further, the panel held the district court erred in dismissing plaintiffs’ Exchange Act claims, which were based on Abengoa’s refusal to consider the same allegations from the confidential witnesses and Spanish proceedings. However, the panel held the district court properly denied plaintiffs leave to assert Exchange Act claims against Abengoa’s former CEO, as such claims would have been futile.

Probation Office Must Revise PSR in Calculating Defendant’s Sentencing Guidelines Range

Defendant was convicted after a jury trial of obstructing justice and making false statements to a U.S. agency. Defendant was acquitted on another count of obstructing justice and the instant court declared a mistrial on the other 12 counts. The court granted a judgment of acquittal on one count of accepting a bribe as a public official. After a second trial, the jury convicted defendant on conspiring to defraud the U.S.; and conspiring to possess with intent to distribute and to distribute controlled substances, including less than 50 kilograms of marijuana. The jury acquitted defendant on counts that involved an alleged agreement to protect a co-defendant whose trial had been severed from his. The U.S. Probation Office filed a Presentence Investigation Report (PSR) calculating defendant’s U.S. Sentencing Guidelines range. The instant court sustained in part and overruled in part defendant’s objections to the PSR, finding that the counts should be divided into two rather than three groups; defendant’s relevant conduct involves at least 400 kilograms but less than 700 kilograms of converted drug weight; and the firearm enhancement was properly applied.

NEW YORK | CONTRACTUAL DISPUTES

Amended Profit-Sharing Agreement, Which Provides Definite Duration, Is Terminable at Will

Hedge funds entered into a profit-sharing agreement in 2004, and an amended agreement in 2011, under which Hound Partners plaintiffs agreed to provide defendant Tiger Mgmt. 12% of its yearly revenue share in exchange for \$23 million in seed capital for individual plaintiff to start his first hedge fund. The parties performed under the amended agreement until 2024, when Hound sent defendant a notice terminating it. Plaintiff alleged since the agreements contain no termination provision, the amended agreement is terminable at will and it is entitled to terminate the contract after over 20 years of performing its obligations to Tiger. Defendants argued the contract is clear that Tiger is entitled to collect a revenue share “for so long as” Hound is in business. The court had to decide whether the agreement is terminable at will or establishes a definite duration tied to the continuation of Hound’s business. The court granted defendant’s motion to dismiss plaintiff’s declaratory judgment action, as Hound failed to show the amended agreement was terminable at will since the contract provides a definite duration: it remains in effect so long as Hound operates its business.

KINGS | LANDLORD TENANT LAW

Landlord Fails to Adequately Plead Exemption to Good Cause Eviction Law

Petitioner landlord brought a holdover proceeding to recover possession of a unit located at the subject premises. Petitioner contended the tenancy is covered by Article 6-4 of the Real Property Law, known as the Good Cause Eviction Law (GCEL), and that the proceeding is allowed because petitioner “desires to use premises for use and occupancy, or principal residence, of the Petitioner-Landlord’s spouse, domestic partner, child, stepchild, parent, step-parent, sibling, grandparent, grandchild, parent-in-law, sibling-in-law.” Other than utilizing form language from RPL §216(1)(g), petitioner provided no facts to support the allegation. The court dismissed the petition, finding petitioner failed to adequately plead an exemption to the GCEL. As the GCEL is new and there is no case law on point, the court analogized it to requirements promulgated in the Rent Stabilization Code and case law addressing sufficiency of pleadings in owner’s use cases. Appellate courts have held that mere reiteration of statutory language in a notice of non-renewal based upon owner occupancy is insufficient to sustain an eviction proceeding.

U.S. - SDNY | CIVIL RIGHTS

Racially Insensitive Comments, Minus Unlawful Act, Do Not Support Equal Protection Claim

Plaintiffs D.C. and Tahlil were students at the Eldred Junior Senior High School. Defendant Messina was a teacher at the school, and defendant Ferreira was the superintendent of the district. D.C. and Tahlil, who are African American, attended a study hall period supervised by Messina. They were the only African American students in the study hall class. During the period, Messina questioned D.C. and Tahlil about the color of their skin and the texture of their hair and asked whether each was a “pure bred” Black. Plaintiffs reported the incident to the district administration, which informed them it would place a disciplinary letter in Messina’s employment file. Plaintiffs, who contended the district should have taken punitive actions against her, asserted claims under Title VII and for negligent hiring, supervision, training and retention based on Messina’s conduct and Ferreira’s and the district’s response. The court granted defendants’ motion to dismiss, finding Messina’s “racially insensitive comments” insufficient to support an equal protection claim, as plaintiffs did not allege the statements were accompanied by physical injury or other unlawful action.
