NEW YORK | PERSONAL INJURY

NYCHA's Dismissal Denied After § 50-h Hearing Adjourned Without Date

Plaintiff brought an action alleging negligence arising from a fall on a staircase in a building owned by defendant New York City Housing Authority (NYCHA). NYCHA moved to dismiss pursuant to CPLR 3211(a)(7), arguing that plaintiff failed to satisfy a statutory condition precedent requiring an examination under oath pursuant to General Municipal Law § 50-h and Public Housing Law § 157(2). NYCHA noticed an examination for June 2024, which was adjourned without date at plaintiff's request. The parties later rescheduled the examination for October 31, 2024, when plaintiff appeared, but the examination was again adjourned without date. NYCHA did not set a new date or renew its demand before plaintiff commenced the action. After commencement, NYCHA renewed its request, and an examination was scheduled for October 20, 2025, which plaintiff missed due to a calendaring error by counsel. The court denied the motion, holding that dismissal was unwarranted where the examination was adjourned indefinitely and not re-noticed before suit.

WESTCHESTER | CONSTITUTIONAL LAW

Correction Law § 865(1) Age Eligibility Survives Challenge Under Equal Rights Amendment

In a declaratory judgment action, Tammy L. George, a fifty-eight incarcerated individual at Taconic Correctional Facility, challenged the constitutionality of New York Correction Law § 865(1), which limits eligibility for the Shock Incarceration Program to individuals under the age of fifty. The challenge was brought under Article I, § 11 of the New York Constitution as amended by the Equal Rights Amendment. The program is a six-month, military-style boot camp providing intensive discipline and rehabilitation for people convicted of nonviolent felonies, offering immediate conditional release upon completion. Plaintiff argued that the amendment's inclusion of age as a protected classification requires strict scrutiny review and that the statutory age cap is arbitrary and lacks a legitimate governmental purpose. The State responded that participation in the program is a privilege, that statutes enjoy a presumption of constitutionality and that age-based eligibility criteria are subject to rational basis review. The court held that Correction Law § 865(1) is not unconstitutional on its face, finding no clear evidence of retroactive legislative intent.

SECOND CIRCUIT | CRIMINAL APPEALS

Panel Remands for Resentencing After US Supreme Court Bars Dual Firearm Convictions

Defendant has repeatedly appeared before the Second Circuit challenging convictions entered in the district court following a jury trial at which he was found guilty of multiple Hobbs Act robbery conspiracies and substantive robberies, related firearms offenses, and, in connection with one robbery, the murder of a victim. The panel addressed defendant's latest appeal following a U.S. Supreme Court remand clarifying that a defendant cannot be convicted under both 18 U.S.C. §924(c) (use of a firearm during a crime of violence) and § 924(j) (murder committed in the course of such a crime) based on the same underlying conduct. On remand, the Second Circuit held that its prior ruling permitting convictions and sentences on both §924(c) and §924(j) counts could not stand. It therefore withdrew that portion of its earlier opinion, vacated the judgment in part, and instructed the district court to vacate one of the two overlapping convictions and resentence defendant in accordance with the Supreme Court's guidance. The panel declined to revisit its earlier determination that defendant's aggregate 50-year sentence was substantively reasonable.

U.S. - SDNY | CIVIL PROCEDURE

Court Dismisses Counterclaims Against Fellow Attorney Over Alleged Smear Campaign

The parties, both attorneys, met about seven years ago when defendant was a summer associate at a large law firm. Plaintiff contended that on the night they met, defendant violently raped and sexually assaulted her, causing significant physical, professional and psychological harm. Defendant denied the allegations, asserting the encounter was consensual, and brought counterclaims for tortious interference with contract and intentional infliction of emotional distress. Defendant further alleged that after he told a mutual friend he was not seeking a serious relationship, plaintiff launched a smear campaign against him and filed suit to obtain a financial payoff. The court granted plaintiff's motion to dismiss, holding that the tortious interference claim failed because defendant did not plausibly allege plaintiff's knowledge of any specific contract terms, intentional procurement of a breach, or an actual breach. The emotional distress claim also failed because, under New York law, filing a lawsuit, even if allegedly false, does not constitute extreme and outrageous conduct, and defendant's additional allegations were too conclusory.

Court Upholds Foreclosure After Finding No Valid Acceleration in Prior Action

Plaintiff commenced a foreclosure action concerning a mortgage encumbering the property located at 224 Madison Street in Brooklyn. A 2008 foreclosure action was dismissed for plaintiff's lack of standing, and on appeal the court held that the 2008 action did not validly accelerate the debt because plaintiff lacked standing. Plaintiff commenced a 2018 foreclosure action. Plaintiff's motion for a judgment of foreclosure and sale was denied based on its failure to demonstrate compliance with RPAPL 1303 and 1304, and the court granted defendant's motion to dismiss that action on the same grounds. Plaintiff commenced the instant action. Defendant moved to dismiss, asserting that the action was time barred under the Foreclosure Abuse Prevention Act (FAPA), that plaintiff lacked standing, and that plaintiff failed to comply with RPAPL 1304. Plaintiff cross moved for summary judgment. The court denied defendant's motion and granted plaintiff's motion for summary judgment, holding that the operative acceleration occurred in the 2018 action and not in 2008 action, rendering the claims timely under FAPA.

WESTCHESTER | FAMILY LAW

Defective Attorney Affirmations Lead Court To Deny Motions and Review Referee Report

In a contested matrimonial action grounded on the irretrievable breakdown of the parties' marriage, an attorney referee was appointed to hear and report and subsequently issued a report addressing all remaining issues. The referee directed the parties to comply with statutory deadlines for motions to confirm or reject the report. Both plaintiff and defendant filed motions pursuant to CPLR § 4403, but the court denied both in their entirety due to noncompliance with CPLR § 2106, ruling that the attorney affirmations submitted in support and opposition were inadmissible and had to be disregarded. As a consequence, the court held that the matter procedurally stood as though no party had filed a motion to confirm or reject the referee report. Relying on CPLR § 4403 and 22 NYCRR § 202.44, the court determined that, in the absence of a valid party motion, it had an affirmative obligation to act. The court therefore independently reviewed the referee report, emphasized that the attorney referee clearly defined the issues and resolved credibility.

U.S. - SDNY | INTELLECTUAL PROPERTY

Court Denies Motion to Dismiss Claim Against AI Music Platform Over 'Stream Ripping'

Plaintiffs, a group of record companies and music businesses, brought an action against Uncharted Labs, Inc., which operates Udio.com, alleging copyright infringement and unlawful circumvention of technological measures. Plaintiffs alleges that Udio trained its generative AI models on millions of copyrighted recordings without authorization, including by "stream ripping" content from YouTube. Defendants moved to dismiss the DMCA claim, arguing that YouTube's measures constitute copy controls rather than access controls and that plaintiffs failed to allege actionable circumvention under 17 U.S.C. § 1201(a). The court rejected that argument at the pleading stage, holding that plaintiffs plausibly alleged both the existence of a technological measure controlling access and its circumvention. The court noted that the distinction between access controls and copy controls, while legally significant, could not be resolved on the current record, and that further factual development is required. Accordingly, the court allowed the DMCA claim to proceed, leaving defendants free to renew their arguments at a later stage.

U.S. - EDNY | CRIMINAL LAW

Court Sentences Defendant to 30 Months For Multistate Jewelry and Coin Theft Conspiracy

The court sentenced defendant to 30 months' imprisonment following his guilty plea to conspiracy to transport stolen property across state lines in violation of 18 U.S.C. §371. The case arose from a coordinated theft scheme carried out between August 2022 and January 2023, in which defendant and co-conspirators targeted jewelry and coin shows across the United States, stealing high-value items including Rolex watches, antique coins and cash through distraction tactics, disguises and coordinated roles. The thefts included incidents in Chicago and New York, including at the Javits Center and other exhibition venues, resulting in losses exceeding \$1 million. The court considered the defendant's background, including a childhood marked by abuse and instability, as well as his role in the offenses and acceptance of responsibility. Applying the statutory sentencing factors, the court determined that a custodial sentence was necessary to reflect the seriousness of the offense, promote deterrence and protect the public, while also imposing restitution exceeding \$5.2 million and a term of supervised release.

QUEENS | PERSONAL INJURY

Personal Injury Complaint Dismissed; Contractor Alleged Undefined Site Conditions

Defendant Vivar Group LLC moved pursuant to CPLR 3211 to dismiss a personal injury complaint brought by plaintiff Hassan Vallejo Avila. Plaintiff, a contractor retained to perform mechanical and plumbing work, alleged that he sustained injuries in a work-related accident on April 19, 2025, at a property in Suffolk County. In response, plaintiff cross-moved for leave to amend the complaint to add Marcos Monson as an additional defendant and to assert that his injuries were caused by dangerous job site conditions and a defective saw. The court granted defendant's motion to dismiss the complaint in its entirety and denied plaintiff's cross-motion. The court held that plaintiff's allegations concerning dangerous or defective conditions at the work site were wholly conclusory and failed to identify any specific condition that caused the injury. The court further found that the proposed defective saw claim was patently devoid of merit, noting that the saw was owned, operated and maintained by the plaintiff himself and was marked with his initials.

WESTCHESTER | EMPLOYMENT LITIGATION

Court Reinstates Mercy University Accounting Professor Fired Over CPA Registration

Petitioner Kelly Blacker commenced an Article 78 proceeding seeking to annul and vacate a determination by Mercy University and its President, Susan L. Parish, terminating her employment. Blacker had been employed as an assistant professor of accounting since 1996 and held a Certified Public Accountant license. In 2024, Denise Stefano, chair of the accounting program, discovered during preparation of state filings that the New York State Education Department did not list Blacker as a registered CPA since 1997. Blacker explained that she possessed a CPA license but did not understand the significance of triennial registration and later obtained a valid registration. The University, through Interim Provost Kristin Greenwood, initiated disciplinary proceedings and dismissed Blacker. She filed a grievance, and the Faculty Grievance Committee unanimously found no established misconduct, procedural failures, and that termination was a disproportionate sanction, recommending reinstatement. Despite this recommendation, the University President upheld the termination. The court held the determination arbitrary and capricious and found termination grossly disproportionate.

Matter of Blacker v. Mercy Univ., 68316/2025 (April 13)

U.S. - SDNY | CONSUMER PROTECTION

Court Allows Undisclosed Membership Fee Claim in Credit Builder Loan Case to Proceed

Plaintiff, an Instacash and Credit Builder Plus (CB Plus) customer, brought a putative class action on behalf of active duty servicemembers and their dependents who obtained Instacash or Credit Builder loans from defendants within the applicable statute of limitations through the date notice is disseminated. Among other claims, plaintiff challenged MoneyLion's Credit Builder loan product, a multi-payment installment loan available only to members of the "ML Plus Membership Program," which requires payment of a monthly membership fee. Plaintiff alleged that this fee was in fact an undisclosed component of the loan's finance charge, in violation of the Truth in Lending Act (TILA). The court denied defendants' motions to compel arbitration and dismiss, holding that plaintiff plausibly stated a TILA claim by alleging that the membership fee should have been disclosed as part of the finance charge, particularly where CB Plus membership does not provide benefits typically associated with credit union membership, such as reduced loan interest rates, higher returns on deposit accounts, or member ownership rights.
